This special session will focus on how the OSCE can concretely strengthen its interaction with Partners for Co-operation. *Inter alia*, the session will examine the status of the Organization's co-operation with Partners as well as the potential for enhanced engagement and exchanges of experience with them, particularly with Afghanistan and those along the South Mediterranean, in responding to transnational threats - especially those related to fighting terrorism, border management and migration management. The relevance of OSCE experience on police matters could also be discussed.

Under the overall theme of ‘*Toward a Security Community: What has to be Done*’, the opening session is intended to set the stage for the rest of the Conference by exploring the notion of a Security Community, particularly in relation to initiatives in the politico-military dimension that can lead to the strengthening of the Euro-Atlantic and Eurasian security environment and address emanating threats. Following the address by the NATO Secretary General, the opening session will allow for an exchange of ideas and concrete initiatives, including those initiated during the Corfu discussions, on how the Organization can adjust itself strategically and operationally to the current security challenges, and also embrace new opportunities to give meaning and direction to security relationships on different levels, and across the widest possible political, geographic and institutional space.

<b>3 - 6 p.m.</b>	<b>Working Session I: Transnational threats and challenges: strengthening the coherence of the OSCE response and interaction with other international actors</b>

This working session will offer participants the opportunity to focus on identifying a clear profile of OSCE contributions to international efforts to combat transnational threats, taking account of, *inter alia*, the 2003 Maastricht Strategy to Address Threats to Security and Stability in the 21<sup>st</sup> Century, MC Decision No. 2/09 on ‘Further OSCE Efforts to Address Transnational Threats and Challenges to Security and Stability’, and the Secretary General’s ‘Report on the Implementation of MC.DEC/02/09’ (SEC.GAL/107/10).

Topics for discussion include: police-related activities, including police development and reform; preventing and combating terrorism; border security and management; illegal migration; combating trafficking of illicit drugs and precursors; cyber security; and, curbing the proliferation of weapons of mass destruction in the context of implementation of UNSCR 1540. This is not an exhaustive list and, moreover, it includes topics that require a comprehensive, multidimensional and collective approach (Athens MC Decision 2/09, first para). Participants may wish to address them, where appropriate, in a comprehensive and cross-dimensional manner. Throughout, participants are encouraged to focus on how the OSCE can combat transnational threats through a greater unity of effort and purpose, and by adding value to the efforts of others while optimizing the Organization’s comparative advantages.

Building on previous discussions, the working session will focus on strengthening the OSCE's role and effectiveness in preventing and resolving conflicts, crisis management and mediation, and post-conflict rehabilitation and reconciliation. In that respect, improving co-ordination with international actors throughout the conflict cycle may also be addressed. The session will also look at the impact that existing conflicts in the OSCE area have on regional and international peace, security and human rights situation, including conflict in Georgia, and how to increase efforts in order to resolve them. The session will additionally include a forward looking perspective on future trends and patterns in potential causes of conflict in the OSCE region over the next 10 to 15 years (including social, economic and environmental considerations). In that respect, participants are encouraged to discuss the consequences for the Organization (and the wider international community) regarding how it could respond in preventing, managing and resolving such future conflicts – again in co-ordination with other international actors.
