### **I. PRACTICAL ARRANGEMENTS**

With reference to the Permanent Council Decision No. 1085 of 4 July 2013, the Section for External Co-operation would like to inform participants regarding the following practical arrangements for the 2013 OSCE Mediterranean Conference on the topic “Enhancing the Role of Women in Public, Political and Economic Life”, co-hosted by the Monegasque Government and the Organization for Security and Co-operation in Europe (OSCE), to be held in Monaco, on 28 and 29 October 2013.

#### **I.1 Venue**

The Conference will be held at the conference center of the Le Méridien Beach Plaza Hotel, Monte Carlo.

#### **I.2 Registration of Participants in the Conference**

The duly completed form should reach the OSCE Secretariat [pm-ext-coop@osce.org](mailto:pm-ext-coop@osce.org) by **7 October 2013**.

Participants representing Embassies or Consulates in Monaco are also requested to comply with this requirement.

### **I.3 Accommodation**

The Host Country has negotiated a special rate at the Le Méridien Beach Plaza Hotel, Monte Carlo – the venue of the Conference. The deadline for booking at the favourable conditions expires on 7 October 2013.

Interested participants are requested to make their reservations online. Le Méridien Beach Plaza Hotel has created a personalized website for participants in the OSCE Mediterranean Conference <https://www.starwoodmeeting.com/StarGroupsWeb/res?id=1307266969&key=60BE3> which will be available until 7 October 2013 for booking, modifying or cancelling a reservation.

Participants will be responsible for their own accommodation costs and incidentals occurring during their stay.

## **II. TRAVEL**

### **II.1 Visa Requirements**

To enter the Monegasque territory it is necessary to travel through the French territory.

Entering and staying on the Monegasque territory is subject to holding a valid passport or other forms of travel documents with the necessary authorizations required by the French authorities, permitting entrance in France. Participants requiring visa (list of countries in question is attached to this document) are advised to timely submit visa applications in the country of residence, through the French Embassy or Consulate or any other country that is party to the Schengen agreement. There is no possibility to obtain a visa upon arrival.

Even though the Principality of Monaco is a sovereign and independent state, there are no border formalities crossing to and from France.

A valid Schengen visa allows entering and staying on the territory of the Principality of Monaco and France for a period that does not exceed 90 days.

Participants requiring visa, in addition to the visa application as stipulated above, are kindly requested to complete Section II of the registration form and submit it with a copy of the relevant pages of the passport to the OSCE Secretariat for information.

### **II.2 Travel arrangements**

Participants are responsible for making their own travel arrangements.

### **II.3 Transport between airport and hotel**

**Nice Côte d'Azur Airport** is the main airport to enter Monaco. It is located approximately 30 km away from the Le Méridien Beach Plaza Hotel. On Sunday, 27 October 2013, a welcome service will be located in the arrivals area to greet and assist participants upon arrival.

On Sunday, 27 October 2013, the Host Country offers a **shuttle service** between the Nice Côte d'Azur Airport and the Le Méridien Beach Plaza Hotel, and on Tuesday, 29 October 2013, back to the airport. For that purpose, on the registration form there is an option to indicate the flight details.

Participants travelling on different days are advised to arrange for their own transportation.

The Nice Airport Xpress shuttle (line 110) commutes in 30 minute intervals between Nice Airport and Monaco (for time schedule and fare, please consult: [www.niceairportxpress.com](http://www.niceairportxpress.com)).

A taxi fare for one direction costs approximately EUR 100. Tipping the driver is not required.

### **III. HOSPITALITY**

On Sunday, 27 October 2013, the Host Country is offering a city tour for interested participants. The shuttle will depart from the Méridien at 5:30 p.m. and return at 07:30 p.m. The tour is planned as follows: Departure in front of the Méridien Beach Plaza, port of Monaco, a tour of Monaco-Ville (Castle, Cathedral, Museum), Casino (with stop at the Casino for clients wishing to walk back) and return to the hotel.

### **IV. GENERAL INFORMATION**

#### **IV.1. Attire**

While business attire is required for the conference, it is recommended that participants bring smart casual wear for the city tour on 27 October 2013.

#### **IV.3 Weather conditions**

In October, the daytime temperature in Monaco ranges between 15°C (low) and 20°C (high). The weather tends to be mild and sunny with a small chance for rainfall. The sun rises approximately at 07:00 and sets at approximately 18:00.

#### **IV.3 Insurance**

Personal and medical insurance is the responsibility of the individual participant.

The currency used in Monaco is the Euro (€), which is the only currency acceptable for payment. All major credit cards are accepted in hotels, restaurants, cafes, supermarkets and taxis. Cash can be obtained from ATMs or at the nearest bank.

#### **IV.6 Banking Services**

Working hours of banks in Monaco is from 08:30 to 12:00 and from 13:30 to 17:00. Please note that banks are closed on Saturdays and Sundays. Money can also be exchanged at the hotels and at the official exchange offices in the city centre.

#### **IV.7 Electricity**

The voltage in Monaco is 200V and European style two-pin sockets are used.

#### **IV.8 Telecommunications**

The international code for Monaco is +377.

#### **IV.9 Smoking**

Smoking is prohibited inside all public buildings, restaurants, bars and public transportation.
