12.15 – 13.30: Measures that Businesses, Civil Society and Governments can take to Prevent Trafficking in Human Beings for Labour Exploitation

In keeping with the Framework for Joint Action agreed by the Council of Europe and the OSCE at the conference organized in February 2014 on the occasion of the Austrian Chairmanship of the Council of Europe and the Swiss OSCE Chairmanship, this joint CoE-OSCE side event will review the efforts of civil society and businesses to combat trafficking in human beings in the private sector. Ways in which businesses could contribute more effectively will be discussed. The event will include a presentation of a new occasional paper prepared by the Office of the Special Representative and Co-ordinator for Combating Trafficking in Human Beings, "Ending Exploitation". This study questions whether the current methods used to motivate businesses to respect commitments made under voluntary initiatives (such as a commitment to prohibit trafficking and forced labour) are effective and suggests how States could encourage businesses to do more to prevent modern-day slavery.

This will be followed by a presentation of corporate social responsibility (CSR) initiatives by businesses in the post-Soviet States, as well as a presentation from the US examining the Coalition of Immokalee Workers' Fair Food Program, looking at the mechanisms that have made it so effective in terms of its impact on both the industry and workers, and how it can serve as a model for social accountability design, monitoring and enforcement.


