Strengthening Peace and Security Cooperation towards Democracy and Development

Regional Organisations play a crucial role in ensuring peace and security in their respective regions. They are increasingly called upon to strengthen and sustain peace and security by supporting peace-building processes and establishing functioning democratic institutions in post-conflict and countries in transition.

Regional Organisations have a series of potential comparative advantages in dealing with crisis situations. They are often regarded as having greater legitimacy and a greater understanding of the socio-cultural context, including of the local political dynamics. They are well positioned to detect and respond to crises faster. Intra-regional advice and assistance appears generally more welcome and more likely to be accepted and result in positive outcomes.

The potential role of Regional Organisations to contribute to peace and security has been enshrined in the United Nations (UN) Charter. Chapter VIII of the UN Charter encourages regional arrangements between the UN and ROs to maintain international peace and security.

The work of Regional Organisations can often been supported by Civil Society Organisations (CSOs) that have been developing significant capacities in areas such as early warning, track II diplomacy, policy analysis, advocacy and media outreach. The role that CSOs can play in the development and implementation of peace and security strategies is, however, not always common knowledge within Regional Organisations. The same can be said of CSOs, which are not always aware of the mandates, capacities and roles of Regional Organisations.

The main purpose of the International Conference is to discuss the role of Regional Organisations in conflict prevention and peacebuilding and to formulate policy recommendations on how to enhance cooperation among the UN, Regional Organisations and CSOs in the area of peace, security and democracy support.

The objectives of the Conference are: (a) to discuss existing mechanisms and initiatives for cooperation between Regional Organisations the UN and CSOs for conflict prevention and peacebuilding and identify good practices and lessons learned (b) to explore experiences in translating early warning into preventive actions and the conflict resolution, particularly in recurring crises (c) to explore experiences in peace building including in constitution building processes (d) to formulate policy recommendations to strengthen the global peacebuilding architecture through enhanced cooperation in conflict prevention and peacebuilding, including the role of different actors in the implementation of the Post 2015 Development Agenda.

This Conference brings together senior representatives from Regional Organisations, the UN, representatives from CSOs and experts in these fields to present regional innovations, exchange experiences and interactively discuss key issues.
