



Convention and its Protocol : Roles in implementation and compliance



- Parties
 - ✓ **Key responsibilities**
- Aarhus Centres
 - ✓ **Supporting responsibilities**
 - Act as informational multipliers
 - Promote and, as appropriate, directly contribute to the implementation
 - Assist in facilitating multi-stakeholder dialogues to address the identified priorities and challenges

Road to MoP-5 and MoPP-2: international level




- Strategic Plan 2009-2014
 - ✓ Objectives: facilitating full implementation, expansion and development
 - ✓ New plan for 2015-2020 is being developed with indicators of progress and targets
- Work Programme 2012-2014
 - ✓ Main priority: compliance and implementation, including capacity-building
 - ✓ Particular priorities: access to justice, public participation, access to information
 - ✓ New programme for 2015-2017 is being developed
- Issues identified in the reports on the meetings of the Convention bodies and on the regional/subregional workshops






Road to MoP-5 and MoPP-2: National level



- National Action Plans
 - ✓ Need to be adjusted after MoP-5 and MoPP-2
 - ✓ Include issues related to public participation in international forums
- National Implementation Reports
 - ✓ Art. 10 of the Convention, decisions I/8 and IV/4 (new – GMOs, PPIF and compliance issues)
 - ✓ Multi-stakeholder participation
 - ✓ Reporting on practical implementation and challenges
 - ✓ Prepared by 1 December 2013
 - ✓ Online national reporting database

Focus area

- Raise awareness among the public about their rights
- Facilitate the dissemination of the priority types of information identified in Decision II/3
- Improve access to environment-related health information
- Promote the accessibility of information held by the private sector and by other bodies than environmental authorities

Public Participation in Decision-making



Focus area

- Capacity-building (training) activities to ensure effective public participation in decision-making with regard to:
 - **Projects**
 - **Plans , programmes and strategies**
 - **Draft legislation, regulations and other generally applicable legally binding normative instruments**
- Assist public authorities in carrying out public participation procedures under the Convention
 - **disseminate notice of the public participation procedure**
 - **organize public hearings**

Public Participation in decision-making on GMOs



Focus area

- Raise awareness among the public about their rights under the Convention to participate in GMO decision-making
- Provide capacity-building/training to government officials about how to ensure effective public participation in this area

- Assist in implementing related decisions, as appropriate





Issues of primary focus



- Prepararion of 2014 national implementation reports for the Convention and its Protocol
- Provide annotations of existing tools for the Convention and the Protocol on the Aarhus Centres websites in national languages
- Make the text of the Convention, GMO amendment, PRTR Protocol and other tools available in national languages
- Upload regularly the available training material and information on capacity-building and awareness-raising projects on the Aarhus Clearinghouse and PRTR.net
- Submit case studies for PPDM and summaries of court cases
- Promote the development and adoption by the Parties of national action plans (including PPIF and GMO issues) as an outcome of relevant capacity-building projects
