# **Communities Committees**




Communities Committees (CC) are municipal mechanisms comprised of representatives of communities living in the municipality and Municipal Assembly (MA) members. Their establishment is obligatory. The CC's core competence is to review all municipal policies, practices, and activities with a view to recommending measures to the MA to ensure that the rights and interests of communities are respected.



# Establishment

CCs are established in all 38 municipalities. During the reporting period, 28 CCs met regularly on a monthly basis, eight CCs met regularly, but less frequently than once a month, and two CCs met on an irregular or ad-hoc basis.




Each community residing in a municipality should be represented in the CC, but some communities remain underrepresented. The most underrepresented communities are **Kosovo Turks**, **Kosovo Bosniaks** and **Kosovo Gorani**.






