**09:30 – 11:00**      **Session I - *Shaping a Security Community: thematic and geographic issues within a comprehensive security agenda.***

In the “Astana Commemorative Declaration: Towards a Security Community”, participating States acknowledged that more should be done to implement the OSCE core principles and commitments undertaken in the three dimensions. During the Lithuanian Chairmanship substantial efforts were undertaken to implement the tasking set by participating States at the Summit. The Irish Chairmanship, building on these efforts has initiated the *Helsinki + 40 process*. What are the major problems facing the Euro-Atlantic Eurasian Security Community? What should policy-makers look at when shaping a Security Community? The first session of the 2012 OSCE Security Days aims at identifying the main topics to be included in a comprehensive and balanced security agenda, keeping in mind the geopolitical landscape and the new threats to security.

**Session II - *Shaping a Security Community: addressing emerging global challenges. Developing a new approach to conventional arms control?***

If, on the one hand, the emergence of asymmetric security threats requires developing new and creative cooperative approaches, on the other hand, conventional arms control and confidence and security-building regimes remain major instruments for military predictability and transparency. Which are the new global challenges that OSCE is currently facing and how can we effectively deal with them? To what extent and how should the OSCE revitalize conventional arms control? What other tools should be developed to address global challenges, and how can the OSCE contribute? These are just some of the key questions to be addressed by the participants of the second session in order to develop some policy proposals on two key aspects of a Security Community.

**Session III - *Towards Reconciliation: addressing the protracted conflicts and revitalising dialogue.***

The third session will be centred on dialogue as the key vehicle for political processes within the OSCE. Is dialogue in the current format an effective tool to address the security concerns of participating States? Is there still a need to promote reconciliation within the OSCE? Are the current conflict resolution mechanisms effective? Confidence building measures that aim to build trust between divided communities are a crucial tool for building a lasting Security Community. In this session, participants will be free to formulate policy proposals on dialogue and conflict resolution for further consideration by OSCE participating States.

**Session IV - *Towards Reconciliation: a new vision for the OSCE?***

In this concluding session participants should analyse the potential way forward when it comes to implementing the Astana vision of building a free, democratic, common and indivisible Euro-Atlantic Eurasian Security Community. Such a Security Community would have to be crafted around inclusive reconciliation processes, common values and shared interests. Looking back at the Charters of Paris (1990) and Istanbul (1999), is there a need for a new fundamental document or for a new security framework for the OSCE? The *Helsinki + 40* process will try to answer this question in a transparent manner, focussing pragmatically on those areas where the OSCE can do more and better (so-called "building blocks"). This session would also offer the speakers an opportunity to revisit the previous panels' debates and draw some conference conclusions.
