National Strategy on Development and Integration

The final draft of NSDI has been discussed and endorsed in principle to the Strategic Planning Committee.

In response to a concern voiced by many stakeholders, including several of the donor partners, the Strategic Planning Committee has decided that an additional effort needs to be made to have the document fully consulted with the Parliament and the political parties in particular. This will be followed by a series of consultations with the parliamentary commissions within the next weeks. A national conference to launch the National Strategy for Development and Integration will be held in early 2008.

TV debates on National Strategy for Development and Integration

As of 17 October 2007, a series of ten

TV debates called “Challenges and Strategies” were broadcast on public television TVSH. The first seven debates were recorded in different cities across Albania and featured a sector theme: education (in Korça), rural development (in Lushnja), tourism (in Vlora), social care (in Gjirokastra), infrastructure (in Durrës), health (in Elbasan), and environment (in Shkodra). The last three were recorded in Tirana and focused on the overall strategic priorities of the NSDI: Justice and Rule of Law, Socio-Economic Development and EU and NATO Integration. The last two were broadcast on 19 and 26 December 2007. The Government, the opposition, technical experts and local community representatives participated in the debates. These debates were funded by DFID/OPM and were facilitated by the Institute for Contemporary Studies.

Integrated Planning System Immediate Phase (IPS)

Recent Developments on IPS Multi-Donor Trust Fund (MDTF)

The group of the donors co-financing the IPS MDTF is now complete. Austrian Government, the last to join, has also finalized the legal procedures with the World Bank during the month of December. The rest of the donors, with the exception of Italy have signed the amendments to the Administrative Agreements. As soon as this process will be completed, the World Bank will be able to sign the Grant Agreement with the Government of Albania.

In the meantime, another donor, the Government of Switzerland, has expressed interest to participate in the IPS MDTF to the value of 450,000 Euros. The Government of Albania has expressed its appreciation for this commitment from the Swiss Government in supporting the IPS implementation, and the World Bank will soon start the legal arrangement to include their contribution in the TF.

ONE UN Programme

Norway and Switzerland supporting the One UN in Albania

On 7 December 2007, the Norwegian Ministry of Foreign Affairs and the Swiss Agency for Development and Cooperation signed agreements with the United Nations to support the One UN Programme in Albania. Both Governments are strong supporters of UN reform and their financial support will be channelled towards strategic programme results. Norway is contributing \$1,092,896 and Switzerland \$540,178. Albania has been selected, along with seven other

countries to pilot a worldwide programme of UN reform. As part of ongoing United Nations efforts to enhance efficiency and responsiveness, the One UN Pilot aims to bring UN Agencies together – with one programme, one budget, one leader and one UN house. Albania's selection followed the request of the Albanian Government to the United Nations system. The Programme of One UN in Albania fully corresponds to national priorities and reduces costs in line with the Paris Declaration on Aid Effectiveness. Sector Related Activities

Donor Lunch Introduces USAID's New Assistance Programs:

On 15 November 2007, USAID hosted a working lunch with representatives of the donor community and Government of Albania counterparts to introduce three new USAID programs that will address issues in Albania's agriculture, judicial, and local government sectors. The five-year, \$10 million Albanian Agriculture Competitiveness (AAC) Program will assist farmers and agribusinesses in improving their productivity and responsiveness to trade conditions and opportunities in the domestic and global markets. In order to stimulate local economic development and improve local governance, USAID's four-year, \$8 million Local Governance in Albania Program (LGPA) will work with 10 municipalities to increase economic investments and better manage public resources. USAID assistance to the judicial sector through the three-year, \$4 million Rule of Law Program in Albania, will promote better functioning oversight institutions and more accountable courts. USAID/MCC Programme Sets Up Online Tax Filing and Payment System:

The 14 November 2007 VAT deadline saw a significant increase (from less than 10 in October to 48) in the number of taxpayers using the new e-filing system for their monthly VAT returns. Now Large Taxpayers also have the option of using the new e-payment system, available through the online banking systems of the American Bank of Albania and Raiffeisen Bank. In the coming months, more banks are expected to begin advertising this online tax payment service. Almost 160 additional Large Taxpayers were registered in November and e-filed on 14 December 2007. These systems are made possible through the MCA Threshold

Programme reforms, administered by USAID, which will reduce the opportunities for abuse and corruption in the tax administration.

British Embassy and OSCE Presence launch anti-corruption project in Shkodra hospital

On 11 December 2007, the British Embassy and the OSCE Presence in Albania, in co-operation with the Ministry of Health, launched an anti-corruption project in the regional hospital of Shkodra. The project aims to assist in improving the service offered to the public by the medical staff of promoting transparency and helping the fight against corruption. The project will focus on raising citizens' awareness of their rights to obtain medical services as well as their duties; and to improve the hospital's facilities by installing electronic information panels, security cameras and modern equipment. The project is financed both by the British Embassy and the OSCE Presence, and it will be implemented by the OSCE Presence. Activities foresee the finalization of a code of conduct to be signed by doctors and nurses, television advertisements

European Commission - Enlargement Strategy and Progress Reports 2007

On 6 November 2007 the European Commission adopted its annual strategy document explaining its policy on EU enlargement. The document includes also a summary of the progress made over the last twelve months by each candidate and potential candidate: Croatia, the former Yugoslav Republic of Macedonia, Turkey, as well as Albania, Bosnia and Herzegovina, Montenegro, Serbia and Kosovo (under UN Security Council Resolution 1244). In addition, the 2007 progress reports were published, where the Commission services monitor and assess the achievements of each of the candidate and potential candidates over the last year. The so-called "enlargement package" contains also proposals to the Council for revised European and Accession partnerships for each country, in which the Commission lists areas where further reforms are needed.

Seven agreements of cooperation between Albania and Kuwait signed

On 12 December 2007, in the presence of Albanian Prime Minister, Sali Berisha, and Prime Minister of the state of Kuwait, Sheikh Naser Al Mohammad Al Ahmad Al Jaber Al Sabah, Albania and Kuwait signed seven agreements of cooperation:

Minister of Foreign Affairs, Lulzim Basha and Under-Secretary of the Kuwaiti Ministry of Foreign Affairs, Khalid Sulaiman Al Jarallah signed the Agreement on establishing the joined Cooperation Committee and the Memorandum of Understanding for Bilateral Consultation between the Ministries of Foreign Affairs of both governments. Minister of Economy, Trade and Energy, Genc Ruli, and the Minister of Finance of Kuwait signed the Agreement for Economic and Technical Cooperation. Minister of Finance, Ridvan Bode, and the Minister of Finance of Kuwait signed the Agreement on Mutual Promotion and Protection of Investments. Minister of Tourism, Culture, Youth and Sports, Ylli Pango, and the Minister of Trade and Industry of Kuwait signed the Agreement on Tourist Cooperation and the Agreement on Culture and Arts. Another Agreement between the respective Chambers of Commerce was also signed.

The Embassy of the Kingdom of the Netherlands supports three projects from December 2007 onwards which will contribute to environmentally sustainable development in Albania:

REC Trust Fund 2

Following the positive experience from Trust Fund 1, REC Albania and the Embassy of the Kingdom of the Netherlands are extending their cooperation for another three years to improve the environmental situation in Albania. The scope of the follow-up programme covers improving physical environmental conditions, cooperation among stakeholders, and public participation and environmental awareness. To reach these objectives approximately 75 locally initiated projects will be implemented and about 300 NGO members and other involved representatives will be trained on topics related to environmental planning.

Milieukontakt 'Strengthening Albanian Civil Society for an Improved Environment'

The Embassy of the Kingdom of the Netherlands and Milieukontakt International will cooperate to implement the 'Strengthening Albanian Civil Society for an Improved Environment, 2007-2010' project. By improving the position of civil society, strengthening the dialogue between civil society, government and other stakeholders, and raising the quality of local and national environmental policies, Milieukontakt and the Embassy hope to realize improved implementation and enforcement of national policies on waste, water, and air quality, strengthen community involvement on these topics and build capacities of NGOs. The ultimate goal of Milieukontakt's

intervention is to create a strong and independent environmental NGO movement in Albania.

UNDP 'Identification and prioritization of "environmental hotspots" in Albania'

The project "Identification and prioritization of 'environmental hotspots' in Albania" is a follow up of several United Nation Environment Protection (UNEP) studies on environmental hotspots. The environmental situation around these hotspots is a serious concern as expressed in the National Environmental Action Plan of 2002. UNDP programme will carry-out identification and in-depth assessment of environmental hotspots in Albania, establish a database for the identified hotspots, and build the capacity of the environmental administration to further identify and monitor hotspots as well as to plan remedial actions. By creating an inventory of hotspots, a more systematic and effective approach towards addressing and cleaning up environmental hotspots will be possible.

OSCE Presence and Ministry of Interior organize workshop on address system model for Albania

A workshop on an address system model for Albania was held on 7 December 2007 in Tirana by the OSCE Presence and the Ministry of Interior. The workshop

also focused on the required changes to the relevant law and a draft decision on street signs and building numbers. Participants included representatives from state institutions and local government whose work is affected by the address system, as well as from international bodies, civil society organizations and private institutions. The workshop was a 'follow-up' to the Conference on the Modernization of the Address and Civil Registration Systems in Albania, which was held in November 2007. Activities on modernization of the address and civil registration systems are implemented in the framework of an EC-funded project implemented by the OSCE Presence.

Beginning of a new CARDS project - EURALIUS II

On 16 November 2007, the European Assistance Mission to the Justice System in Albania (EURALIUS II), a CARDS 2006 project, started as an immediate follow-up Mission to EURALIUS I that ended by the middle of November 2007. Like EURALIUS I, EURALIUS II will also be implemented by the Austrian Federal Ministry of Justice as the lead partner in a consortium with the German Federal Ministry of Justice. In addition to the work scope of EURALIUS I, the work-plan of EURALIUS II will also encompass Criminal Justice. By the middle of

February 2008, the full experts' staff will be working and a detailed work plan for the first 6 months of the implementation period will be prepared in collaboration with the Albanian state institutions.

Awareness campaign: Together to promote human rights and women's rights

The Civil Society Development Center (CSDC) in Korça organized an awareness campaign on human rights and women's rights from 25 November to 10 December. The main goals were: to raise awareness of Korça and Pogradec communities on human rights and especially on women's rights; to increase the community consciousness on domestic violence and to encourage the community to prevent it; to encourage the local civil society organisations to give a positive impact in the life of the local community; to strengthen and improve the cooperation and networking among local NGO-s.

Eleven NGOs were involved into the campaign: Korça Woman Organization, Me the Woman (Pogradec), Mother, Family, the Future, Physical Rehabilitation Association, Mjaft!. Citizens' Club, Romani Baxt, Amaro Drom, Disutni Albania, Golden Hands Foundation, Association of Orphan Children and Youngsters and Social Club, Youth Parliament.

This year, the CSDC has had very good cooperation with the Red Cross, Korca Branch and Terre des Hommes. The Red Cross and Terre des Hommes co-financed the designing of a banner, which was placed in the town centre.

Ministry of Labour, Social Affairs and Equal Opportunities, United Nations Volunteers and UNDP sign agreement to support the National Strategy for Improving Roma Living Conditions

The Ministry of Labour, Social Affairs and Equal Opportunities, UN Volunteers and UNDP signed an agreement on 22 November to support the National Strategy for Improving Roma Living Conditions. The two-year project will assist the poorest and most marginalized minority communities at the local level in Fier, Elbasan and Tirana by facilitating community access to basic services, promoting participatory planning, developing local infrastructure and increasing community access to the labour market. Project partners include Terre des Hommes, Tirana Legal Aid Services, the Albanian Red Cross, the Spanish Red Cross and the Regional Environmental Centre. The project complements UN efforts to establish a monitoring and progress reporting





mechanism for the National Strategy for Improving Roma Living Conditions.

Ministry and Donors Support National Conference on Child Protection

Save the Children in Albania and Transnational Action against Child Trafficking (TACT) program organized on 12 December 2007 the National Conference on Child Protection in Tirana. The Minister of Labour, Social Affairs and Equal Opportunities, Save the Children Programme Director, Terre des Hommes Head of Mission, USAID, UNICEF representatives, head of municipalities, child protection experts and social workers gathered to discuss the provision and expansion of protection services for children across Albania. In 2006 six municipal-level Child Protection Units (CPU) were established with the support of the multi-national child protection TACT and Save the Children. These units analyze and monitor the economic and social situations of vulnerable children and families and provide protection services. CPUs have been an integral part in creating a network of quality social service providers that strengthen the National Child Rights Protection System. The establishment and sustainability of CPUs have been made possible through the support of USAID, UNICEF, Hellenic Aid, OAK Foundation, Austrian Development Agency, and the Norwegian Ministry of Foreign Affairs.

Coordination key to reliable tourism data:

UNDP Albania hosted a round-table discussion as part of the Eco and Cultural Tourism Support programme on 15 November, to discuss findings from research conducted on the production of Albanian statistical data on tourism. Participants included representatives of the main institutions involved in collecting and interpreting tourism statistics - the Ministry of Tourism, Culture, Youth and Sports; the Ministry of Interior; the

Institute of Statistics (INSTAT); and the Bank of Albania. Other donor agencies who participated included: GTZ, SNV, USAID/EDEM project. The discussion was organized to look for ways to improve

the system of tourism statistics. It was agreed to follow a shared and recognized methodology coordinated by the Ministry of Tourism, Culture, Youth and Sports.

Tourism development

Educational Cooperation between Albania and Austria:

Austrian Development Agency organises an activity at the Hotelier –Tourism School in Durres marking the successful completion of the 'Tourreg Albania' project

On the 14 December 2007 saw the successful completion of the Tourreg. Albania project, which has been running for three years. The project aimed at supporting vocational training in the field of tourism. This project includes other countries in the region, such as Bulgaria, Romania, Former Yugoslav Republic of Macedonia and Montenegro. Project implementation was performed by the KulturKontakt Austria project office in Tirana and is funded by the Austrian Development Agency in an amount of 240,000 Euros. A stronger communication amongst the schools and business community and a higher level of management modernisation was achieved

in all the three Hotelier and Tourism pilot schools in Tirana, Durres and Saranda. An important contribution has been given in assuring a teaching process which is very close to practice.

The cooperation between Albania and Austria in the tourism education field has been functioning for over a decade. It has started with the opening of the hotelier-tourism branch at the existing school in Tirana.

The activity had the participation of the Minister of Education and Science Mr. Genc Pollo, representatives of the Austrian Embassy in Tirana, Mr. Christopher Opancar, from the Austrian Development Agency, representatives from the Education Departments and the schools in Tirana, Durres and Saranda as well as from the local government of Durres. Activity was closed with a cocktail reception, prepared and served by the students of the Hotelier and Tourism School of Durres.

Participation in World Travel Market in London

On 13 November 2007, Albania's Minister of Tourism, Culture, Youth and Sports, Mr. Ylli Pango, announced at the annual World Travel Market in London, several efforts that the Ministry would be undertaking to increase tourism to Albania. The Ministry and the National Tourism Organization, with the support of USAID, produced several promotional materials featured at the fair including two photographic exhibitions showcasing Albania's past and present sites, "Albanian Destinations" by Roland Tasho and "The Historic Marubi Collection: 1853-1950." In addition, 11 Albanian tourism companies participated and exhibited at the Albania stand.



This year's stand at the World Travel Market showcased tourism packages offered by Albanian private tour operators, municipalities, and the National Tourism Organization. Since 2004, USAID's EDEM program has assisted tourism businesses and national tourism organizations and associations to develop promotional products and services that strengthen Albania's tourism industry.

USAID Programme: New Graduates to Add Value to Growing Insurance Industry

Albania's first class of professional actuaries received certification for completion of an actuarial training and certification programme. The two-year Actuarial Certification Programme was funded by USAID and organized by the Financial Services Volunteer Corps (FSVC), in cooperation with Albania's Financial Supervisory Authority (FSA), the UK Institute of Actuaries, and the University of Tirana's Faculty of Nature Sciences. This actuarial training and certification serves as an important step toward the compliance with Law No. 9267 "On the activity of insurance, reinsurance

and intermediation in insurance and reinsurance" that entered into force on 10 August 2004. Through USAID's Central Bank Assistance Programme. The FSVC has worked to support the development of a sound, well-regulated and efficient financial sector, including support to Albania's Central Bank and the Deposit Insurance Agency, since initiating assistance to the financial sector in 1996.

Parliamentarians and community in Shkodra and Peshkopi discuss European integration challenges in OSCE Presence-organized forum

Members of the Parliamentary Committee on European Integration and other state officials were in Shkodra and Peshkopi on 27 November and 11

December 2007, respectively, to discuss with interests groups there the challenges deriving from the implementation of the Stabilization and Association Agreement with the European Union. The events, organized by the OSCE Presence in Albania, the Albanian Assembly and the European Movement, are part of the Presence's activities in the framework of its Parliamentary Support Project. Similar forums will be organized in several regions of the country in 2008.

Civil society and regional council set priorities for cross border projects:

On 22 November 2007, CSDC Kukes organized a meeting between civil society in Kukes and the Head of the Regional Council in order to discuss on priorities on cross border projects from which the Kukes region will benefit. The Ministry of European Integration, in the role of the national coordinator of the community assistance in Albania, is leading the work towards the preparation for cross border Programmes which will be funded by IPA during the period 2007-2011. One of these programmes, is the development programme for Kukes region with Kosovo. However, considering the fact that Kosovo has not been defined as an independent state yet, these projects will be awarded only to Kukes region. The aim of this programme is to encourage the initiatives

on environment, tourism and cultural values. Local government units, NGOs and business sector too are eligible to participate. In this meeting the Head of the Regional Council after explaining the programme goal to the participants, invited NGOs to give their ideas on what are the main and potential fields for these projects. The list of priorities by NGOs will be associated with a list from local government units and business sector. After collecting ideas there will be the phase of prioritizing these ideas which will be further development into project proposals to be submitted to the Kukës Regional Council. Later, the Regional Council (a committee where civil society will have a representative will be established to decide on the best priorities) will approve the projects they consider to be the best and then submit them to the Ministry of European Integration and IPA. This is a very good chance for local NGOs to apply for projects and they are encouraged to apply in partnerships with other NGOs or other local government units. It is the first time NGOs are offered this kind of collaboration.

Bringing Back Albanopoli Project

In order to continue implementing the project “Bringing Back Albanopoli”, on 1 December, the CSDC organized a cleaning activity at the square of Zgerdhesh. This was an area of high pollution created by years of local neglect. The project staff worked for 2 months to raise awareness to support the old saying, “If you are looking for a clean environment first clean the mind”. They organised seminars by communicating environmental issues and the importance of keeping a clean environment. They also placed banners around the square that helped to inform those living in

this area. The messages in the banners were: “cleanliness protects one’s health”; “all people for a clean environment” and “tourism is hindered by an unclean environment”. There were 120 volunteers who participated in this activity. Nature for Humanity, CSDC-Durres, Albanopoli, Peace Corps volunteers and other willing individuals all set strong examples to be followed in the future. The main goal of this activity was to bring back the beauty of the old Illyrian city of Zgerdhesh(Albanopoli) for visitors to come from all areas to appreciate the historical and archaeological aspects.

Issues of Solid Waste Management in Velipoja

On 4 December 2007, CSDC and Aarhus Information Center, supported by OSCE Presence organized a workshop in Velipoja Commune on the topic “Issues of Solid Waste Management in Velipoja”. After a series of previous meetings with the Head of Velipoja Commune, Mr. Nikolle Marku and his staff, the Head of the Regional Environmental Agency, Mr. Idrizi, it was decided to hold a workshop with various stakeholders who operate in tourist area and brainstorm on a work plan for the next 6 months

on environmental issues and the improvement of Solid Waste Management System before the beginning of the new summer season. The participants came up with the idea of involving local schools during the awareness campaigns and cleaning activities. The participants were optimistic about this work plan and promised to realize it within the time line of the next six months.

Germany continues its support to the Water Sector

As a result of the successful implementation of the project “Water Supply in Korça City” during the period of 2000-2003, the Water Supply and Sewerage Company of Korça has made an enormous progress. Now 24 hours of potable water supply is guaranteed to the consumer. The completion of this project was made possible through an investment of 24 Million Euros by the Government of the Federal Republic of Germany. The successful construction of the water supply system with contemporary parameters is in accordance with international standards, not only regarding technical means, but also regarding accompanying measures like the management of the company. As a result of all these achievements, the new project of “Sewerage System in Korça” was established. It aims at securing a safe ecological and

hygienical system for the accumulation, transportation and discharge of the waste water from urban sewerage of Korça as well as protecting the local water sources in the city. This project also foresees the construction of a contemporary waste water treatment plant with a state of the art technology and bearable costs for the social and economical conditions of the city. This project was realized through 5 Million Euros by the Government of the Federal Republic of Germany which were used for investments on the waste water net and for the elimination of the impurity in the water holder field of the city. Also, the European Investment Bank has allocated another sum of 15 Million Euros for the rehabilitation of the waste water network in the city and the Waste Water Treatment Plant.

In-Country Missions

A World Bank Proposed Second Development Policy Operations (DPO2), Supervision Mission, an Albania Country Economic Memorandum identification mission and a Debt Management Technical Assistance Mission have been visiting the country from 3 to 21 December:

(a) **The DPO2 supervision (from 3 to 14 December 2007)** reviewed, with the Government team and stakeholders, the progress made since the pre-appraisal mission, focusing on: pension reforms, water sector reforms, civil service reforms, health sector reforms, concessions framework, and fiscal decentralization.

(b) Members of the **Country Economic Memorandum (CEM) Scoping Mission (from 3 to 21 December 2007)** have began work on CEM, a report planned to look at growth priorities for Albania in the context of future EU accession.

(c) **Debt Management Technical Assistance Mission (from 17 to 21 December 2007)** had as a primary aim to assist the Ministry of Finance in improving government debt management capacity and institutions.

A World Bank Technical Supervision Mission for the Integrated Coastal Zone Management and Clean-up Project (APL-1) took place from 7 to 11 December 2007, aiming at the improvement of the management and conservation of Albanian coastal resources. The mission reviewed all components under the **Integrated Coastal Zone Management and Clean-up Project**, particularly focused on observing the first presentations and public outreach activities for the Draft Southern Coastal Development Plan, preparation for the public hearings in January 2008 and update on the reform of

the construction inspectorate
