

# Daily Report 225/2019

23 September 2019<sup>1</sup>

#### **Summary**


- Compared with the previous reporting period, between the evenings of 20 and 21 September, the SMM recorded more ceasefire violations in Donetsk region and no ceasefire violations in Luhansk region.
- Between the evenings of 21 and 22 September, the Mission recorded fewer ceasefire violations in Donetsk region and more ceasefire violations in Luhansk region, compared with the previous 24 hours.
- Small-arms fire was assessed as directed at an SMM mini unmanned aerial vehicle near Bohdaniyka
- Inside the Stanytsia Luhanska disengagement area, the SMM saw workers clearing vegetation, working on pillars for the pedestrian bypass bridge, welding parts of the metal bridge structure, laying asphalt on the bridge, and cutting and welding roadside steel fencing cables.
- The SMM observed anti-tank mines near the Zolote and Petrivske disengagement areas.
- The Mission saw weapons in violation of withdrawal lines in non-government-controlled areas, including at the former Luhansk international airport.
- The SMM monitored adherence to the ceasefire to facilitate the operation of essential civilian infrastructure and the drilling of wells near Raivka.
- Restrictions of the Mission's access continued, including at checkpoints near non-government-controlled Verkhnoshyrokivske, Zaichenko, and Petrivske.\*

Number of recorded ceasefire violations<sup>3</sup>


#### Number of recorded explosions<sup>4</sup>

In Donetsk region, between the evenings of 20 and 21 September, the SMM recorded more ceasefire violations, including, however, fewer explosions (about 110), compared with the <u>previous reporting period</u> (about 135 explosions). More than 65 per cent of ceasefire violations, including the majority of explosions, were recorded by the SMM camera at the entry-exit checkpoint in Pyshchevyk (government-controlled, 84km south of Donetsk) at a range of 2-4km south and south-south-east of the camera.

Between the evenings of 21 and 22 September, the SMM recorded fewer ceasefire violations, including fewer explosions (about 100), compared with the previous 24 hours. Around 28 per cent were recorded in areas south and south-south-east of Pyshchevyk, around 25 per cent were recorded east and east-south-east of Svitlodarsk (government-controlled, 57km north-east of Donetsk), around 17 per cent recorded north-west of Horlivka (non-government-controlled, 39km north-east of Donetsk) including 29 explosions, and around nine per cent recorded north-west and west-north-west of Debaltseve (non-government-controlled, 58km north-east of Donetsk) with the largest number of explosions (39).

In Luhansk region, between the evenings of 20 and 21 September, the SMM recorded no ceasefire violations compared with 17 (all explosions) during the <u>previous reporting period</u>.

Between the evenings of 21 and 22 September, the SMM recorded five ceasefire violations including, however, no explosions, compared with the previous 24 hours. All ceasefire violations were recorded by the SMM camera in Kriakivka (government-controlled, 38km north-west of Luhansk) in a south-south-westerly direction.

### Small-arms fire assessed as directed at SMM unmanned aerial vehicle near Bohdanivka

On 21 September, positioned 1.7km north-east of Bohdanivka (government-controlled, 41km south-west of Donetsk), while conducting a mini-unmanned aerial vehicle (UAV) flight at a distance of 2.2km east, over the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk), the SMM heard five shots and four bursts of small-arms fire about 2km east, which were assessed as inside the disengagement area and assessed as directed at the UAV, which the SMM safely recovered without damage.

#### Stanytsia Luhanska disengagement area

On the evening of 20 September, the SMM observed four workers from non-government-controlled areas cutting trees along the southern bank of the Siverskyi Donets River about 200m west of the checkpoint of the armed formations and three workers from non-government-controlled areas welding and laying asphalt on the metal section of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

On 21 September, the SMM observed three members of the State Emergency Service (SES) of Ukraine about 80m west of the broken section of the bridge and one SES member in an area about 400m north of the broken section of the bridge, on the eastern side of the road, all inspecting areas where the SMM observed workers from government-controlled areas clearing vegetation. At the same location, the SMM observed 12 workers cutting and welding the roadside steel fencing cables and clearing vegetation. The SMM also observed 12 workers from government-controlled areas east of the broken section of the bridge with a crane and an excavator working on the pillars of the pedestrian bypass bridge, of which five pillars were

under construction and one was almost completed. The SMM heard the sound of chainsaws being used about 100m south of the metal part of the Stanytsia Luhanska bridge and later saw freshly cut tree trunks placed 50m south of the bridge on the eastern edge of the road.

On 22 September, the SMM observed at least six workers from government-controlled areas working on the foundation of the pedestrian bypass bridge 7-10m east of the broken section of the bridge and two members of the SES inspecting the area east of the broken section of the bridge. The SMM also observed seven members of the armed formations (wearing armbands with "JCCC" written on them) between the checkpoint of the armed formations and the broken section of the bridge.<sup>5</sup>

On 21 September the SMM saw a deceased male lying on the metal section of the Stanytsia Luhanska bridge and three medical personnel and an ambulance. Medical personnel stated that the victim was a 60-year-old resident of non-government-controlled areas who had likely died from a blood clot. The body was transported by ambulance to non-government-controlled areas.

#### Other disengagement areas<sup>6</sup>

On 20 September, an SMM mid-range UAV spotted 34 <u>previously reported</u> anti-tank mines (TM-62), running from south-west to north-east in a field near the checkpoint of the Ukrainian Armed Forces just north of the disengagement area near Zolote (government-controlled, 60km west of Luhansk).

On 20 September, on the road between Bohdanivka and Viktorivka (non-government-controlled, 42km south-west of Donetsk), an SMM mini-UAV spotted 11 previously reported anti-tank mines (TM-62) laid in two rows about 200m north of the northern edge of the Petrivske disengagement area, assessed as belonging to the Ukrainian Armed Forces. Along the same road, 160m north of the disengagement area, the UAV again spotted 38 anti-tank mines (TM-62) laid in four rows. The same UAV spotted two armoured personnel carriers (APC) (BTR variant) inside the disengagement area, one about 1.2km south of its northern edge and 1.3km east of its western edge, and one about 600m further east, both assessed as belonging to the Ukrainian Armed Forces. Another SMM mini-UAV spotted for the first time a "Barely Visible Obstacle" across the road between Petrivske and Bohdanivka stretching into the vegetation about 4m on either side of the road, 500m from the contact line.

On 21 September, about 2.5km north-east of the northern edge of the Petrivske disengagement area, the SMM saw two armed members of the armed formations digging a 10-15m long trench about 5m from a newly constructed checkpoint as well as a military-type excavator and a digger about 150m of the same checkpoint.\*

On 22 September, positioned close to the disengagement area near Petrivske, the SMM observed a calm situation.\*

On 22 September, the SMM safely crossed the Zolote disengagement area from government to non-government-controlled areas and back again.

#### Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In total, the Mission observed 44 weapons in non-government-controlled areas in violation of withdrawal lines, including at the former Luhansk international airport about 10km south of Luhansk city (for more details, see the below table of weapons in violation of withdrawal lines as of 22 September 2019.)

#### Weapons that the SMM could not verify as withdrawn<sup>7</sup>

At a heavy weapons holding area in a non-government-controlled area of Donetsk region 22 September

The SMM noted that six towed howitzers (2A65 Msta-B, 152mm) continued to be missing.

At a heavy weapons permanent storage site in a non-government-controlled area of Donetsk region

22 September

The SMM noted that the site was abandoned and 13 tanks (nine T-72 and four T-64) continued to be missing.

#### Indications of military and military-type presence in the security zone<sup>8</sup>

Government-controlled areas

20 September

An SMM mini-UAV spotted an armoured combat vehicle (ACV) in Stanytsia Luhanska (16km north-east of Luhansk).

An SMM long-range UAV spotted:

- an armoured reconnaissance vehicle (BRDM-2) near Avdiivka (17km north of Donetsk);
- two ACVs near Nevelske (18km north-west of Donetsk);
- five ACVs near Krasnohorivka (21km west of Donetsk);
- three ACVs near Pobeda (27km west of Donetsk);
- an APC (probable BTR-80) and three infantry fighting vehicles (IFV) (BMP variant) near Berezove (31km south-west of Donetsk);
- three APCs (BTR-60) and a probably APC (BTR-variant) near Novotroitske (36km south-west of Donetsk);
- an APC (BTR-60) near Mykolaivka (40km south of Donetsk).

#### 21 September

The SMM saw:

- an APC (BTR-70) near Novokalynove (29km north-west of Donetsk) and
- an IFV (BMP-2) near Kamianka (20km north of Donetsk).

Non-government-controlled areas

20 September

An SMM mini-UAV spotted two ACVs (type undetermined) near Verkhnoshyrokivske (formerly Oktiabr, 85km south of Donetsk).

#### 21 September

The SMM saw a trench digger (TMK-2) in Styla (34km south of Donetsk).

#### SMM facilitation of repair works to civilian infrastructure

On 21 September, the SMM monitored adherence to the ceasefire to facilitate the drilling of wells near Raivka (non-government-controlled, 16km north-west of Luhansk).

On the same day, the SMM continued to monitor the security situation around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

On 21 and 22 September, the SMM continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk). Despite security guarantees being provided, on 21 September the SMM recorded an explosion 1-2km east and on 22 September recorded 42 ceasefire violations 1-2km east of the station.

#### Boder areas not under government control

On 22 September, while at a border crossing point near Uspenka (73km south-east of Donetsk) for about one hour, the SMM saw 23 cars (three with Ukrainian and eight with Russian Federation licence plates, 11 with "DPR" plates, and one with no plates), seven trucks (two with Ukrainian and two with Russian Federation licence plates, three with "DPR" plates), and 11 pedestrians exiting Ukraine. It also saw 37 cars (four with Ukrainian and 24 with Russian Federation licence plates, nine with "DPR" plates), 64 trucks (29 with Ukrainian and four with Russian Federation licence plates, 31 with "DPR" plates), five buses (two with Russian Federation licence plates, three with "DPR" plates), and seven pedestrians (mixed gender, 20-40 years old) entering Ukraine.

#### ATO veterans protesting Russian Federation coal shipments in Sosnivka

On 16 September, the SMM followed up on a protest in Sosnivka (53km north of Lviv) that had reportedly been ongoing since 1 September. Near the railway station in Sosnivka, the SMM saw ten people (men, around 45 years old) in a small camp composed of four tents with 15 flags (11 Ukrainian, four red-and-black). Ten of the participants told the SMM that they were ATO veterans attempting to block what they alleged was coal being sent from the Russian Federation to the coal refinery in Sosnivka. The SMM observed 64 carriages nearby with "Russian Railway" written in Russian on the sides. During its presence, the SMM did not observe any incident.

#### The SMM observed a calm situation in Chonhar and Valok, south-east of Kherson

On 20 September, the SMM saw a team of workers erecting fences and doing roadwork at the checkpoint in Chonhar (163km south-east of Kherson) and observed a calm situation. The next day, the SMM observed a calm situation at a Ukrainian Border Guard Service checkpoint in Valok (188km south-east of Kherson).

## \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report 14 September 2019). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

#### Denial of access:

- On 21 September, at a checkpoint 600m west of Verkhnoshyrokivske (formerly Oktiabr, non-government controlled, 85km south of Donetsk), an armed member of the armed formations prevented the SMM from crossing the checkpoint, citing ongoing engineering works near Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk). The SMM noted that civilian vehicles were allowed to pass through the checkpoint.
- On 21 and 22 September, at a checkpoint 800m north of Zaichenko (non-government-controlled, 93km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage towards Pikuzy, citing "ongoing demining activities" and "concerns for SMM safety".
- On 21 and 22 September, at a checkpoint on the northern edge of Petrivske (non-government-controlled, 41km south of Donetsk), an armed member of the armed formations denied the SMM passage citing "ongoing demining activities". As a result, the SMM was unable to access its camera site in Petrivske.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

#### Delay:

- On 22 September, at a checkpoint 600m west of Verkhnoshyrokivske (formerly Oktiabr, non-government controlled, 85km south of Donetsk), a member of the armed formations allowed the SMM to proceed only after about 40 minutes of waiting.

#### Other impediments:

- On the evening of 20-21 September, an SMM long-range UAV lost its GPS signal due to signal interference assessed as caused by probable jamming, as well as dual GPS signal interference assessed as caused by jamming, while flying over government- and non-government-controlled areas of Donetsk region. 9
- On 21 September, positioned 1.7km north-east of Bohdanivka (government-controlled, 41km south-west of Donetsk), while conducting a mini-UAV flight at a distance of 2.2km east, over the Petrivske disengagement area, the SMM heard five shots and four bursts of small-arms fire about 2km east, which were assessed as in the direction of the UAV (see above).


