


Daily Report 238/2019

8 October 2019¹

Summary

- Compared with the previous 24 hours, the SMM recorded fewer ceasefire violations in both Donetsk and Luhansk regions.
- Small-arms fire was assessed as directed at an SMM mini-unmanned aerial vehicle (UAV) south-east of Hnutove and east of Pyshchevyk.
- The Mission followed up on reports of a man injured in Yakovlivka and saw fresh damage to two apartments in Dokuchaievsk.
- Inside the Stanytsia Luhanska disengagement area, the SMM saw ongoing dismantling works at the broken section of the bridge.
- The Mission recorded ceasefire violations inside the Zolote disengagement area.
- The Mission saw 16 weapons in violation of withdrawal lines on both sides of the contact line.
- The SMM monitored adherence to the ceasefire to facilitate repairs and the operation of critical civilian infrastructure, including repairs to water pipelines between Zolote-3/Stakhanovets and Popasna, maintenance works on the Phenol Sludge Reservoir near Zalizne as well as the drilling of wells near Raivka.
- In Dnipro, Ivano-Frankivsk and Odessa, the SMM monitored peaceful gatherings related to recent political developments.
- Restrictions of the Mission's freedom of movement continued, including at non-government-controlled checkpoints near Petrivske, Zaichenko and Mykolaivka.*

Ceasefire violations²





In Donetsk region, the SMM recorded fewer ceasefire violations, however, more explosions (about 340), compared with the previous 24 hours (about 220 explosions). The majority of ceasefire violations were recorded in areas north-north-east of Marinka (government-controlled, 23km south-west of Donetsk), south and south-south-east of Pyshchevyk (government-controlled, 84km south of Donetsk), south-south-east of Chermalyk (government-controlled, 77km south of Donetsk), and at southerly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk).

In Luhansk region, the SMM recorded fewer ceasefire violations, almost all of which were explosions (seven), compared with the previous 24 hours (ten explosions). All ceasefire violations were recorded near to or inside the disengagement area close to Zolote (government-controlled, 60km west of Luhansk).

Small-arms fire assessed as directed at an SMM UAV on two occasions south-east of Hnutove and east of Pyshchevyk

Positioned on a road between Hnutove (government-controlled, 90km south of Donetsk) and Pyshchevyk (government-controlled, 84km south of Donetsk), while conducting a mini-UAV flight east of Hnutove, the SMM heard 25 bursts of small-arms fire about 3.5km south-east of its position, assessed as directed at the UAV, which at the time was flying 3.5km south-east of the SMM. On a subsequent flight south-east of Pyshchevyk, the Mission heard an uncountable number of bursts and shots of small-arms fire about 3.5km east-north-east of its position, assessed as directed at the UAV, which at the time was flying 3.6km east of the SMM. On both occasions the SMM safely landed the UAV.*

Man injured in Yakovlivka

On 5 October, the SMM followed up on reports of a man injured due to shelling in Yakovlivka (non-government-controlled, 10km north of Donetsk). The SMM saw a man who said that he was standing on the road in front of his house at 147 Yasynuvatska Street on the afternoon of 12 September when he heard three explosions and took cover in nearby bushes. He said that members of the armed formations provided first aid and that he went to the hospital a few days later. A member of the armed formations told the SMM that on the afternoon of 12 September a medic had provided first aid to the man who had a superficial wound (burned skin) near his left armpit. The mother (in her 60s) of the casualty told the SMM that a mortar round had landed between her son's yard and his neighbour's houses. According to her, five windows of the house had shattered, the roof, the outside wall, the fence in the yard and a wall of a neighbour's house were slightly damaged by shrapnel. A neighbour (woman in her forties) confirmed that the man had been injured on 12 September as a result of an impact. The SMM was unable to reach the area due to security concerns.

Damage to civilian property in Dokuchaievsk

The SMM followed up on reports of damage to residential buildings on 6 October in Dokuchaievsk (non-government-controlled, 30km south-west of Donetsk). At 9 Vatutina Street, in an apartment located on the fourth floor of a five-storey residential building, the SMM saw a broken south-west-facing window with its frame damaged in one room. In another room it saw a broken south-south-west-facing external window of a balcony and three holes (0.5-4cm in diameter) in the window dividing the balcony from the room. The SMM also saw glass debris and pieces of plastic near the balcony windows. The SMM assessed the damage as fresh but could not determine the type of weapon used and the direction of fire. A resident of the apartment (woman in her seventies) told the SMM that she

had seen the damage on 6 October and that nobody had been present in the apartment at the time of the incident.

At 15 Vatutina Street, the SMM saw a hole in the upper-right corner of a south-south-west-facing window on the first floor of a five-storey building. The Mission assessed the damage as fresh but could not determine the type of weapon used and the direction of fire. Two female residents of the building told the Mission that there had been shelling in the area on the evening of 6 October.

On 4 October, the SMM observed damage to two other civilian properties in this area, all four properties are within 300m of each other (see <u>SMM Daily Report 7 October 2019</u>).

A crater near Novoluhanske

On 5 October, the SMM saw a fresh crater in a road running along the eastern edge of the Bakhmut Agrarian Union's pig farm near Novoluhanske (government-controlled, 53km north-east of Donetsk). The Mission could not determine the type of weapon used and the direction of fire.

Stanytsia Luhanska disengagement area

On 7 October, about 320m north of the broken section of the Stantysia Luhanska bridge (15km north-east of Luhansk), the Mission saw a dump truck and a crane parked on the main road as well as five members of the State Emergency Service (SES) of Ukraine removing wood 10-15m east of the road and a truck, a bulldozer, and workers from government-controlled areas about 200m north of the broken section of the bridge clearing vegetation 20-25m east and west of the main road. The Mission saw four workers from government-controlled areas constructing a bus stop on the road about 660m north of the broken section of the bridge. The Mission saw ten workers from government-controlled areas with equipment and machinery continuing to dismantle the remains of the broken section of the bridge by demolishing concrete slabs and dismantling metal sections of the broken section of the bridge.

Other disengagement areas⁵

On 6 October, inside the disengagement area near Zolote, an SMM mini-UAV spotted two people, assessed as Ukrainian Armed Forces personnel, on road T-1316 about 130m south the railway bridge, near a position of the Ukrainian Armed Forces, as well as five people in military-style attire, a combat reconnaissance vehicle (BRM-1K) and two military trucks on the south-eastern edge of Katerynivka (government-controlled, 64km west of Luhansk).

On the same day, outside the disengagement area, the same UAV spotted an ongoing demining activity in a minefield located about 450m east-south-east of the checkpoint of the Ukrainian Armed Forces 300m north of the disengagement area, with stacks of about 280 anti-tank mines with fuses being removed and at least 15 anti-tank mines still laid in three rows in a field on the northern edge of the minefield (for previous observations, see SMM Daily Report 27 March 2019). The same UAV also spotted at least three people with metal detectors conducting demining activities about 250m south-west of the above-mentioned checkpoint, an armoured combat vehicle (ACV) (type undetermined) on the checkpoint's

eastern side, as well as a mine-resistant ambush protected vehicle (MRAP) about 150m north of the disengagement area's northern edge.

On the evening of the same day, the SMM camera in Zolote recorded an undetermined explosion and an airburst at an assessed range of 2-4km south (unable to assess whether inside or outside the disengagement area). During the day on 7 October, while positioned near the checkpoint of the Ukrainian Armed Forces 300m north of the Zolote disengagement area, the SMM heard two undetermined explosions about 1km south, assessed as inside the disengagement area. Positioned near a checkpoint of the armed formations on the area's southern edge, it heard four undetermined explosions at an assessed range of 5-7km northeast, assessed as outside the disengagement area but within its 5km periphery.

On 7 October, inside the Zolote disengagement area, the SMM saw four Ukrainian Armed Forces personnel carrying demining equipment and working around 750m south of the northern edge of the disengagement area, in a field about 450m east-north-east of the railway bridge inside the disengagement area. The SMM saw at least five excavators and engineering vehicles, including one combat engineering vehicle (BAT-2), digging at a location about 100m north-north-east and at a second location about 150m west of the Ukrainian Armed Forces checkpoint on the northern edge of the disengagement area, outside the disengagement area.

On 6 October, inside the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk), an SMM long-range UAV spotted a probable ACV and six people in trenches, assessed as Ukrainian Armed Forces personnel, near a previously <u>observed position</u> of the Ukrainian Armed Forces about 1km south of the disengagement area's northern edge and about 2km east of its western edge. About 600m west, inside the disengagement area, the same UAV spotted a probable armoured personnel carrier (BTR variant). All equipment was assessed as belonging to the Ukrainian Armed Forces.

On 7 October, positioned about 2km north of the disengagement area near Petrivske, the SMM observed a calm situation.*

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed 13 weapons in violation of withdrawal lines in Bakhmut (formerly Artemivsk, government-controlled, 67km north of Donetsk), two near Luhansk city (non-government-controlled) and one near Sarabash (formerly Komunarivka, non-government-controlled, 26km south of Donetsk) (for more details, see the tables below).

Indications of military and military-type presence in the security zone⁶

The SMM observed military and military-type presence in the security zone in governmentand non-government-controlled areas, including infantry fighting vehicles, armoured combat vehicles, a new bunker and ongoing refurbishment of existing trenches (for more details, see the table below).

Anti-tank mines near Vodiane

On 5 October, an SMM mini-UAV spotted <u>again</u> at least 22 anti-tank mines (TM-62) laid in two rows on the south-eastern edge of Vodiane (government-controlled, 94km south of Donetsk).

SMM facilitation of operation of and repair works to civilian infrastructure

The SMM monitored adherence to the ceasefire to facilitate the drilling of wells near Raivka (non-government-controlled, 16km north-west of Luhansk); to enable repair works on a water pipeline between Zolote-3/Stakhanovets (government-controlled, 61km north-west of Luhansk) and Popasna (government-controlled, 69km west of Luhansk); and to enable maintenance of the Phenol Sludge Reservoir near Zalizne (formerly Artemove, government-controlled, 42km north-east of Donetsk).

The Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitored the security situation in the area of the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

The Mission continued monitoring in Kharkiv, Kherson, Odessa, Lviv, Ivano-Frankivsk, Dnipro, Chernivtsi and Kyiv.

Peaceful gatherings in Dnipro, Ivano-Frankivsk and Odessa

On 6 October, the Mission monitored three peaceful public gatherings: one at 1 Oleksandra Polia Avenue in Dnipro, one in front of the Regional State Administration (RSA) building in Ivano-Frankivsk and one at the Duke Monument at 7 Primorskyi Boulevard in Odessa.

In Dnipro, the SMM saw about 1,000 people (mixed gender and ages) standing in a circular formation and about nine law enforcement officers. In Ivano-Frankivsk, the SMM saw about 100 people (mostly men of mixed ages), some wearing clothing with insignia of the National Corps as well as about 15 law enforcement officers. In Odessa, the SMM saw about 500 people (men and women of mixed ages) and four law enforcement officers. At the three gatherings, the SMM saw some participants holding Ukrainian flags and flags of Right Sector and Euro Maidan and heard them express messages critical of recent political developments concerning certain areas of Donetsk and Luhansk regions.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report 5 October 2019). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denials of access:

- At a checkpoint north of Petrivske (non-government-controlled, 41km south of Donetsk), a member of the armed formations <u>again</u> denied the SMM passage citing "the SMM's safety", thereby restricting the SMM's access to its camera in Petrivske.
- At a checkpoint 800m north of Zaichenko (non-government-controlled, 93km south of Donetsk), two members of the armed formations <u>again</u> prevented the SMM from proceeding towards Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk) and Sakhanka (non-government-controlled, 97km south of Donetsk) citing "demining activities" in the area.
- At a checkpoint east of Mykolaivka (non-government-controlled, 70km south of Donetsk), two members of the armed formation prevented the SMM from entering Mykolaivka citing "kinetic activity in the area".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- On two occasions, while conducting a mini-UAV flight on a road between Hnutove (government-controlled, 90km south of Donetsk) and Pyshchevyk (government-controlled, 84km south of Donetsk), as the UAV was 3.5km south-east, the SMM heard 25 shots of small-arms fire 3.5km south-east and then, as the UAV was 3.6km east, the SMM heard an uncountable amount of shots and bursts of small-arms fire about 3.5km east-north-east, assessed in both instances as aimed at the UAV. The patrol safely retrieved the UAVs and left the area (see above).
- On the night of 6 and 7 October, an SMM-long range UAV experienced GPS signal interference, assessed as probable jamming while flying over Petrivske (non-government-controlled, 41km south of Donetsk), Pervomaiske (government-controlled, 17km north-west of Donetsk) and Novhorodske (government-controlled, 35km north of Donetsk). The same UAV experienced GPS signal interference, assessed as jamming while flying over Marinka (government-controlled, 23km south-west of Donetsk).
- On 7 October, an SMM mini-UAV lost its GPS signal due to signal interference assessed as caused by probable jamming while flying near Pervomaiske (government-controlled, 17km north-west of Donetsk).


