


# **Daily Report 241/2019**

11 October 2019<sup>1</sup>

#### **Summary**

- Compared with the previous reporting period, the SMM recorded fewer ceasefire violations in both Donetsk and Luhansk regions.
- Inside the Stanytsia Luhanska disengagement area, the SMM saw ongoing dismantling works at the broken section of the bridge.
- The SMM observed illumination flares signalling readiness to renew disengagement in both the Zolote and Petrivske disengagement areas by the armed formations, however, the activities related to the renewal of the disengagement did not commence.
- The Mission observed weapons in violation of withdrawal lines in government-controlled areas of Donetsk region and non-government-controlled areas of Luhansk region.
- The SMM facilitated and monitored adherence to the ceasefire to facilitate repairs of critical civilian infrastructure on both sides of the contact line, including to power lines near Artema and gas pipelines near Betmanove, maintenance works at the Phenol Sludge Reservoir near Zalizne, as well as the drilling of wells near Raivka.
- Restrictions of the Mission's freedom of movement continued, including at a checkpoint of the armed formations near Zaichenko.\*



In Donetsk region, the SMM recorded fewer ceasefire violations, however, more explosions (about 90), compared with the <u>previous reporting period</u> (about 70 explosions). The majority of ceasefire violations were recorded in areas north and north-east of Shyrokyne (government-controlled, 100km south of Donetsk) and in areas south-south-east of Chermalyk (government-controlled, 77km south of Donetsk).

In Luhansk region, the SMM recorded fewer ceasefire violations, however, more explosions (24), compared with the <u>previous reporting period</u> (22 explosions). The majority of ceasefire violations, including the majority of explosions, were recorded at westerly directions of Kadiivka (formerly Stakhanov, non-government-controlled, 50km west of Luhansk).

#### Stanytsia Luhanska disengagement area

In the afternoon of 9 October and during the day on 10 October, the SMM continued to observe ten workers from government-controlled areas cutting metal parts of the broken section of the Stanytsia Luhanska bridge (15km north-east of Luhansk) and digging a new foundation at the northern edge of it. On 10 October, the Mission saw 14 workers from government-controlled areas with a crane, an excavator and two trucks cutting trees and vegetation, east of the road, along a 300m stretch from the broken section of the bridge northwards. On the evening of the same day, it saw that most of the metal parts of the broken section of the bridge had been removed.

On 10 October, the Mission saw seven workers from non-government-controlled areas clearing vegetation on the western side of the road, south of the broken section of the bridge, and smoke emanating from burning garbage and vegetation. In the afternoon, the Mission saw a white truck moving from the checkpoint of the armed formations to a location near the blue container (50m south of the broken section of the bridge) and four men in civilian clothing unloading parts of benches from it.

#### Disengagement areas near Zolote and Petrivske<sup>4</sup>

Following a 1 October <u>meeting of the Trilateral Contact Group</u>, during which a renewal of withdrawal of forces and hardware from the disengagement areas near Zolote (government-controlled, 60km west of Luhansk) and Petrivske (non-government-controlled, 41km south of Donetsk) and a timeline of activities were agreed upon, at 12:00 on 10 October, the SMM saw members of the armed formations, around 300m north of the checkpoint of the armed formations on the southern edge of the Zolote disengagement area, fire two white illumination flares, signalling readiness to renew disengagement. But since there was no reciprocal action, the activities related to withdrawal of forces and hardware did not commence.

The Mission saw six men (aged 20-30) – five in civilian and one in military style clothing-outside the checkpoint of the Ukrainian Armed Forces on the northern edge of the disengagement area near Zolote (for previous observations, see <u>SMM Daily Report 10</u> October).

On 9 October, inside the disengagement area near Zolote, an SMM mini-unmanned aerial vehicle (UAV) spotted two persons in military clothing just south of its northern edge and about 2km east of its western edge. Also inside the disengagement area, the UAV spotted

three people in military clothing: one about 750m south-east and two about 1km east of the Ukrainian Armed Forces checkpoint on the northern edge of the disengagement area.

Inside the Zolote disengagement area, throughout the day on 10 October, the SMM saw 15-20 Ukrainian Armed Forces personnel and three trucks clearing vegetation on the eastern and western sides of road T-1316, up to 400m south of the northern edge of the disengagement area. Around 370m south of the northern edge of the disengagement area, the SMM saw 13 anti-tank mines (TM-62M) without fuses placed in rows on both sides of the road. About 250m south of the northern edge of the disengagement area, the Mission saw a Ukrainian Armed Forces personnel with a metal detector and a prodding device checking the shoulder of the road. On four instances, inside the disengagement area, the SMM heard four explosions, assessed as controlled detonation of unexploded ordnance.

At the northern edge of the disengagement area, the SMM <u>again</u> saw three excavators and one engineering vehicle (BAT-2) operating in the fields. Also, outside the disengagement area, near a Ukrainian Armed Forces checkpoint on its northern edge, during the same day, the SMM observed a UAV being launched by Ukrainian Armed Forces personnel. About ten minutes later, it saw the UAV returning north from the direction of the disengagement area.

At 12:11, 14:10 and 15:00 on 10 October, about 300m north-east of the Petrivske disengagement area's north-eastern corner, the SMM saw a member of the armed formations launching an illumination flare, signalling readiness to renew disengagement. But since there was no reciprocal action, the activities related to withdrawal of forces and hardware did not commence.

On 9 October, inside the Petrivske disengagement area, an SMM mini-UAV spotted two persons in military clothing, assessed as Ukrainian Armed Forces personnel, near a treeline about 540m south of the northern edge of the disengagement area and about 1.4km east of its western edge, as well as two Ukrainian Armed Forces personnel about 500m south of the disengagement area's northern edge and about 700m east of its western edge and two Ukrainian Armed Forces personnel about 1.3km further east. A mini-UAV flight again spotted nine anti-tank mines (TM-62) laid out in two rows 180m north of the northern edge, 650m east of the north-western edge of the disengagement area, blocking the road connecting Bohdanivka to Viktorivka (non-government-controlled, 42km south-west of Donetsk), and again spotted 38 anti-tank mines (TM-62M) blocking the road 120m further west. On the same day, inside the disengagement area, an SMM mini-UAV again spotted an armoured reconnaissance vehicle (BRDM-2) about 1km south of its northern edge and 1.8km east of its western edge and again spotted an armoured personnel carrier (APC) (BTR-80), two heavy utility trucks, and six men in military clothing, assessed as Ukrainian Armed Forces Personnel, about 700m west.

Positioned in two locations north of Petrivske and in Petrivske, the Mission heard nine undetermined explosions at an assessed range of 2-4km north-west and an undetermined explosion at an assessed range of 4-5km south, all assessed as outside the disengagement area.

#### Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed nine weapons in violation of withdrawal lines in government-controlled areas of Donetsk region and non-government-controlled areas of Luhansk region.

It also observed 64 weapons beyond withdrawal lines but outside storage sites in non-government-controlled areas of Luhansk region and government-controlled areas of Donetsk region (for more details, see the tables below).

#### Indications of military and military-type presence in the security zone<sup>5</sup>

The SMM observed military and military-type presence in the security zone in government-controlled and non-government-controlled areas, including armoured personnel carriers, armoured combat vehicles, and an infantry fighting vehicle, (for more details, see the table below).

#### Cargo train in non-government-controlled area

On 10 October, near the railway station in Yasynuvata (non-government-controlled, 16km north-east of Donetsk), the SMM saw a train heading north-west powered by a locomotive pulling at least four gas wagons, a gravel wagon, and at least four wagons (unable to assess whether they were full or empty). At least three wagons had administrative numbers of the Russian Federation, while at least three other wagons had the logo of a bank registered in the Russian Federation.

#### SMM facilitation of operation of and repair works to civilian infrastructure

The SMM monitored adherence to the ceasefire to facilitate repairs to power lines servicing the Petrivske pumping station near Artema (government-controlled, 26km north of Luhansk), the drilling of wells near Raivka (non-government-controlled, 16km north-west of Luhansk), maintenance of the Phenol Sludge Reservoir near Zalizne (formerly Artemove, government-controlled, 42km north-east of Donetsk), and to enable gas pipeline repairs near Betmanove (formerly Krasnyi Partyzan, non-government-controlled, 23km north-east of Donetsk).

The Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitor the security situation in the area of the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

The SMM monitored adherence to the ceasefire in order to enable a transfer of funds from non-government- to government-controlled areas in Luhansk region, reportedly related to water payments.

#### Population survey in non-government-controlled areas of Donetsk and Luhansk region

On 10 October, three women in their fifties from non-government-controlled areas of Donetsk region told the SMM that they had participated in a population survey. At a population survey centre located in a school in non-government-controlled Donetsk city, a woman conducting the survey told the SMM that she had been involved for its remuneration. She added that, while most of the survey is conducted by going door to door, the centre is open on a daily basis for those who were unable to participate in such surveys from their homes. She further stated that no identification document was required to participate in a survey; although no information would be gathered over the phone.

The Mission continued monitoring in Kharkiv, Kherson, Odessa, Lviv, Ivano-Frankivsk, Dnipro, Chernivtsi and Kyiv.

# \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report 5 October 2019). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

#### Denial of access:

- At a checkpoint 800m north of Zaichenko (non-government-controlled, 93km south of Donetsk), a member of the armed formations <u>again</u> prevented the SMM from proceeding towards Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk) and Sakhanka (non-government-controlled, 97km south of Donetsk) citing "demining activities in the area".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines. UXO and other obstacles.


