
21 October 2019¹

Summary

- Compared with the previous reporting period, between the evenings of 18 and 19
 October, the SMM recorded fewer ceasefire violations both in Donetsk and Luhansk
 regions.
- Between the evenings of 19 and 20 October, the Mission recorded fewer ceasefire violations in Donetsk region and more in Luhansk region, compared with the previous 24 hours.
- The Mission saw damage to civilian properties from gunfire in Zolote-5/Mykhailivka and a crater in Pikuzy.
- Inside the Stanytsia Luhanska disengagement area, the SMM continued to observe reconstruction of the broken section of the bridge.
- The Mission saw clearing of vegetation as well as military and military-type presence inside the disengagement area near Zolote. It registered ceasefire violations inside both disengagement areas near Zolote and Petrivske.
- The Mission observed weapons in violation of withdrawal lines in government-controlled areas of Donetsk region and in non-government-controlled areas of Luhansk region.
- The SMM saw anti-tank mines near government-controlled Vodiane, unexploded ordnance near non-government-controlled Verkhnoshyrokivske and demining activities on the road between Pervomaisk and Popasna.
- The SMM monitored events related to marking of the European Anti-Trafficking Day.


Ceasefire violations²

In Donetsk region, between the evenings of 18 and 19 October, the SMM recorded fewer ceasefire violations, including fewer explosions (165), compared with the <u>previous reporting period</u> (about 485 explosions). The highest number of ceasefire violations were recorded at southerly directions of Yasynuvata (non-government-controlled, 16km north-east of Donetsk) and in areas west of Sakhanka (non-government-controlled, 97km south of Donetsk).

Between the evenings of 19 and 20 October, the SMM recorded fewer ceasefire violations, including fewer explosions (about 30), compared with the previous 24 hours. The highest number of ceasefire violations were recorded in areas east-north-east and east of Maiorsk (government-controlled, 45km north-east of Donetsk), and in areas south-west and west-south-west of Yasynuvata.

In Luhansk region, between the evenings of 18 and 19 October, the SMM recorded fewer ceasefire violations, including fewer explosions (14), compared with the <u>previous reporting period</u> (about 160 explosions). The highest number of ceasefire violations were recorded at easterly directions of Zolote (government-controlled, 60km west of Luhansk) and in areas north-east of Popasna (government-controlled, 69km west of Luhansk).

Between the evenings of 19 and 20 October, the SMM recorded more ceasefire violations including more explosions (115), compared with the previous 24 hours. The majority of ceasefire violations, including the majority of explosions, were recorded in areas south-west of Pervomaisk (non-government-controlled, 58km west of Luhansk).

Damage to civilian properties from gunfire in Zolote-5/Mykhailivka and a crater in Pikuzy

On 19 October, at 5 Voikova Street in the south-western part of Zolote-5/Mykhailivka (non-government-controlled, 61km north-west of Luhansk), about 500m from the forward positions of the armed formations, the SMM saw two holes in a north-facing window – as well as a 7.62mm bullet in the window glass and another on the floor, together with shattered glass – of an apartment on the first floor of a five-storey apartment building. The SMM assessed the damage as fresh and caused by small-arms fire. A woman (in her eighties) told the Mission that she heard the shooting in the early morning hours of 19 October.

On 20 October, on Akhmatovoi Street in Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk), the Mission saw a fresh crater in the middle of the asphalted road. Inside the crater, it saw splinter grooves and an 82mm mortar tailfin, assessed as fired from a westerly direction. About 450m west-south-west, at 7 Peremohy Street, the SMM saw a burnt house with its roof missing and windows destroyed on the east-facing wall of the house. The Mission could not assess the cause of the damage, but assessed it as fresh. A resident of the village (woman in her sixties) told the SMM that the village was shelled on 18 October and that the said house had burned on the same day.

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 19 October, inside the disengagement area near Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk), the SMM saw three members of the armed formations (wearing armbands with "JCCC" written on them) for the first time at the entrance

of the temporary pedestrian bypass bridge. On the same day, outside the disengagement area, the Mission saw a truck delivering gravel to the parking lot adjacent to the Prince Ihor monument about 1km south-south-east of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

On 20 October, inside the disengagement area, the SMM saw workers from government-controlled areas east of the broken section of the bridge operating a crane, while one worker was sandblasting a metallic bridge support pillar. Outside the disengagement area, the SMM saw about 100 cars and about 100 pedestrians queuing near the Prince Ihor monument, while the adjacent parking lot was still closed for construction. The Mission again saw members of the armed formations (wearing armbands with "JCCC" written on them) at the entrance of the temporary pedestrian bypass bridge and between the southern edge of the broken section of the bridge and the checkpoint of the armed formations.

On the evening of 18 October, the SMM camera in **Zolote** recorded 15 projectiles in flight at an assessed range of 2-4km south-east, assessed as inside the disengagement area and three projectiles in flight at an assessed range of 3-5km east-north-east and east, assessed as outside the disengagement area but within its 5km periphery. The camera also recorded two projectiles in flight at an assessed range of 1-2km east-south-east and south-east (unable to assess whether inside or outside the disengagement area).

On 19 October, inside the disengagement area near Zolote, the SMM continued seeing at least 25 Ukrainian Armed Forces personnel clearing and burning vegetation on both sides of road T-1316, up to about 750m south of the disengagement area's northern edge. The Mission saw four additional Hesco-type barriers and saw around ten Ukrainian Armed Forces personnel adding concrete barriers at a <u>previously reported</u> position on the eastern shoulder of road T-1316, about 40m south of the area's northern edge. Inside the disengagement area, the SMM saw six members of the armed formations and an anti-aircraft gun (ZU-23, 23mm), about 650m east of road T-1316 and about 100m north of the area's southern edge.

On the same day, outside the disengagement area, at the checkpoint of the Ukrainian Armed Forces about 300m north of the disengagement area, the SMM saw an armoured ambulance vehicle (MT-LB variant) covered with camouflage netting and an armoured personnel carrier (KrAZ Cougar) with a heavy-machine gun mounted on it, facing south. The Mission saw about 20 Ukrainian Armed Forces personnel and four vehicles (including trench diggers and excavators) building and fortifying <u>previously seen</u> trenches and positions at various locations about 1km east and 750m west of road T-1316 and up to 2km north of the northern edge of the disengagement area.

On 20 October, inside the Zolote disengagement area, the SMM saw two Ukrainian Armed Forces personnel inside trenches on the western side of T-1316 road south of the railway tracks. Positioned on the southern edge of the disengagement area, the SMM heard an undetermined explosion and 24 shots and bursts of small-arms and heavy-machine-gun fire at an assessed range of 2-4km north-north-east, assessed as outside the disengagement area but within its 5km periphery.

In the morning hours of 19 October, positioned about 1km east-north-east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the SMM heard a shot of small-arms fire at an assessed range of 1-3km east, assessed as inside **the disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), and two undetermined explosions at an assessed range of 5-7km north-north-east, assessed as outside the disengagement area but within its 5km periphery.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed 43 weapons in violation of withdrawal lines in government-controlled areas of Donetsk region and non-government-controlled areas of Luhansk region. It also observed 96 weapons beyond withdrawal lines but outside of designated storage sites in government-controlled areas of Donetsk region and non-government-controlled areas of Luhansk region (for further details, see the tables below).

Weapons that the SMM could not verify as withdrawn⁶

At a heavy weapons holding area in non-government-controlled areas of Luhansk region 19 October

The SMM noted that 16 self-propelled howitzers (2S1 *Gvozdika*, 122mm) and six towed howitzers (D-30 *Lyagushka*, 122mm) were present and no weapons were missing.

Indications of military and military-type presence in the security zone

The SMM observed military and military-type presence, armoured combat vehicles, armoured personnel carriers and infantry fighting vehicles in the security zone, on both sides of the contact line, including in residential areas of Pavlopil (government-controlled, 84km south of Donetsk) and Kadiivka (formerly Stakhanov, non-government-controlled, 50km west of Luhansk) (for more details, see the table below).

On 18 October, about 3.3km north of Shyrokyne (government-controlled, 100km south of Donetsk), an SMM mid-range unmanned aerial vehicle (UAV) spotted a new 50m trench branching off an existing 380m trench, assessed as belonging to the Ukrainian Armed Forces and extending towards the forward positions of the armed formations, located about 1km east (not seen in the imagery before 12 September 2019).

SMM facilitation of operation of civilian infrastructure

On 19 and 20 October, the Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitor the security situation in the area of the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

Anti-tank mines near Vodiane, demining on road T-0504 south west of Molodizhne and unexploded ordnance (UXO) near Verkhnoshyrokivske

On 18 October, an SMM mid-range UAV spotted <u>again</u> about 30 anti-tank mines (TM-62) laid in two rows in a field on the south-eastern edge of Vodiane (government-controlled, 94km south of Donetsk).

On 19 October, at a checkpoint of the armed formations, about 1.7km south-west of Molodizhne (non-government-controlled, 63km north-west of Luhansk), the Mission saw four deminers from non-government-controlled areas and a member of the armed formations (wearing an armband with "JCCC" written on it) carrying out demining near road T-0504 and going towards the fields west of the said road. During the same day, the SMM recorded three explosions, assessed as controlled detonations of UXO.

On 19 and 20 October, in a field 1km west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), the SMM <u>again</u> saw a piece of an unexploded 120mm mortar round embedded about 0.5m north of a road. On 20 October, 40m and 300m west of the said mortar round, the Mission saw for the first time a complete rocket-propelled grenade and another piece of partially detonated ordnance, assessed as a rocket-propelled grenade (RPG OG-7).

Situation at checkpoints along the contact line

The SMM continues to see long queues at the entry-exit checkpoints (EECPs) of the Ukrainian Armed Forces and at checkpoints of the armed formations along the contact line. On 19 October, at a checkpoint on highway H-15 near Kreminets (non-government-controlled, 16km south-west of Donetsk), the SMM saw about 260 cars, 11 buses and 70 pedestrians queueing to travel towards government-controlled areas and at least 90 cars, seven buses and 15 pedestrians in the opposite direction.

At the EECP near Marinka (government-controlled, 23km south of Donetsk), the Mission saw about 35 cars, a bus and about 200 pedestrians queuing to travel towards government-controlled areas and about 45 cars, two buses and about 50 pedestrians in the opposite direction.

On 20 October, at a checkpoint near Horlivka (non-government-controlled, 39km north-east of Donetsk), the SMM saw about 200 cars and 50 pedestrians queuing to travel towards government-controlled areas and about 100 cars, six buses and about 300 pedestrians in the opposite direction. At the same location, the Mission saw ongoing construction of a new checkpoint of the armed formations, with a large part of the construction site was covered with freshly poured cement.

Gatherings marking the European Anti-Trafficking Day

On 19 October in Kyiv, the SMM saw about 200 people dressed in black (men and women, mainly young adults) gathered at *Maidan Nezalezhnosti* and marching through the city centre on the occasion of the European Anti-Trafficking Day. The Mission monitored similar gatherings in Kherson and Odessa on 18 October where 31 to 110 people took part in a peaceful event.

The Mission continued monitoring in Lviv, Ivano-Frankivsk, Kharkiv, Dnipro and Chernivtsi.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, UXO and other impediments – which vary from day to day. The

SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report 16 October 2019). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines. UXO and other obstacles.

Delay:

- On 19 October, at a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), a member of the armed formations allowed the SMM to proceed only after about 25 minutes of waiting.

Other impediments:

- On the night of 17-18 October, an SMM long-range UAV lost its GPS signal due to signal interference, assessed as caused by probable jamming, while flying between Kostiantynivka (government-controlled, 60km north of Donetsk) and Zorynsk (non-government-controlled, 54km south-west of Luhansk) and between Kypuche (formerly Artemivsk, non-government-controlled, 46km west of Luhansk) and Buhaivka (non-government-controlled, 37km south-west of Luhansk).
- On 19 October, an SMM mini-UAV lost its GPS signal due to signal interference, assessed as caused by probable jamming, while flying in the vicinity of Kachkarske (non-government-controlled, 91km south of Donetsk).


