Daily Report 272/2019

16 November 2019¹

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire • violations both in Donetsk and Luhansk regions.
- A man from non-government-controlled Donetsk city was injured by gunfire. •
- The SMM continued to monitor the situation at the Petrivske disengagement area. •
- The Mission observed personnel of the State Emergency Service of Ukraine dismantling positions and workers from non-government-controlled areas clearing vegetation inside the Zolote disengagement area.
- Inside the Stanytsia Luhanska disengagement area, the Mission continued to observe • construction works at the broken section of the bridge.
- The Mission continued to facilitate repairs to and the operation of critical civilian • infrastructure on both sides of the contact line.
- Restrictions of the SMM's freedom of movement continued, including at checkpoints • near non-government-controlled Verkhnoshyrokivske and Kruta Balka.*



Ceasefire violations observed by the SMM 15 November 2019



In Donetsk region, the SMM recorded more ceasefire violations, including, however, fewer explosions (about 95), compared with the <u>previous reporting period</u> (about 175 explosions). The majority of ceasefire violations, including the majority of explosions were recorded in areas south-east and east-south-east of Svitlodarsk (government-controlled, 57km north-east of Donetsk) and north and north-north-east of Shyrokyne (government-controlled, 100km south of Donetsk).

In Luhansk region, the SMM recorded more ceasefire violations, including more explosions (about 100), compared with the <u>previous reporting period</u> (16 explosions). The majority of ceasefire violations were recorded in areas south-west of Kalynove-Borshchuvate (non-government-controlled, 61km west of Luhansk) and close to the disengagement area near Zolote (government-controlled, 60km west of Luhansk), where the majority of explosions were recorded.

Man from non-government-controlled Donetsk city injured by small-arms fire

The SMM followed up on reports of a man injured on 13 November in the Trudivski area of Donetsk city's Petrovskyi district (non-government-controlled). On 14 November, medical staff at Hospital No. 14 in Donetsk told the SMM that a man (in his fifties) had been admitted on the afternoon of 13 November with injuries to his thigh, close to the artery, caused by small-arms fire and was transferred to the Regional Hospital in Donetsk city for further treatment.

On 15 November, at the latter hospital in Donetsk city, the SMM saw a man (54 years old) with four bandages – two on each thigh. He told the Mission that he was injured by gunfire while walking in the Trudivski area in the afternoon of 13 November. A member of medical staff told the SMM that a bullet was removed from the man's thigh.

Disengagement areas near Petrivske, Zolote and Stanytsia Luhanska⁵

On 15 November, positioned about 2km north of Petrivske (non-government-controlled, 41km south of Donetsk), the SMM heard three explosions about 2km south-west, assessed as controlled detonations, inside **the disengagement area near Petrivske**.

On 14 November, inside **the disengagement area near Zolote**, an SMM mini-unmanned aerial vehicle (UAV) spotted four vehicles and 15 personnel of the State Emergency Service (SES) of Ukraine dismantling fortified positions by retrieving wooden logs near the railway bridge, about 900m south of the area's northern edge.

On the evening of 14 November, the SMM camera in Zolote recorded two explosions assessed as airbursts about 3-5km north-east and a projectile in flight about 2-4km north-east. On the same evening, while on the northern edge of Popasna (government-controlled, 69km west of Luhansk), the SMM heard 37 shots and bursts about 4-6km south-east. On 15 November, while at the same location, the SMM heard 58 explosions about 10-15km east-north-east. All ceasefire violations were assessed as outside the disengagement area, but within its 5km periphery.

On 15 November, positioned on the northern edge of the disengagement area, the SMM heard an explosion (also recorded by an SMM camera on the southern part of the area), and saw smoke, about 1km south of its position, assessed as a controlled detonation. The SMM also saw for the first time a launched rocket propelled grenade tube (probable RPG-26) about 30m west of road T-1316 and about 170m south of the disengagement area's northern edge.

Outside the disengagement area, on the same day, the SMM saw a fence made of wooden poles and barbed wire about 50m south of a road leading to Zolote 4/Rodina (government-controlled, 59km west of Luhansk), stretching from a location about 300m north-east of the checkpoint of the Ukrainian Armed Forces north of the area's northern edge to the entrance to Zolote 4/Rodina.

On the same day, inside the disengagement area, the SMM saw 17 workers from nongovernment-controlled areas clearing vegetation east and west of road T-1316, about 700m north of the area's southern edge. The Mission saw a truck leaving the area loaded with cut wood, and thereafter re-entering it empty. The SMM also saw four members of the armed formations (wearing armbands with "JCCC" written on them) and two workers inside a truck near the checkpoint of the armed formations on the southern edge of the disengagement area.

On 15 November, inside **the disengagement area near Stanytsia Luhanska** (governmentcontrolled, 16km north-east of Luhansk), the SMM observed ten workers from governmentcontrolled areas painting the Stanytsia Luhanska bridge (15km north-east of Luhansk) and compacting earth below the bridge. At the entry-exit checkpoint (EECP) of the Ukrainian Armed Forces north of the disengagement area, the Mission saw at least four journalists with cameras recording the construction works on the bridge and five workers from governmentcontrolled areas installing four stationary radiation monitoring systems, two at each end of the EECP.

Also inside the disengagement area, the SMM saw a worker from non-government-controlled areas along with a truck installing cables north of the checkpoint of the armed formations south of the bridge. The Mission also saw 11 workers from non-government-controlled areas clearing and burning vegetation in the area east of the checkpoint of the armed formations south of the bridge. The SMM also saw at least five members of the armed formations (wearing armbands with "JCCC" written on them) between the checkpoint and the southern edge of the broken section of the bridge.

Outside the disengagement area, the Mission saw a freshly dug hole (at least 5x3m), about 100m north-west of the Prince Ihor monument. Near the monument, the Mission saw a member of the armed formations (wearing an armband with "JCCC" written on it).

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed no weapons in violation of the withdrawal lines. It observed 15 weapons beyond withdrawal lines but outside of designated storage sites in government-controlled areas of Donetsk and Luhansk regions (for further details, see the tables below).

Weapons that the SMM could not verify as withdrawn⁶

15 November

At a heavy weapons holding area in a government-controlled area of Donetsk region The SMM noted that:

- ten anti-tank guns (four MT-12 *Rapira*, 100mm and six D-48, 85mm);
- 29 towed howitzers (12 2A36 *Giatsint-B*, 152mm and 17 D-20, 152mm); and
- seven self-propelled howitzers (2S3 Akatsiya, 152mm) continued to be missing.

At two heavy weapons holding areas in government-controlled areas of Luhansk region The SMM noted that:

- nine infantry fighting vehicles (BTR-3);
- three self-propelled howitzers (2S3 Akatsiya, 152mm); and
- a surface-to-air missile system (9K35 Strela-10) were present; and that
- seven tanks (T-80) were missing for the first time.

Weapons permanent storage site

15 November

At a permanent storage site in a government-controlled area of Luhansk region The SMM noted that:

- three mortars (2B11 Sani, 120mm) were missing for the first time.

Indications of military and military-type presence in the security zone⁷

The SMM observed military and military-type presence inside the security zone on both sides of the contact line, including armoured personnel carriers in a government-controlled area of Donetsk region (for further details, see the table below).

SMM facilitation of repairs to and operation of critical civilian infrastructure

The Mission monitored adherence to the ceasefire to facilitate maintenance of and repairs to power lines between Holubivka (formerly Kirovsk, non-government-controlled, 51km west of Luhansk) and Berdianka (non-government-controlled, 45km west of Luhansk) and in Vesele (non-government-controlled, 9km north-west of Donetsk).

The SMM continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitor the security situation around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see <u>SMM Daily Report 26 October 2019</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near <u>Pryshyb</u>; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-governmentcontrolled, 85km south of Donetsk), armed members of the armed formations <u>again</u> denied the SMM passage, citing "orders from superiors", on two occasions.

Delay:

- At a checkpoint west of Verkhnoshyrokivske, on two occasions, armed members of the armed formations <u>again</u> allowed the SMM to proceed only after about 20 and 40 minutes of waiting, respectively.

Conditional access:

- At a checkpoint about 700m south-east of Kruta Balka (non-government-controlled, 16km north of Donetsk), an armed member of the armed formations allowed the SMM to pass only with an escort car from the armed formations between the checkpoint and the settlement.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- On 15 November, at Hospital No. 2 in Horlivka (non-government-controlled, 39km north-east of Donetsk) medical staff refused to provide the Mission with information about a civilian casualty citing "a requirement for written permission from those in control".


