


OSCCE Special Monitoring Mission to Ukraine

Daily Report 281/2019

27 November 2019¹

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire • violations in Donetsk region and fewer in Luhansk region.
- A woman was injured due to gunfire in government-controlled Marinka. •
- The SMM saw a trench filled with concrete blocks and soil on the road between • Bohdanivka and Viktorivka, north of the Petrivske disengagement area.
- The Mission observed workers from non-government-controlled areas installing • railings on the metal part of the Stanytsia Luhanska bridge.
- The SMM continued to monitor the situation in the Zolote disengagement area. •
- It monitored adherence to a localized ceasefire to facilitate repairs to critical civilian infrastructure, including to communication equipment in Obozne, water pipelines between Novoluhanske and Kurdiumivka and drilling of wells near Pankivka.
- Restrictions of the SMM's freedom of movement continued, including in non-• government-controlled Novoazovsk and Siedove in southern Donetsk region.*



In Donetsk region, the SMM recorded more ceasefire violations, including more explosions (about 220), compared with the <u>previous reporting period</u> (190 explosions). Almost half of the ceasefire violations were recorded at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk), southerly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk) and in areas south-east and south of Zalizne (government-controlled, 42km north-east of Donetsk).

In Luhansk region, the Mission recorded fewer ceasefire violations, including, however, more explosions (62), compared with the <u>previous reporting period</u> (about 30 explosions). The majority of ceasefire violations, including the majority of explosions were recorded at easterly and southerly directions of Popasna (government-controlled, 69km west of Luhansk).

Woman injured from small-arms fire in government-controlled Marinka

The SMM followed up on reports of a woman injured on 25 November in Marinka (government-controlled, 23km south-west of Donetsk), in an area about 750m from the forward positions of the Ukrainian Armed Forces. On 26 November, medical staff at a hospital in Kurakhove (government-controlled, 40km west of Donetsk) told the SMM that a woman (in her late thirties) had been admitted on 25 November with a gunshot wound to her chest and an open fracture in the left arm.

At the same hospital, the SMM saw the woman with bandages on her chest and left arm. She told the SMM that she had been injured by gunfire while walking on a bridge at Druzhby Avenue in Marinka with her 20-month-old son in a stroller. She also said that two nearby workers had rushed to her aid; one rescuing her baby and the other covering her to protect them from the ongoing shooting. The two workers (in their fifties and sixties) who witnessed the incident, told the SMM that on 25 November, they had been working in the vicinity of Marinka School No.2 when they heard shooting and saw a woman crouching on the bridge.

Disengagement areas near Petrivske, Zolote and Stanytsia Luhanska⁵

On 25 November, outside the **disengagement area near Petrivske** (non-governmentcontrolled, 41km south of Donetsk), on the road between Bohdanivka (governmentcontrolled, 41km south-west of Donetsk) and Viktorivka (non-government-controlled, 42km south-west of Donetsk), an SMM mini unmanned aerial vehicle (UAV) again spotted 11 antitank mines which form part of a previously reported mine field, assessed as belonging to the Ukrainian Armed Forces. About 90m south of the aforesaid location, also outside the disengagement area, the UAV spotted uprooted mine hazard signs, a barrier tape on the ground as well as two anti-tank mines.

On 26 November, on the abovementioned road, about 1km west of the abovementioned 11 anti-tank mines, the Mission saw a trench filled with concrete blocks and soil. Positioned about 1km east of Bohdanivka, the Mission saw seven vehicles and an ambulance, all belonging to the State Emergency Service of Ukraine, heading toward the disengagement area.

On the same day, at a checkpoint of the armed formations about 3km north of Petrivske, the SMM saw for the first time a trench running about 100m west towards a treeline (for previous observations in the area, see <u>SMM Daily Report 18 September 2019</u>).

Positioned about 1km north-east of Bohdanivka, the SMM heard four shots of (30mm) cannon fire and five undetermined explosions, at an assessed range of 3-5km south-east, assessed as outside the disengagement area. Positioned about 2km north of Petrivske, the SMM heard 40 explosions (including ten assessed as fired from an automatic grenade launcher) and about 55 shots of small-arms and heavy-machine-gun fire, at an assessed range of 1-4km south-east and south-south-east; it also heard and saw a burst of an anti-aircraft cannon, at an assessed range of 2km south (all assessed as outside the disengagement area but within its 5km periphery).

On 26 November, the SMM saw 15 workers and seven deminers from non-governmentcontrolled areas arriving at a checkpoint of the armed formations on the southern edge of the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk) and entering the disengagement area on road T-1316.

Positioned at the aforesaid checkpoint, the SMM heard two undetermined explosions, at an assessed range of 4-5km north-north-east, assessed as outside the disengagement area, but within its 5km periphery.

Inside **the disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw five workers from non-government-controlled areas installing new railings on the metal part of the Stanytsia Luhanska bridge (15km north-east of Luhansk).⁶ The Mission also saw workers from non-government-controlled areas cutting vegetation about 100m south-east of the checkpoint of the armed formations and a fire at the southern bank of Sieverskyi Donets river about 50m east of the road.

The SMM saw at least five members of the armed formations (wearing armbands with "JCCC" written on them), between the bridge and the checkpoint of the armed formations inside the disengagement area.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed three weapons beyond withdrawal lines but outside of designated storage sites in government-controlled areas of Donetsk region (for further details, see the tables below).

Weapons that the SMM could not verify as withdrawn⁷

26 November

At a heavy weapons holding areas in a government-controlled area of Donetsk region The SMM noted that:

- four mortars (2B11 Sani, 120mm) were present; and
- 12 self-propelled howitzers (2S3 *Akatsyia*, 152mm), ten tanks (T-72) and two surface-to-air missile systems (9K35 *Strela-10*) continued to be missing.

Indications of military and military-type presence in the security zone⁸

The SMM observed military and military-type presence inside the security zone on both sides of the contact line, including an armoured combat vehicle in a residential area (for further details, see the table below).

SMM facilitation of repairs to and operation of critical civilian infrastructure

The SMM monitored adherence to a localized ceasefire to facilitate repairs to communication equipment in Obozne (non-government-controlled, 18km north of Luhansk), water pipelines between Novoluhanske (government-controlled, 53km north-east of Donetsk) and Kurdiumivka (government-controlled, 54km north of Donetsk) and drilling of wells near Pankivka (non-government-controlled, 16km north of Luhansk).

The Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitored the security situation in areas around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

Border areas not under government control

While at a border crossing point near Marynivka (78km east of Donetsk) for about an hour, the SMM saw 12 cars (four with Ukrainian and two with Russian Federation licence plates, as well as six with "DPR" plates), a covered cargo truck with "DPR" plates and two pedestrians (men in their forties) entering Ukraine. It also saw 35 cars (four with Ukrainian and 20 with Russian Federation licence plates, as well as 11 with "DPR" plates), two covered cargo trucks (one with Ukrainian licence plates and one with "DPR" plates), three buses (two with Russian Federation licence plates and one with "DPR" plates) and a pedestrian (man in his fifties) exiting Ukraine. The SMM saw for the first time a white container with two flags (with black, blue and red, and red blue and red colours) on the left side of the road about 50m before the checkpoint premises.

While at the border crossing point near Uspenka (73km south-east of Donetsk) for about an hour, the SMM saw 18 cars (six with Russian Federation licence plates and 12 with "DPR" plates), 11 covered cargo trucks (seven with Ukrainian licence plates and four with "DPR"

plates), a fuel tanker with Ukrainian licence plates, three buses with "DPR" plates and two pedestrians (women, mixed ages) entering Ukraine. It also saw 26 cars (five with Ukrainian and 11 with Russian Federation licence plates, as well as ten with "DPR" plates), three covered cargo trucks (one with Ukrainian licence plates and two with "DPR" plates), a chemical liquids tanker with "DPR" plates and eight buses (one with Russian Federation licence plates and seven with "DPR" plates) exiting Ukraine.

Public gathering marking the first anniversary of the developments at sea near Kerch Strait

On 26 November, the SMM monitored a public gathering in Kyiv (about 30 participants, mainly young people, mixed genders) marking the first anniversary of the <u>developments at</u> sea near the Kerch Strait on 25 November 2018 in front of the embassy of the Russian Federation. The SMM observed about ten police officers securing the event, which ended without incidents.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro and Chernivtsi.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Coordination should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see <u>SMM Daily Report of 19 November 2019</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint north of Novoazovsk (non-government-controlled, 102km south of Donetsk), a member of the armed formations denied the SMM passage, citing "orders from superiors".
- At a checkpoint near Siedove (non-government-controlled, 106km south of Donetsk), two members of the armed formations denied the SMM passage towards Siedove (non-government-controlled, 106km south of Donetsk), citing "ongoing special operations in the area".

Delay:

- At a checkpoint about 1.8km north-east of Stepanivka (non-government-controlled, 62km west of Luhansk), an armed member of the armed formations allowed the SMM to proceed east towards Veselohorivka (non-government-controlled, 64km west of Luhansk) only after about 25 minutes of waiting.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.


