

Daily Report 285/2019


2 December 2019¹

Summary

- Compared with the previous reporting period, between the evenings of 29 and 30 November, the SMM recorded more ceasefire violations in Donetsk region and no ceasefire violations in Luhansk region.
- Between the evenings of 30 November and 1 December, the Mission recorded more ceasefire violations in Donetsk region. It recorded ceasefire violations in Luhansk region.
- The SMM continued to monitor the situation in the Zolote, Petrivske and Stanytsia Luhanska disengagement areas.
- It monitored adherence to a localized ceasefire to facilitate repairs to and the operation of critical civilian infrastructures on both sides of the contact line in Donetsk region, including to power lines in Shumy.
- The Mission monitored peaceful gatherings in Chernivtsi and in Kyiv.
- The SMM's freedom of movement continued to be restricted, including at checkpoints of the armed formations near Zaichenko, Bezimenne and Verkhnoshyrokivske, all in Donetsk region.*

Ceasefire violations²



In Donetsk region, between the evenings of 29 and 30 November, the SMM recorded more ceasefire violations, including more explosions (80), compared with the <u>previous reporting period</u>. The majority of ceasefire violations were recorded at easterly and southerly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk) and at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk).

Between the evenings of 30 November and 1 December, the Mission recorded more ceasefire violations, including, however, fewer explosions (25), compared with the previous 24 hours. The majority of ceasefire violations were recorded at northerly directions of Shyrokyne and at easterly and southerly directions of Hnutove (government-controlled, 90km south of Donetsk).

In Luhansk region, between the evenings of 29 and 30 November, the Mission did not record any ceasefire violations.

Between the evenings of 30 November and 1 December, the Mission recorded ceasefire violations (six in total), however no explosions, in areas north-north-east of Zolote-5/Mykhailivka (non-government-controlled, 58km west of Luhansk) and Pervomaisk (non-government-controlled, 58km west of Luhansk).

Disengagement areas near Zolote, Petrivske and Stanytsia Luhanska ⁵

On 30 November and 1 December, the SMM saw members of the armed formations (wearing armbands with "JCCC" (Joint Centre for Control and Co-ordination) written on them) at the checkpoint of the armed formations on the southern edge of the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk).

On 1 December, outside of the disengagement area near Zolote, the SMM continued to see the presence of police and national guard personnel patrolling in areas north of the disengagement area.

On the same day, positioned in Pervomaisk, the SMM heard a burst of small-arms fire, at an assessed range of 3-4km north-north-east. About 45 minutes later, positioned in Zolote-5/Mykhailivka, the Mission heard about five shots of small-arms fire, at an assessed distance of 1-2km north-north-east. All of the above were assessed as outside the disengagement area near Zolote but within its 5km periphery.

On 30 November and 1 December, positioned east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the SMM saw up to 21 State Emergency Service of Ukraine (SES) personnel on board of vehicles, driving east on the road towards Viktorivka (non-government-controlled, 42km south-west of Donetsk) and entering the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk).

On 1 December, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw at least five members of the armed formations (wearing armbands with "JCCC" written on them), between the southern edge of

the newly constructed section of the bridge and the checkpoint of the armed formations inside the disengagement area.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed a weapon beyond withdrawal lines but outside of designated storage sites in a government-controlled area of Donetsk region (for further details, see the table below).

Heavy Weapons Permanent Storage Site

At a heavy weapons permanent storage site in a non-government-controlled area of Luhansk region

30 November

The SMM saw that all weapons declared as withdrawn at this site were present.

Indications of military and military-type presence in the security zone⁶

The SMM observed armoured combat vehicles in government-controlled areas of Donetsk and Luhansk regions (for further details, see the table below).

On 30 November, the SMM saw a new dug-out assessed as a trench line, about 3-5m north-west of a local road south-west of Dovhe (non-government-controlled, 22km north-west of Luhansk), assessed as belonging to the armed formations.

Presence of unexploded ordnance (UXO) in Heorhiivka

On 30 November, the SMM saw a piece of UXO assessed as a multiple launch rocket system rocket (*Uragan*, 220mm) in a field about 50m east of a local road in the southern outskirts of Heorhiivka (non-government-controlled, 15km south of Luhansk), assessed as not recent. The SMM noted that the UXO was not marked or fenced.

SMM facilitation of repairs to and the operation of critical civilian infrastructure

On 30 November, the SMM monitored adherence to a localized ceasefire to facilitate repairs to power lines in Shumy (government-controlled, 41km north of Donetsk).

On 30 November and 1 December, the Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitored the security situation in areas around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

Border areas not under government control

On 30 November, while at the border crossing point near Uspenka (73km south-east of Donetsk) for about an hour, the SMM saw 37 cars (two with Ukrainian and eight with Russian Federation licence plates, as well as 27 with "DPR" plates), two covered cargo trucks (one with Ukrainian licence plates and one with "DPR" plates), and a bus with Russian Federation licence plates entering Ukraine. It also saw seven cars (one with Ukrainian and two with Russian Federation licence plates, as well as four with "DPR" plates), a covered cargo truck with Ukrainian licence plates, and a bus with "DPR" plates exiting Ukraine.

On 1 December, while at the same location for about 40 minutes, the Mission saw seven cars (four with Russian Federation licence plates as well as three with "DPR" plates), a bus with Russian Federation licence plates, and two pedestrians (a woman and a man in their forties and fifties) entering Ukraine. It also saw 11 cars (four with Russian Federation licence plates as well as seven with "DPR" plates), and ten covered cargo trucks (eight with Ukrainian and one with Russian Federation licence plates, as well as one with "DPR" plates) exiting Ukraine.

On 30 November and 1 December, while at the border crossing point near Ulianivske (61km south-east of Donetsk) for about 15 and 30 minutes respectively, the SMM saw two pedestrians (a man and a woman in their fifties) entering Ukraine.

The SMM monitored peaceful gatherings in Chernivtsi and in Kyiv

On 28 November, in front of the Shevchenko Monument at the central square in Chernivtsi, the SMM observed a peaceful gathering of about 20 people (mostly men, mixed ages), some wearing uniforms with Right Sector (*Pravyi Sektor*) insignia, expressing messages critical of the signing of the text of the "Steinmeier formula". The SMM observed about 20 police officers and saw the protesters disperse without incidents.

On 1 December, the SMM monitored a pre-announced public gathering by the Right Sector (*Pravyi Sektor*) in front of the building of the Presidential Administration at 11 Bankova Street in Kyiv. The Mission saw about 150 people (mostly men, mixed ages) gathered, some wearing military-style clothing. The SMM saw about 12 police officers and 20 dialogue police officers. No incidents were observed.

The SMM monitored the security situation in south-east parts of Kherson region

On 29 November, the SMM observed calm situations at the checkpoints between Kalanchak (67km south-east of Kherson) and Chaplynka (77km south-east of Kherson) and Crimea.

The Mission continued monitoring in Odessa, Lviv, Ivano-Frankivsk, Kharkiv and Dnipro.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, UXO and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM

<u>Daily Report of 19 November 2019</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following <u>the fatal incident of 23 April 2017 near Pryshyb</u>; these restrictions continued to limit the Mission's observations.

Denial of access:

- On 30 November, at a checkpoint about 800m north of Zaichenko (non-government-controlled, 93km south of Donetsk), two armed members of the armed formations <u>again</u> denied the SMM passage southwards to Sakhanka (non-government-controlled, 97km south of Donetsk) and westwards to Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk), citing "demining activities".
- On 30 November, at a checkpoint west of Bezimenne (non-government-controlled, 100km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage, citing "demining activities".
- On 1 December, at a checkpoint near Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), a member of the armed formations again denied the SMM passage to non-government-controlled areas, citing "demining activities near Sakhanka and Pikuzy".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- On 1 December, on two separate occasions, an SMM mini-unmanned aerial vehicle experienced GPS signal interference, assessed as probably caused by jamming, while flying over areas near Stepne (government-controlled, 29km south-west of Donetsk).⁷


