

Daily Report 296/2019

14 December 2019¹

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in Donetsk region. It recorded an explosion in Luhansk region.
- The Mission continued to monitor the situation in the disengagement areas near Petrivske, Zolote and Stanytsia Luhanska.
- It saw a tank in violation of withdrawal lines in a non-government-controlled area of Luhansk region.
- The SMM saw for the first time six anti-tank mines near a road leading from non-government-controlled Verkhnoshyrokivske to government-controlled Pyshchevyk.
- The SMM monitored adherence to a localized ceasefire to facilitate the drilling of water wells in a non-government-controlled area of Luhansk region. It continued to facilitate the operation of the Donetsk Filtration Station.
- Freedom of movement for the SMM continued to be restricted, including near Korsun, Staropetrivske and at a checkpoint close to Verkhnoshyrokivske, all in nongovernment-controlled areas of Donetsk region.*



In Donetsk region, the SMM recorded more ceasefire violations, including, more explosions (about 230), compared with the <u>previous reporting period</u> (30 explosions). The majority of explosions were recorded at south-easterly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk) while the majority of shots and bursts were recorded at south-easterly and south-westerly directions of Yasynuvata (non-government-controlled, 16km north-east of Donetsk).

In Luhansk region, the Mission recorded an undetermined explosion in an area south-west of Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk) (see below). In the <u>previous reporting period</u>, the SMM recorded no ceasefire violations in Luhansk region.

Disengagement areas near Petrivske, Zolote and Stanytsia Luhanska 5

During the day on 13 December, positioned near the **disengagement area close to Petrivske** (non-government-controlled, 41km south of Donetsk), the SMM observed a calm situation.

On 13 December, positioned on the southern edge of the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk), the SMM saw 17 workers with chainsaws and five de-miners from non-government-controlled areas, as well as two members of the armed formations (wearing armbands with "JCCC" written on them) enter the area. Throughout the day, the Mission saw five members of the armed formations (wearing armbands with "JCCC" written on them) at the southern edge of the area.

On 13 December, inside the **disengagement area near Stanytsia Luhanska**, the SMM saw three workers from non-government-controlled areas welding new railings on the western side of the metal span of the Stanytsia Luhanska bridge (15km north-east of Luhansk). Approximately 200m south, the SMM saw two workers drilling holes to install reportedly a new fence on the eastern side on the road leading to the metal span of the bridge. Throughout the day, the Mission saw five members of the armed formations (wearing armbands with "JCCC" written on them) between the checkpoint of the armed formations and the new section of the bridge.

The same day, positioned on the north-eastern edge of Stanytsia Luhanska, the SMM heard an undetermined explosion at an assessed range of 3-5km south-west (assessed as outside the disengagement area but within its 5km periphery).

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

It saw a tank in violation of withdrawal lines in a non-government-controlled area of Luhansk region. The SMM also saw two towed howitzers beyond withdrawal lines but outside of designated storage areas in a government-controlled area of Donetsk region (for further details, see the table below).

Indications of military and military-type presence inside the security zone⁶

The SMM saw infantry fighting vehicles, armoured personnel carriers, armoured reconnaissance vehicles and an anti-aircraft gun inside the security zone on both sides of the contact line (for further details, see the table below). Additionally, an SMM mini-unmanned aerial vehicle (UAV) spotted military-type positions (two concrete bunkers under construction) within a residential area of Sosnivske (non-government-controlled, 78km south of Donetsk).

Presence of anti-tank mines near a checkpoint in Verkhnoshyrokivske

The SMM saw for the first time six anti-tank mines north of a road leading from Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk) to Pyshchevyk (government-controlled, 84km south of Donetsk). The mines were about 1km from the checkpoint of the armed formations and about 3.5km from the entry-exit checkpoint of the Ukrainian Armed Forces. One of the aforementioned mines was as close as 2.5m from the side of the road.

SMM facilitation of repairs and operation of critical civilian infrastructure

The SMM monitored adherence to a localized ceasefire to facilitate the drilling of water wells near Pankivka (non-government-controlled, 16km north of Luhansk) and continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk).

Border areas outside government control

While at a border crossing point near Novoazovsk (102km south-east of Donetsk) for about 30 minutes, the SMM saw four cars (one with Georgian licence plates and three with "DPR" plates) and three covered cargo trucks (two with Ukrainian licence plates and one with "DPR" plates) entering Ukraine. It also saw three cars (two with Ukrainian and one with Russian Federation licence plates) exiting Ukraine.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Coordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report of 11 December 2019). The SMM's operations in Donetsk and Luhansk regions remain restricted following

the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denials of access:

- About 1.5km north-east of Korsun (non-government-controlled, 31km north-east of Donetsk), two armed members of the armed formations stopped the SMM and denied it passage towards Debaltseve (non-government-controlled, 58km north-east of Donetsk), citing "ongoing training in the area".
- About 1.5km north of Staropetrivske (non-government-controlled, 35km north-east of Donetsk), two armed members of the armed formations stopped the SMM and denied it passage towards non-government-controlled Donetsk city, citing "ongoing training in the area".
- At a checkpoint about 600m west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), three armed members of the armed formations denied the SMM passage eastwards, citing "ongoing demining activities in the area". The SMM saw several vehicles driving through in both directions.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.



(In red: a forward patrol base from which SMM staff has temporarily relocated based on recommendations of security experts from participating States as well as SMM security considerations. The SMM uses the premises during daylight hours and patrols in this settlement during daylight hours, as well).
