

# Daily Report 20/2020

25 January 2020<sup>1</sup>

#### **Summary**

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in both Donetsk and Luhansk regions.
- Small-arms fire was assessed as directed at an SMM mini-unmanned aerial vehicle flying over areas near non-government-controlled Krasnyi Yar, in Luhansk region.\*
- The Mission continued monitoring the security situation at the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. A member of the armed formations again restricted the Mission's access near the Petrivske disengagement area, including to the SMM camera.\*
- The SMM's freedom of movement continued to be restricted, including at five checkpoints of the armed formations in southern Donetsk region and close to two border crossing points in non-government-controlled areas of Luhansk region.\*

#### Ceasefire violations<sup>2</sup>





In Donetsk region, the SMM recorded more ceasefire violations, including about 350 explosions, compared with the <u>previous reporting period</u> (about 150 explosions). Almost half of the ceasefire violations, including almost half of the explosions, were recorded at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk) and in areas west and north-west of non-government-controlled Donetsk city.

In Luhansk region, the Mission recorded more ceasefire violations, including more explosions (about 110), compared with the <u>previous reporting period</u> (four explosions). The majority of ceasefire violations, including the majority of explosions, were recorded in areas north-east of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below) and north-west of Sentianivka (formerly Frunze, non-government-controlled, 44km west of Luhansk).

#### Small-arms fire assessed as directed at SMM mini-unmmaned aerial vehicle

On 24 January, while conducting an SMM mini-unmanned aerial vehicle (UAV) flight over areas near Krasnyi Yar (non-government-controlled, 12km north-east of Luhansk), the SMM heard a burst of small-arms fire at an assessed range of 1-1.5km north-east, assessed as directed at the UAV, which was flying about 1.3km north-east of its position. The SMM landed its UAV safely and left the area.\*

#### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>5</sup>

During the day on 24 January, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw six members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge (15km north-east of Luhansk) and their checkpoint south of it.

On 24 January, positioned on the southern edge of the **disengagement area near Zolote** the SMM heard 15 undetermined explosions and about 110 shots and bursts of heavy-machine-gun fire at an assessed range of 3-8km east and north-east (all assessed as outside the disengagement area). The same day, the SMM also saw a white non-SMM UAV hovering for about 30min at an altitude of approximately 150m inside area (near its southern edge), before heading north. Throughout the day, the Mission saw four members of the armed formations (wearing an armband with "JCCC" written on it) on the southern edge of the disengagement area. Outside the disengagement area, the SMM saw six Ukrainian Armed Forces personnel digging up trenches on the western edge of Zolote-4/Rodina (government-controlled, 59km west of Luhansk), south of the road running parallel to the disengagement area.

In the morning of 24 January, while positioned at two locations near the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), the SMM heard ten undetermined explosions (all assessed as outside the disengagement area). Positioned near the SMM camera 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the SMM saw black smoke rising at an assessed range of 2-3km east-south-east (unable to be assessed as inside or outside the disengagement area). In the afternoon of the same day, the SMM camera 2km east of Bohdanivka recorded three projectiles in flight at an assessed range of 2-4km east-north-east (all assessed as outside the disengagement area). The same day, at a checkpoint about 3km north of Petrivske, an armed member of the armed formations again

denied the SMM passage south towards the settlement, hindering the Mission's monitoring of the area and access to its camera.\*

#### Indications of military and military-type presence in the security zone<sup>6</sup>

The SMM saw military and military-type presence in the security zone on both sides of the contact line (for further details, see above and the table below).

#### Presence of new mine hazard sign near non-government-controlled Raivka

The SMM saw that a previously observed roadblock on a road leading from Raivka (non-government-controlled, 16km north-west of Luhansk) to Kruta Hora (non-government-controlled, 16km north-west of Luhansk) had been removed. The SMM also saw that a red sign with "Stop mines" written on it in Russian language, which previously was observed atop of the roadblock, was now lying on the ground about 1.5m south-east of the aforementioned road (for previous observations in the area see SMM Daily Report 18 January 2020).

#### SMM facilitation of maintainance and operation of critical civilian infrastructure

The SMM facilitated and monitored adherence to a localized ceasefire to enable maintenance of the phenol sludge reservoir near Zalizne (formerly Artemove, government-controlled, 42km north-east of Donetsk). Positioned on the eastern edge of Zalizne during the aforementioned maintenance works, the SMM recorded five bursts of small-arms fire at an assessed range of 2-3km south-east.

The Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitor the security situation in the area of the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

#### Border areas outside government control

While at a border crossing point near Uspenka (73km south-east of Donetsk) for about one hour, the SMM saw 30 cars (four with Ukrainian licence plates and 26 with "DPR" plates), two covered cargo trucks (one with Ukrainian licence plates and one with "DPR" plates), one bus with "DPR" plates and seven pedestrians (four men and three women, mixed ages) entering Ukraine. The Mission also saw 22 cars (five with Ukrainian, seven with Russian Federation and two with Georgian licence plates, as well as eight with "DPR" plates), three covered cargo trucks (one with Ukrainian licence plates and two with "DPR" plates) and two buses with "DPR" plates exiting Ukraine.

At a border crossing point near Izvaryne (52km south-east of Luhansk), the SMM saw no traffic in either direction. After about six minutes, a member of the armed formations told the SMM to leave the area.\* At a pedestrian border crossing point near Sievernyi (50km south-east of Luhansk), the SMM saw no traffic in either direction. After about 15 minutes, a member of the armed formations told the SMM to leave the area.\*

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

## \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see below). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

#### Denials of access:

- At a checkpoint of the armed formations about 3km north of Petrivske (non-government-controlled, 41km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage south towards the settlement, citing "orders from superiors due to an ongoing operation in the area".
- At a checkpoint near Starolaspa (non-government-controlled, 51km south of Donetsk), an armed member of the armed formations denied the SMM passage, citing "an ongoing operation in the area".
- On two occasions, at a checkpoint north of Zaichenko (non-government-controlled, 93km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage towards Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk) and Sakhanka (non-government-controlled, 97km south of Donetsk), citing "ongoing demining activities". The SMM saw several civilian vehicles driving through the checkpoint.
- At a checkpoint near Prymorske (non-government-controlled, 76km south of Donetsk), two armed members of the armed formations denied the SMM passage towards Naberezhne (non-government-controlled, 77km south of Donetsk), citing "an ongoing operation in the area".
- At a checkpoint east of Sosnivske (non-government-controlled, 78km south of Donetsk), an armed member of the armed formations denied the SMM passage, citing "ongoing kinetic activities in the area" and "concerns for the SMM's safety".
- At a border crossing point near Izvaryne (non-government-controlled, 52km south-east of Luhansk), a member of the armed formations told the SMM to leave the area.
- At a pedestrian border crossing point near Sievernyi (non-government-controlled, 57km south-east of Luhansk), a member of the armed formations told the SMM to leave the area, citing the need of permission from senior members of the armed formations.

#### Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

#### Delays:

- On two occasions, at a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), a member of the armed formations allowed the SMM passage after about 20 minutes of waiting.

#### Other impediments:

- While conducting a mini-UAV flight over areas near Krasnyi Yar (non-government-controlled, 12km north-east of Luhansk), the SMM heard a burst of small-arms fire, assessed as directed at its UAV.
- SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Pyshchevyk (government-controlled, 84km south Donetsk).<sup>7</sup>


