

Daily Report 21/2020

27 January 2020¹

Summary


- Compared with the previous reporting period, between the evenings of 24 and 25 January, the SMM recorded fewer ceasefire violations in both Donetsk and Luhansk regions.
- Between the evenings of 25 and 26 January, the Mission recorded fewer ceasefire violations in Donetsk region and more in Luhansk region, compared with the previous 24 hours.
- Small-arms and heavy-machine-gun fire was assessed as directed at an SMM miniunmanned aerial vehicle near non-government-controlled Holubivske, Luhansk region.
- The Mission continued monitoring the security situation at the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. The SMM recorded ceasefire violations inside the disengagement area near Petrivske.
- The SMM saw weapons in violation of withdrawal lines in non-government-controlled areas of Donetsk region.
- The SMM monitored adherence to localized ceasefires to enable the operation of critical civilian infrastructure.
- The SMM's freedom of movement continued to be restricted, including at checkpoints of the armed formations near Verkhnoshyrokivske and Zaichenko, and for the eighth consecutive time close to the disengagement area near Petrivske.*

Number of recorded explosions⁴



In Donetsk region, between the evenings of 24 and 25 January, the SMM recorded fewer ceasefire violations, including fewer explosions (about 120), compared with the <u>previous reporting period</u> (about 350 explosions). About two-thirds of ceasefire violations were recorded in areas north, south-west and west of Donetsk city centre (non-government-controlled) and at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk).

Between the evenings of 25 and 26 January, the Mission recorded fewer ceasefire violations, including fewer explosions (about 65), compared with the previous 24 hours. The majority of ceasefire violations, including about half of the explosions, were recorded at easterly and southerly directions of Berezove (government-controlled, 31km south-west of Donetsk), as well as at southerly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk).

In Luhansk region, between the evenings of 24 and 25 January, the Mission recorded fewer ceasefire violations (two, including one explosion), compared with the <u>previous reporting period</u> (about 110 explosions). Both ceasefire violations were recorded close to the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below).

Between the evenings of 25 and 26 January, the SMM recorded more ceasefire violations, including more explosions (140), compared with the previous 24 hours. The majority of ceasefire violations were recorded in areas north-east of Holubivka (formerly Kirovsk, non-government-controlled, 51km west of Luhansk).

Small-arms and heavy-machine-gun fire assessed as directed at SMM mini-unmanned aerial vehicle near Holubivske

On 26 January, positioned in the centre of Holubivske (non-government-controlled, 51km west of Luhansk) while conducting an SMM mini-unmanned aerial vehicle (UAV) flight, the SMM heard about 100 shots of small-arms and heavy-machine-gun fire at an assessed range of 1-2km north-east, assessed as directed at the UAV, which was flying about 1.7km north-east of the SMM's position. The SMM landed its UAV safely and left the area.*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 25 and 26 January, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge (15km north-east of Luhansk) and their checkpoint south of it.

On 24 January, outside the disengagement area near Stanytsia Luhanska, an SMM mini-UAV <u>again</u> spotted an anti-aircraft gun (ZU-23, 23mm) (covered by ammunition boxes and wooden planks) near the Prince Ihor Monument south-east of the disengagement area.

On 24 January, inside the **disengagement area near Zolote**, about 350m south of the area's northern edge and about 550m east of road T-1316, an SMM mini-UAV spotted a man walking on the railway tracks. Later in the same area, the same UAV also spotted a man entering a shelter, assessed as part of a former position of the Ukrainian Armed Forces. On 25 January, the SMM camera in Zolote recorded an undetermined explosion and a projectile in flight at an assessed range of 2-4km east-north-east and east, both assessed as outside the disengagement area but

within 5km of its periphery. On the same day, the SMM saw a member of the armed formations (wearing an armband with "JCCC" written on it) on the southern edge of the disengagement area.

On 24 January, outside the disengagement area near Zolote, an SMM mini-UAV spotted two infantry fighting vehicles (IFV) (BMP-2), one about 100m east and the other about 100m west of a checkpoint of the Ukrainian Armed Forces about 300m north of the disengagement area. An SMM long-range UAV also spotted two armoured combat vehicles, also about 100m east of the same checkpoint. On 26 January, the SMM saw four IFVs (BMP-2) within a 200m radius of the same checkpoint, as well as 20 soldiers of the Ukrainian Armed Forces in the area of the checkpoint. On the mornings of 25 and 26 January, on four occasions, about 350m east of the disengagement area and about 700m south of Zolote-5/Mykhailivka (non-government-controlled, 58km west of Luhansk), the SMM saw two men in civilian clothing and two members of the armed formations digging in the ground about 20m west of a road. On the afternoon of 26 January, while positioned on the southern edge of the disengagement area, the SMM saw a dark fixed-wing UAV flying about 100-300m south of its position.

On the night between 25 and 26 January, the SMM camera in Zolote recorded an undetermined explosion at an assessed range of 3-5km east-south-east. On the morning of 26 January, positioned in two locations near the disengagement area near Zolote, the SMM heard 23 undetermined explosions and about 40 bursts of heavy-machine-gun fire. All of the above ceasefire violations were assessed as outside the disengagement area but within 5km of its periphery.

On the evening and night between 24 and 25 January, the SMM camera 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded eight projectiles in flight at an assessed range of 2-4km east and east-south-east and assessed as inside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), as well as nine projectiles at an assessed range of 4-6km east and east-south-east and assessed as outside the disengagement area but within 5km of its periphery. On the afternoons of 24 and 25 January, the same camera recorded two projectiles in flight and four muzzle flashes, all at an assessed range of 2-5km east and east-south-east and of which the SMM was unable to assess as inside or outside the disengagement area.

On the evening of 25 January and afternoon of 26 January, the SMM camera 2km east of Bohdanivka recorded about 60 projectiles in flight and a muzzle flash, all at an assessed range of 1-3km east and east-south-east and assessed as inside the disengagement area.

On 24 January, outside the disengagement area near Petrivske, an SMM long-range UAV spotted two trenches (not seen in imagery from 12 September 2019) about 100-300m west of the western edge of the disengagement area, both running north to south for about 95m and 530m and assessed as belonging to the Ukrainian Armed Forces. About 4km south-east of Bohdanivka and about 600m south of the disengagement area, the UAV also spotted two armoured combat vehicles, assessed as belonging to the Ukrainian Armed Forces.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The SMM saw weapons in violation of withdrawal lines in non-government-controlled areas of Donetsk region (for further details, see the table below).

Weapons that the SMM could not verify as withdrawn⁶

At two heavy weapons holding areas in non-government-controlled areas of Donetsk region 26 January

The SMM noted that 28 towed howitzers (D-30 *Lyagushka*, 122 mm) and 21 towed mortars (PM-38, 120mm) continued to be missing.

Indications of military and military-type presence in the security zone⁷

The SMM observed armoured combat vehicles on both sides of the contact line inside the security zone (for further details, see the table below).

On 24 January, about 2km north-east of Zolote-4/Rodina (government-controlled, 59km west of Luhansk), an SMM long-range UAV spotted two men digging a position, including a 10m-long trench (for previous observations in the area, see SMM Daily Report 18 January 2020).

On 26 January, about 3.5km north-east of Zhelanne Druhe (government-controlled, 29km north-west of Donetsk), the SMM saw a mini-van with military licence plates and an antenna placed on a tripod nearby. About 5m from the antenna, the SMM saw a man in camouflage clothing operating a remote control and a fixed-wing UAV flying at an approximate altitude of 50m.

Presence of mortar shell close to SMM camera near Bohdanivka, mine hazard signs in Pionerske and unexploded ordnance near Molodizhne

On 25 and 26 January, about 80m north-west of the SMM camera 2km east of Bohdanivka, the SMM for the first time observed an object assessed as the tailfin of an exploded 120mm mortar shell.

On 25 January, in Pionerske (non-government-controlled, 19km east of Luhansk), the SMM saw two identical signs (red sheets of paper with black lettering in Russian language) informing that it was strictly prohibited to cut wood, pick mushrooms or walk near mine hazard signs along the riverbank between Shchastia (government-controlled, 20km north of Luhansk) and Makariv Yar (formerly Parkhomenko, non-government-controlled, 28km east of Luhansk) to avoid minerelated accidents.

On 26 January, the SMM observed for the first time a piece of unexploded ordnance (UXO) assessed as the tailfin of a probable (73mm) round from a recoilless gun or an IFV (BMP-1) cannon, placed atop a brick wall of a checkpoint of the armed formations on road T-0504 about 2km south-west of Molodizhne (non-government-controlled, 63km north-west of Luhansk).

SMM facilitation of operation of critical civilian infrastructure

On 25 and 26 January, the Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk). On 26 January, it monitored the security situation in areas

around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, UXO and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report 25 January 2020). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- On 25 January, at a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), an armed member of the armed formations again denied the SMM passage, citing an "order from superiors".
- On 25 and 26 January, at a checkpoint of the armed formations about 3km north of Petrivske (non-government-controlled, 41km south of Donetsk), armed members of the armed formations <u>again</u> denied the SMM passage southwards towards the disengagement area near Petrivske, citing an "order from superiors" as well as "an ongoing operation" and "demining activities in the area".
- On 26 January, at a checkpoint north of Zaichenko (non-government-controlled, 93km south of Donetsk), an armed member of the armed formations again denied the SMM passage towards Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk) and Sakhanka (non-government-controlled, 97km south of Donetsk), citing "ongoing demining activities".

Delay:

- At a checkpoint west of Verkhnoshyrokivske, on two occasions, armed members of the armed formations allowed the SMM passage after about 50 and 110 minutes of waiting.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- During the day on 24 January, an SMM long-range UAV experienced GPS signal interference, assessed as caused by probable jamming over areas north, east, south-east, south, south-west, west and north-west of Donetsk city (non-government-controlled) on both sides of the contact line and in areas north and west of Luhansk city (non-government-controlled). The same UAV experienced dual GPS signal interference, assessed as caused by jamming, while flying over areas between Staromykhailivka (non-government-controlled, 15km west of Donetsk) and Syhnalne (non-government-controlled, 23km south-west of Donetsk), as well as between Styla (non-government-controlled, 45km south-east of Donetsk), and between Donetskyi (non-government-controlled, 49km west of Luhansk) and Lopaskyne (government-controlled, 23km north-west of Luhansk).
- During the day on 25 January, on two occasions, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over Petrivske (non-government-controlled, 41km south of Donetsk).
- During the day on 25 January, an SMM mid-range UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Novotroitske (government-controlled, 36km south-west of Donetsk).
- During the day on 26 January, positioned in Holubivske (non-government-controlled, 51km west of Luhansk), the SMM heard 100 shots of small-arms and heavy-machinegun fire, assessed as directed at its UAV (see above).
- During the day on 26 January, on two occasions, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over the disengagement area near Petrivske.
