


Daily Report 26/2020

1 February 202<u>0</u>1

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in Donetsk region and fewer in Luhansk region.
- Civilian buildings were damaged by shelling in non-government-controlled Berezivske, in Luhansk region.
- Small-arms fire was assessed as aimed at an SMM mini-unmanned aerial vehicle near Stanytsia Luhanska.
- The Mission continued monitoring the security situation at the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske.
- It saw mortars in violation of withdrawal lines in a non-government-controlled area of Luhansk region.
- The SMM monitored adherence to localized ceasefires to facilitate repair works to water wells near Slovianoserbsk.
- The SMM's freedom of movement continued to be restricted, including at a checkpoint in non-government-controlled Diakove in Luhansk region and at checkpoints near non-government-controlled Sosnivske and Tavrycheske, in southern Donetsk region.*

Ceasefire violations²





In Donetsk region, the SMM recorded more ceasefire violations, including, however, fewer explosions (125), compared with the <u>previous reporting period</u> (about 180 explosions). The majority of ceasefire violations were recorded in areas west and west-north-west of Horlivka (non-government-controlled, 39km north-east of Donetsk), north and north-north-east of Shyrokyne (government-controlled, 100km south of Donetsk), and at south-easterly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk).

In Luhansk region, the Mission recorded fewer ceasefire violations, including fewer explosions (about 100), compared with the <u>previous reporting period</u> (about 310 explosions). The majority of ceasefire violations were recorded in areas south-south-west of Kriakivka (government-controlled, 38km north-west of Luhansk) and north-west of Slovianoserbsk (non-government-controlled, 28km north-west of Luhansk).

Civilian buildings damaged by shelling in Berezivske

At an abandoned one-storey shop at 58 Pervomaiska Street in Berezivske (non-government-controlled, 53km north-west of Luhansk), the SMM saw a fresh impact crater about 3m west of the building, assessed as caused by a 120mm mortar round. Two west-facing windows of the building were shattered, assessed as caused by shrapnel, and the SMM saw several shrapnel marks covering the west-facing wall, all assessed as fresh.

About 10m south of the previously-mentioned building, at an inhabited one-storey residential house at 60 Pervomaiska Street, the SMM saw two holes in a west-facing window, as well as six holes in a west-facing metal gate, all assessed as fresh and caused by shrapnel.

About 30m west-south-west of the previously-mentioned house, at two uninhabited one-storey residential houses at 41 Pervomaiska Street, the SMM saw four shattered north-facing windows, as well as holes in an east-facing wooden fence. All of the above damage was assessed as fresh and caused by shrapnel.

Small-arms fire assessed as directed at an SMM mini-unmanned aerial vehicle near Stanytsia Luhanska

While conducting an SMM mini-unmanned aerial vehicle (UAV) flight in the central part of Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk), the SMM heard ten shots of small-arms fire at an assessed range of 1-2km west, assessed as directed at the UAV, which was flying about 1km west of the SMM's position. The SMM safely landed the UAV and left the area.*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

Inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km northeast of Luhansk), the SMM saw seven members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge (15km north-east of Luhansk) and their checkpoint south of it.

On the evening and night of 30-31 January, the SMM camera in Zolote (government-controlled, 60km west of Luhansk) recorded four projectiles in flight, an illumination flare and eight

undetermined explosions at an assessed range of 4-7km east and east-south-east, assessed as outside the **disengagement area near Zolote** but within 5km of its periphery. Throughout the day on 31 January, on the southern edge of the disengagement area, the SMM saw five members of the armed formations (wearing armbands with "JCCC" written on them).

On the evening and night of 22-23 January, the SMM camera in Petrivske (non-government-controlled, 41km south of Donetsk) recorded 15 projectiles in flight from easterly to westerly directions at an assessed range of .2-1km south-west and west-south-west. On the evening and night of 23-24 January, the same camera recorded 19 projectiles in flight from easterly to westerly directions at an assessed range of .5-1km south-west and south-west, as well as four projectiles in flight at an assessed range of 1-2km south-south-west. All of the above ceasefire violations were assessed as inside the **disengagement area near Petrivske**.⁶

On 31 January, positioned about 1.8km north of Petrivske, the SMM heard and saw three explosions, assessed as impacts, at an assessed distance of 3km south, which were unable to be assessed as inside or outside of the disengagement area. It also heard five shots of small-arms fire at an assessed range of 2-3km south, assessed as outside of the disengagement area.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed two mortars in violation of withdrawal lines in a non-government-controlled area of Luhansk region (for further details, see the table below).

Indications of military and military-type presence in the security zone⁷

The SMM observed armoured combat vehicles inside the security zone in government-controlled areas of both Luhansk and Donetsk regions (for further details, see the table below).

SMM facilitation of repairs to and operation of critical civilian infrastructure

The SMM monitored adherence to localized ceasefires to enable repairs to water wells near Slovianoserbsk (non-government-controlled, 28km north-west of Luhansk). The Mission also continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitored the security situation around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see below). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint east of Sosnivske (non-government-controlled, 78km south of Donetsk), three members of the armed formations denied the SMM passage to the settlement.
- At a checkpoint near Tavrycheske (non-government-controlled, 76km south of Donetsk), an armed member of the armed formations denied the SMM passage to the settlement, citing sniper activity in the area. While present, the SMM saw civilian traffic proceeding through the checkpoint in both directions.
- On the southern outskirts of Diakove (non-government-controlled, 70km south-west of Luhansk), two armed members of the armed formations stopped the SMM and denied it access towards the border area near Leonove (formerly Chervonyi Zhovten, non-government-controlled, 82km south of Luhansk), citing lack of permission from superiors.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Delay:

At a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), on two occasions, armed members of the armed formations <u>again</u> allowed the SMM passage only after about 35 and 50 minutes of waiting.

Other impediments:

- An SMM mini- and mid-range UAV flying over areas near Petrivske (non-government-controlled, 21km south of Donetsk) experienced GPS signal interference, assessed as caused by probable jamming and by jamming, respectively. 8

- An SMM mini-UAV flying over areas near Petrivske (non-government-controlled, 41km south of Donetsk) experienced GPS signal interference, assessed as caused by probable jamming, on four occasions.⁹
- An SMM mini-UAV flying over areas near Orikhove (government-controlled, 57km north-west of Luhansk) experienced GPS signal interference, assessed as caused by probable jamming.¹⁰
- While conducting a mini-UAV flight near Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk), the SMM heard ten shots of small-arms fire, assessed as directed at the UAV (see above).



This map of eastern Ukraine is meant for illustrative purposes and indicates locations mentioned in the report, as well as those where the SMM has offices (monitoring teams, patrol hubs, and forward patrol bases) in Donetsk and Luhansk regions. (In red: a forward patrol base from which SMM staff has temporarily relocated based on recommendations of security experts from participating States as well as SMM security considerations. The SMM uses the premises during daylight hours and patrols in this settlement during daylight hours, as well).
