

# **Daily Report 43/2020**

21 February 2020<sup>1</sup>

### **Summary**

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in both Donetsk and Luhansk regions.
- The Mission saw fresh damage from shelling to residential buildings and a power • substation in non-government-controlled Zolote-5/Mykhailivka and Holubivske.
- The SMM continued monitoring the disengagement areas near Stanytsia Luhanska, . Zolote and Petrivske.
- The Mission facilitated localized ceasefires to enable a transfer of reportedly human remains of two Ukrainian Armed Forces personnel from non-government- to government-controlled areas, as well as to enable repairs to critical civilian infrastructure.
- The SMM's freedom of movement continued to be restricted, including at a checkpoint • of the armed formations near Verkhnoshyrokivske.\*
- The Mission monitored public gatherings commemorating those who lost their lives during Maidan-related events in 2014.



### Map of recorded ceasefire violations



In Donetsk region, the SMM recorded more ceasefire violations, including, however, fewer explosions (90), compared with <u>the previous reporting period</u> (about 105 explosions). Almost half of the ceasefire violations, including 26 explosions, were recorded in areas near the Donetsk Filtration Station (DFS) (15km north of Donetsk).

In Luhansk region, the Mission recorded more ceasefire violations, including, however, fewer explosions (27), compared with <u>the previous reporting period</u> (about 70 explosions). More than half of the ceasefire violations, including almost half the explosions, were recorded in areas north of Berezivske (non-government-controlled, 53km north-west of Luhansk) and north-east and west of Holubivske (non-government-controlled, 51km west of Luhansk).

## Fresh damage from shelling to residential buildings in Zolote-5/Mykhailivka and Holubivske

On 19 February, the SMM saw damage to two residential buildings in Zolote-5/Mykhailivka (non-government-controlled, 58km west of Luhansk) as well as four residential buildings and a power substation in Holubivske (non-government-controlled, 51km west of Luhansk).

At 22 Kotovskoho Street, in the north-eastern part of Zolote-5/Mykhailivka, the Mission saw a hole (about 3m in diameter) in the north-west-facing side of a brick garage located about 10m south of an inhabited one-storey house. Inside the garage, the Mission saw pieces of wood and plaster strewn across the floor. At the house, it saw that four south-west-facing were broken or shattered and pockmarks in the same wall. The Mission assessed all damage as fresh and caused by the impact of an 82mm mortar round (it could not determine the direction of fire) and shrapnel. A man (in his fifties) who introduced himself as the owner of the house told the Mission that at about 10:00-11:00 on 18 February he had been in the garden of his house when an impact occurred nearby.

At 1 Sverdlova Street, about 50m south-east of the abovementioned property, the SMM saw seven craters around a one-storey house (six about 60cm in diameter and one about 8-10cm in diameter, all 4-20m north-east, south and north-west of the house). The SMM saw that the house's six north-facing windows were broken. It saw pockmarks in the west-facing side of the house and two holes in a west-facing and a south-facing window. In the south-facing side of a summer kitchen located about 5m north-east of the house, the SMM saw pockmarks and a window with broken panes. The Mission assessed the craters as fresh and caused by impacts of 82mm mortar rounds (it could not determine the direction of fire), and the damage to the house and the summer kitchen as fresh and caused by a blast and shrapnel.

In the southern part of Holubivske, at 12 Przhevalskoho Street, the SMM saw a hole (about 2m by 3.5m) in the roof of a wooden shed located about 3m north of an inhabited one-storey house. Inside the shed, the Mission saw several broken wooden roof beams and other parts of the roof hanging from the walls and ceiling, with pieces of them scattered on the floor. The Mission saw that three north-facing windows were damaged as well. The SMM assessed the damage as fresh and caused by a 120mm mortar round (it could not determine the direction of fire). A man (in his eighties) who introduced himself as the owner of the house told the Mission that at about 9:00 on 18 February he had been in front of the house when he heard a loud explosion near the shed.

At 19/1 Przhevalskoho Street, about 180m west from the abovementioned address, the SMM saw several damaged north-facing window panes of an inhabited one-storey house.

At 22/12 Radhospna Street, about 150m north of the abovementioned properties on Przhevalskoho Street, the SMM saw a crater (about 2m in diameter) about 23m north of an inhabited two-storey building. The Mission assessed the crater as fresh and caused by a 122mm artillery round; however, it could not determine the direction of fire. On the building's north-facing side, the Mission saw at least 80 holes (all about 15-20cm in diameter) and that at least 18 windows on both floors were shattered. Inside a first-floor apartment, the SMM saw small holes in the east- and south-facing walls and in a glass door in an adjacent room. All damage to the building and the apartment was assessed as caused by shrapnel. A woman (in her fifties) who introduced herself as the owner of the apartment told the Mission that she did not live there and that her neighbours had told her that the damage occurred on the morning of 18 February.

At 15 Radhospna Street, about 300m west of the abovementioned property, the Mission saw a hole (about 1m in diameter) about 1.5m south of the south-facing side of a transformer substation. The SMM saw pockmarks in and black traces on its side. It also saw two small holes in two west-facing windows of an adjacent inhabited one-storey house. The SMM assessed the damage to the substation and to the windows of the house as fresh and caused by shrapnel. A resident (woman, in her fifties) told the Mission that the substation had been damaged on the morning of 18 February and that it remained operational. (For previous observations from Holubivske, see <u>SMM Daily Report 20 February 2020.</u>)

### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>5,6</sup>

On 20 February, inside the **disengagement area near Stanytsia Luhanska** (governmentcontrolled, 16km north-east of Luhansk), the SMM saw six members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge (15km north-east of Luhansk) and their checkpoint south of it.

On 20 February, while positioned in four locations near the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk), the SMM heard six undetermined explosions and about 55 bursts and shots of automated-grenade-launcher, heavy-machine-gun and small-arms fire, all assessed as outside the disengagement area but within 5km of its periphery. The Mission saw six members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area.

On the evening of 18 February, the SMM camera in Petrivske (non-government-controlled, 41km south of Donetsk) recorded two projectiles in flight at an assessed range of 300-500m south-south-west and assessed as inside **the disengagement area near Petrivske**.<sup>7</sup> On 20 February, while positioned about 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the SMM heard two shots and a burst of small-arms fire at an assessed range of 2-3km south-east and assessed as inside the disengagement area, as well as a shot of small-arms fire assessed as outside the disengagement area but within 5km of its periphery. On the same day, while positioned about 2km north of Petrivske, the Mission heard nine shots of small-arms fire assessed as outside the disengagement area but within 5km of its periphery.

### Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum (see the table below).

#### Weapons storage sites

At a heavy weapons permanent storage site in a non-government-controlled area of Luhansk region

20 February

The Mission noted that a self-propelled howitzer (2S1 *Gvozdika*, 122mm) was missing for the first time.

### Indications of military and military-type presence in the security zone<sup>8</sup>

The SMM observed military and military-type presence on both sides of the contact line, including in the zone within which deployment of heavy armaments and military equipment is proscribed according to Point 5 of the Memorandum of 19 September 2014 (for further details, see the table below).

### Mines near Hnutove and unexploded ordnance near Pankivka

On 20 February, an SMM mini-unmanned aerial vehicle <u>again</u> spotted 13 anti-tank mines (probable TM-62), about 3.5km south-east of Hnutove (government-controlled, 90km south of Donetsk), assessed as belonging to the Ukrainian Armed Forces.

On the same day, about 3km south-east of Pankivka (non-government-controlled, 16km north of Luhansk), the Mission saw for the first time an unfenced piece of unexploded ordnance (UXO), assessed as the rocket motor tube from a multiple launch rocket system (BM-21 *Grad*, 122mm), lying in a vertical position (assessed as not recent) about 5m east of a local road.

### SMM facilitation of the transfer of reportedly human remains of Ukrainian Armed Forces personnel of, and of repairs and the operation of critical civilian infrastructure

The SMM facilitated and monitored adherence to a localized ceasefire to allow a transfer of reportedly human remains of two Ukrainian Armed Forces personnel from non-government- to government-controlled areas across the bridge in Shchastia (government-controlled, 20km north of Luhansk).

The SMM facilitated and monitored adherence to localized ceasefires to enable repairs to water pipelines near Pervomaiske (government-controlled, 17km north-west of Donetsk) and near Pivnichne (formerly Kirove, government-controlled, 44km north-east of Donetsk), and to power lines between Berezivske and Donetskyi (non-government-controlled, 49km west of Luhansk). The Mission continued facilitating the maintenance and operation of the DFS.

The Mission also continued to monitor adherence to a localised ceasefire in order to enable a transfer of funds from non-government- to government-controlled areas of Luhansk region, reportedly related to water payments (see <u>SMM Daily Report 20 February 2020</u>).

### Gatherings commemorating Maidan-related events in 2014

On 20 February, the Mission monitored peaceful public gatherings attended by participants of mixed ages and genders in Kyiv (about 450 people), Kharkiv (about 350), Dnipro (about 300), Chernivtsi (about 300), Uzhhorod (about 250), Kherson (about 120), Lviv (about 100), Odessa (about 100) and Ivano-Frankivsk (about 30), all organized in commemoration of those who lost their lives during Maidan-related events in 2014. During some of these gatherings, the SMM observed religious services taking place and participants laying flowers at monuments dedicated to the Maidan events.

### \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, UXO and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see <u>SMM Daily Report 19 February 2020</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following <u>the fatal incident of 23 April 2017 near Pryshyb</u>; these restrictions continued to limit the Mission's observations.

### Denials of access:

- On two occasions at a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, nongovernment-controlled, 85km south of Donetsk), two armed members of the armed formations <u>again</u> denied the SMM passage, citing "ongoing operation in the area" and "orders from superiors". While at the checkpoint, the Mission saw cars passing through the checkpoint in both directions.

### *Regular restrictions related to disengagement areas and mines/UXO:*

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

### Other impediments:

- On three occasions, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Yasynuvata (non-government-controlled, 16km north-east of Donetsk).<sup>9</sup>
- On three occasions, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Kruta Balka (non-government-controlled, 16 km north of Donetsk).


