

# Daily Report 47/2020


26 February 2020<sup>1</sup>

#### **Summary**

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in Donetsk region and fewer ceasefire violations in Luhansk region.
- The SMM continued monitoring the disengagement areas near Stanytsia Luhanska and Zolote, and recorded ceasefire violations inside the disengagement area near Petrivske.
- An SMM mini-unmanned aerial vehicle spotted anti-tank mines near Luhanske, some of which were about 150m from residential houses.
- The SMM facilitated localized ceasefires to enable repairs to and operation of critical civilian infrastructure, including repairs of water pipelines in Zaitseve.
- Members of the armed formations restricted the SMM's freedom of movement at checkpoints in Verkhnoshyrokivske, Prymorske and Sosnivske, all in southern Donetsk region, and at a border crossing point near Voznesenivka in Luhansk region.\*

#### Number of recorded ceasefire violations<sup>3</sup> Number of recorded explosions<sup>4</sup>





In Donetsk region, the SMM recorded more ceasefire violations, including, however, fewer explosions (about 130), compared with the <u>previous reporting period</u> (about 190 explosions). The majority of ceasefire violations were recorded in areas south and south-east of Svitlodarsk (government-controlled, 57km north-east of Donetsk), south-east of Berezove (government-controlled, 31km south-west of Donetsk) and north and north-north-east of Shyrokyne (government-controlled, 100km south of Donetsk).

In Luhansk region, the SMM recorded fewer ceasefire violations, including fewer explosions (about 40), compared with the <u>previous reporting period</u> (110 explosions). The majority of ceasefire violations, including the majority of explosions, were recorded in areas south-south-east of Zolote (government-controlled, 60km west of Luhansk) and north of Holubivka (formerly Kirovsk, non-government-controlled, 51km west of Luhansk).

#### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>5</sup>

On 25 February, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw six members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the bridge and their checkpoint south of it.

In the early morning hours of 25 February, the SMM camera in Zolote recorded 15 undetermined explosions at an assessed range of 3-5km south-south-east, which were unable to be assessed as inside or outside the **disengagement area near Zolote**.

On 25 February, around 450m south of the northern edge of the disengagement area near Zolote and around 3m east of road T-1316, the SMM saw for the first time three square-shaped wooden ammunition boxes and a cylindrical metal object, assessed as a used smoke grenade tube, lying on the ground. The SMM also saw two members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area.

In the early morning hours of 25 February, the SMM camera 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded six projectiles at an assessed range of 1-3km east and east-south-east, assessed as inside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk). In the early morning hours of 20 February, the SMM camera in Petrivske recorded three projectiles in flight at an assessed range of 0.5-1km south-west, assessed as inside the disengagement area.<sup>6</sup>

#### Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum (see table below for further details).

#### Indications of military and military-type presence in the security zone<sup>7</sup>

The SMM observed armoured combat vehicles and an anti-aircraft gun inside the security zone in government-controlled areas of both Luhansk and Donetsk regions, including within residential areas of Luhanske (government-controlled, 59km north-east of Donetsk) (for further details, see the table below).

#### Anti-tank mines near Luhanske

On 24 February, an SMM mini-unmanned aerial vehicle (UAV) spotted eight anti-tank mines laid across a road running from Luhanske to Rozsadky (non-government-controlled, 62km northeast of Donetsk), about 150m from uninhabited houses, as well as an additional 22 anti-tank mines laid in a field about 300m north, all assessed as belonging to the Ukrainian Armed Forces.

#### Convoy of trucks seen carrying liquified hydrocarbon gas in Khartsyzk

On the road in south-eastern Khartsyzk (non-government-controlled, 26km east of Donetsk), the SMM saw a convoy of 12 covered cargo trucks pulling trailers, as well as six tanker trucks. The trucks were parked on both sides of the road and had Ukrainian and Russian licence plates, as well as "DPR" plates. The tanker trucks had orange hazard identification number placards reading "1965," indicating that they were carrying a liquefied hydrocarbon gas mixture.

#### SMM facilitation of repairs to and operation of critical civilian infrastructure

The Mission facilitated and monitored adherence to localized ceasefires to enable repairs to water pipelines near Zaitseve (50km north-east of Donetsk). It continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and to monitor the security situation in the area of the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

#### SMM monitored the security situation in south-east Kherson region

The SMM observed calm situations at a checkpoint between Chonhar (163km south-east of Kherson) and Crimea, and at a Ukrainian State Border Guard Service security post in Valok (188km south-east of Kherson).

The Mission continued monitoring in Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

## \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts

of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see below.) The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

#### Denial of access:

- At a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage, citing an "ongoing operation." While at the checkpoint, the SMM saw civilian traffic proceeding in both directions.
- At the eastern entrance to Sosnivske (non-government-controlled, 78km south of Donetsk), an armed member of the armed formations denied the SMM passage towards the settlement, citing "order of superiors".
- At a checkpoint near Prymorske (non-government-controlled, 76km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage southwards toward Naberezhne (non-government-controlled, 77km south of Donetsk) and Tavrycheske (non-government-controlled, 76km south of Donetsk), citing "demining, engineering works and anti-sniper activities". However, the SMM was allowed to proceed northwards toward Lukove (non-government-controlled, 72km south of Donetsk). While at the checkpoint, the SMM saw civilian traffic proceeding southwards.
- At a border crossing point near Voznesenivka (formerly Chervonopartyzansk, non-government-controlled, 65km south-east of Luhansk), a member of the armed formations asked the SMM to leave the area.

#### Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.


