

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in both Donetsk and Luhansk regions.
- The Mission continued to monitor the disengagement area near Stanytsia Luhanska, saw mines and unexploded ordnance inside the disengagement area near Zolote, and recorded ceasefire violations inside the disengagement area near Petrivske.
- The SMM saw a long queue of civilians between checkpoints waiting to cross the contact line in Donetsk region.
- It facilitated localized ceasefires to enable repairs to a water pipeline near Zaitseve and power lines near Zolote-5/Mykhailivka and Vesela Hora.
- The SMM's freedom of movement was restricted at a checkpoint of the armed formations near Verkhnoshyrokivske in southern Donetsk region and at a border crossing point near non-government-controlled Dovzhanske in Luhansk region.

Number of recorded ceasefire violations³ Number of recorded explosions⁴





In Donetsk region, the SMM recorded more ceasefire violations, including more explosions (115), compared with the <u>previous reporting period</u> (about 65 explosions). The majority of ceasefire violations were recorded at southerly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk), in areas near the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk) (see below) and at westerly directions of Maiorsk (government-controlled, 45km north-east of Donetsk).

In Luhansk region, the Mission recorded more ceasefire violations, including more explosions (100), compared with the <u>previous reporting period</u> (38 explosions). The majority of ceasefire violations, assessed as part of a live-fire exercise outside the security zone, were recorded at south-westerly directions of Buhaivka (non-government-controlled, 37km south-west of Luhansk), while almost all of the explosions were recorded in areas south of Muratove (government-controlled, 51km north-west of Luhansk).

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 27 February, outside of the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), an SMM mini-unmanned aerial vehicle (UAV) again spotted an armoured combat vehicle (BTR variant) adjacent to a house, assessed as used by the Ukrainian Armed Forces, north-east of the Ukrainian Armed Forces entry-exit checkpoint (EECP). In the same residential area, the UAV also spotted two infantry fighting vehicles (BTR-3E) (see SMM Daily Reports of 19 February 2020 and 20 February 2020). The same UAV again spotted an anti-aircraft gun (ZU-23, 23mm) near the Prince Ihor monument, outside of the disengagement area, about 1km south-east of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

On the same day, while positioned about 300m south of the Stanytsia Luhanska bridge, the SMM heard an explosion at an assessed distance of 600-800m west, assessed as the probable detonation of a mine or unexploded ordnance (UXO) inside the disengagement area. It also heard three bursts of heavy-machine-gun fire at an assessed range of 1-2km north, assessed as outside the disengagement area but within 5km of its periphery. While inside the disengagement area, the SMM saw three members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the bridge and their checkpoint south of it.

On the evening and night of 26-27 February, the SMM camera in Zolote (government-controlled, 60km west of Luhansk) recorded 22 projectiles in flight at an assessed range of 1-3km east, assessed as outside of the **disengagement area near Zolote** but within 5km of its periphery. In the early evening of 27 February, the same camera recorded a large fire in a field about 1km south-east, outside of the disengagement area, that lasted about an hour. Around the same time, the same camera recorded two undetermined explosions at an assessed range of 4-6km east-north-east and east, assessed as outside of the **disengagement area** but within 5km of its periphery, and an undetermined explosion at an assessed range of 3-5km south-south-east, which was unable to be assessed as inside or outside of the disengagement area.

On 27 February, inside the disengagement area near Zolote, the SMM saw for the first time a piece of UXO, assessed as a rocket-propelled grenade launcher round (RPG-18 *Mukha*, 64mm), on the ground about 15m west of road T-1316, which is regularly used by the SMM,

about 1km north of the area's southern edge. About 80m north of the previously-mentioned UXO, the SMM saw for the first time an anti-personnel mine (MON-90) on the ground about 20m west of the road and, about 200m further north, it saw for the first time two anti-tank mines (TM-62) on the ground about 15m west of the road. On the same day, the SMM saw a member of the armed formations (wearing an armband with "JCCC" written on it) near the southern edge of the Zolote disengagement area.

On the evening and night of 26-27 February, the SMM camera 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded an undetermined explosion (assessed as an airburst) and 12 projectiles in flight from north-north-east to south-south-west and south-south-west to north-north-east, all at an assessed range of 2-4km east-south-east and assessed as inside the **disengagement area near Petrivske.** It also recorded about 70 projectiles in flight, mainly from north-north-west to south-south-east and south-south-west to north-north-east, all at an assessed range of 2-5km east and east-south-east, which were unable to be assessed as inside or outside of the disengagement area. The same camera recorded two projectiles in flight from west-north-west to east-south-east, assessed as outside the disengagement area.

On the evening of 21 February, the SMM camera in Petrivske recorded two projectiles in flight at an assessed range of 0.5-2km south. On the evening and night of 23-24 February, the same camera recorded ten projectiles in flight at an assessed range of 0.5-2km south-west and west-south-west, the majority of which were flying from south-south-east to north-north-west, as well as nine muzzle flashes at an assessed range of 0.5-2km south-south-west. All of the above were assessed as inside the disengagement area.⁶

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The SMM observed 22 weapons beyond withdrawal lines in a government-controlled area of Donetsk region and in a training area in a non-government-controlled part of Luhansk region (see the table below for further details) (see the table below for further details).

Weapons the SMM could not verify as withdrawn⁷

At a heavy weapons holding area in a government-controlled area of Luhansk region The SMM noted that three self-propelled howitzers (2S3 Akatsiya, 152mm) and a surface-to-air missile system (9K35 Strela-10) were present.

Indications of military and military-type presence in the security zone⁸

The SMM observed armoured combat vehicles and anti-aircraft guns inside the security zone, mainly in government-controlled areas of Donetsk and Luhansk regions, including within a

residential area of Avdiivka (government-controlled, 17km north of Donetsk) (see the table below for further details).

Long queue of civilians between checkpoints on the contact line

On the morning of 27 February, between the EECP near Maiorsk and the checkpoint of the armed formations near Horlivka (non-government-controlled, 39km north-east of Donetsk), the SMM saw about 400 pedestrians and 120 vehicles queuing to enter government-controlled areas. Six people (mixed genders, all in their sixties) told the SMM that they had been waiting for three hours between the checkpoints. Shortly therafter, at the checkpoint of the armed formations near Horlivka, the SMM saw about 20 pedestrians and about 40 vehicles queuing to enter non-government-controlled areas.

SMM facilitation of repairs to and operation of critical civilian infrastructure

The Mission facilitated and monitored adherence to localized ceasefires to enable repairs to a water pipeline near Zaitseve (50km north-east of Donetsk) and to power lines near Zolote-5/Mykhailivka and Vesela Hora (non-government-controlled, 16km north of Luhansk).

It continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and to monitor the security situation in the area of the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

Border areas outside government control

While at a pedestrian border crossing point near Novoborovytsi (79km south of Luhansk) for about 25 minutes, the SMM saw a pedestrian entering Ukraine and a pedestrian exiting Ukraine.

About ten minutes after arriving at a border crossing point near Dovzhanske (84km south-east of Luhansk), a member of the armed formations told the SMM to leave the area. While present, the SMM saw no cross-border traffic.*

The SMM monitored protests related to events in Crimea in Lviv and Kyiv

On 26 February, in front of the Regional State Administration building in Lviv, the SMM saw about 60 people (mixed ages and genders) gather to raise the Crimean Tatar flag in support of Crimea. Speeches were held protesting 2014 events in Crimea, and the event ended peacefully.

On 27 February, the SMM saw about 100 people (mixed ages and genders) gathered in front of the Embassy of the Russian Federation in Kyiv, holding photographs of Crimean Tatar activists currently detained or missing and banners critical of 2014 events in Crimea. About 200 National Guard and police officers were also present, and the event ended peacefully.

The Mission continued monitoring in Kherson, Odessa, Ivano-Frankivsk, Kharkiv, Dnipro, and Chernivtsi.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, UXO and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see below.) The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint about 600m west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage, citing "demining activities" in the area.
- At a border crossing point near Dovzhanske (non-government-controlled, 84km south-east of Luhansk), a member of the armed formations told the SMM to leave the area.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- An SMM mini-UAV experienced signal interference, assessed as caused by probable jamming, while flying over areas near Yasynuvata (non-government-controlled, 16km north-east of Donetsk).⁹

The SMM is deployed to ten locations throughout Ukraine – Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Donetsk, Dnipro, Chernivtsi, Luhansk and Kyiv – as per Permanent Council Decision 1117 of 21 March 2014. This map of eastern Ukraine is meant for illustrative purposes and indicates locations mentioned in the report, as well as those where the SMM has offices (monitoring teams, patrol hubs, and forward patrol bases) in Donetsk and Luhansk regions. (In red: a forward patrol base from which SMM staff has temporarily relocated based on recommendations of security experts from participating States as well as SMM security considerations. The SMM uses the premises during daylight hours and patrols in this settlement during daylight hours, as well).
