
Daily Report 64/2020

17 March 2020¹

Summary

- Compared with the previous 24 hours, the SMM recorded fewer ceasefire violations in Donetsk region and more in Luhansk region, including over 900 explosions in areas east and north-east of Zolote.
- Small-arms fire was assessed as directed at an SMM mini-unmanned aerial vehicle which was flying over areas near Krychnychne, Luhansk region.
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske; it recorded ceasefire violations, including explosions, assessed as inside the disengagement area near Petrivske.
- The Mission observed measures related to the COVID-19 outbreak at entry-exit checkpoints in both Donetsk and Luhansk regions.
- It facilitated and monitored adherence to localized ceasefires to enable demining activities near Krasnyi Yar and repairs to water pipelines in Zaitseve.
- Members of the armed formations continued to restrict the Mission's freedom of movement in Donetsk city and at checkpoints in southern Donetsk region, including near Verkhnoshyrokivske, Nova Marivka, and Staromarivka.*

Ceasefire violations²





In Donetsk region, the SMM recorded fewer ceasefire violations, including fewer explosions (about 120), compared with the <u>previous 24 hours</u> (about 175 explosions). The majority of ceasefire violations were recorded at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk), in areas south-west of Yasyunvata (non-government-controlled, 16km north-east of Donetsk) and east of Maiorsk (government-controlled, 45km north-east of Donetsk).

In Luhansk region, the SMM recorded more than a seven-fold increase in the number of ceasefire violations, including more than ten times the number of explosions (about 940), compared with the <u>previous 24 hours</u> (about 90 explosions). The majority of ceasefire violations, including explosions, were recorded in areas east of Novotoshkivske (government-controlled, 53km west of Luhansk), including 47 explosions assessed as impacts, east and north-east of Zolote (government-controlled, 60km west of Luhansk), including 20 explosions assessed as impacts, and in northerly directions of Holubivske (non-government-controlled, 51km west of Luhansk).

Small-arms fire assessed as directed at SMM mini-UAV near Krynychne

Positioned about 2km north-west of Krynychne (non-government-controlled, 45km west of Luhansk), while conducting a mini-unmanned aerial vehicle (UAV) flight, the SMM heard 20 shots of small-arms fire at a range of 1-2km south-south-west, assessed as directed at the UAV, which was flying about 1.5km south-south-west. The SMM safely landed its UAV and left the area.*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 14 March, outside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), an SMM mini-UAV <u>again</u> spotted an anti-aircraft gun (ZU-23, 23mm) near the Prince Ihor Monument, about 1km south-east of Stanytsia Luhanska bridge (15km north-east of Luhansk). On 16 March, the Mission saw six members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge and their checkpoint south of it.

On the evening of 15 March, the SMM camera in Zolote recorded 24 undetermined explosions, nine projectiles in flight, and four muzzle flashes at an assessed range of 3-6km east and east-north-east, assessed as outside the **disengagment area near Zolote** but within 5km of its periphery. On 16 March, while positioned in four locations,the SMM heard about 210 undetermined explosions and 20 assessed as impacts, as well as 40 bursts of heavy-machine-gun fire, all assessed as outside the disengagement area but within 5km of its periphery. Throughout the day, the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them) on the southern edge of the disengagement area.

On the evening of 15 March, the SMM camera 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded 18 projectiles in flight and three explosions, assessed as impacts, all at a range of 2-4km east-south-east and assessed as inside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk). It also recorded four projectiles and an explosion assessed as an impact at a range of 3-5km east-south-east, which were unable to be assessed as inside or outside of the

disengagement area, as well as three projectiles in flight at a range of 3-5km south-east which were assessed as outside of the disengagement area but within 5km of its periphery.

Recent impacts and unexploded ordnance (UXO) near Vesela Hora and mines and UXO near Luhanske and Sanzhariyka

At a checkpoint of the armed formations about 3km east of Vesela Hora (non-government-controlled, 16km north of Luhansk), the SMM saw three craters on the edge of the road and in an adjacent field, assessed as recent and caused by impacts of (120mm) mortar rounds, as well as the tailfin of a (120mm) mortar round embedded in one of the craters, also assessed as recent.

On 15 March, an SMM mid-range UAV spotted for the first time 40 anti-tank mines laid in two rows in a field about 1km south of Luhanske (government-controlled, 59km north-east of Donetsk), which could not be assessed as recent, assessed as belonging to the Ukrainian Armed Forces.

The same UAV spotted an anti-tank missile pack, assessed as UXO, lying near positions of the armed formations about 2km west of Sanzharivka (non-government-controlled, 67km north-east of Donetsk).

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission saw 19 weapons beyond withdrawal lines but outside of designated storage sites in government-controlled areas (for further details, see the table below).

Indications of military and military-type presence in the security zone⁶

The Mission observed armoured combat vehicles and an anti-aircraft gun in the security zone on both sides of the contact line (for further details, see the table below).

On 1 March, aerial imagery available to the SMM revealed the presence of two new trenches about 3km and 6km south of Troitske (government-controlled, 69km west of Luhansk), running for about 150m and 100m, respectively (not seen in imagery from 21 November 2019).

On 13 March, an SMM mini-UAV spotted two members of the armed formations with shovels in previously-reported trenches in the area of a pumping station south-west of Naberezhne (non-government-controlled, 77km south of Donetsk), as well as an extension to a trench, running for about 190m north-west (not seen in imagery from 2 November 2019). Near the trenches, the UAV spotted about 20 craters, six of which were assessed as recent and caused by probable (82mm) mortar rounds. About 1km west of the trenches, the same UAV spotted nine craters adjacent to previously-reported trenches, assessed as caused by deliberate detonation to facilitate an extension of the trenches. Nearby, it also spotted at least eight recent impact craters, assessed as caused by probable (82mm) mortar rounds.

About 4km north-east of Pavlopil (government-controlled, 84km south of Donetsk) and near forward positions of the Ukrainian Armed Forces, the same UAV spotted at least four recent impact craters, assessed as caused by probable (82mm) mortar rounds.

Situation of civilians and preventive measures against COVID-19 outbreak at entryexit checkpoints

On 16 March, about 20m south of the entry-exit checkpoint (EECP) near Stanytsia Luhanska, the SMM saw a new wooden barrier across the roadway and police officers checking documents. It also saw that neither the shuttle bus nor golf carts between the Stanytsia Luhanska bridge and the EECP were operating. A Ukrainian Armed Forces officer of the Joint Centre for Control and Co-ordination (JCCC) told the SMM that they would not operate until 3 April 2020, until which time traffic at the EECP would be restricted to entry only for those with permanent registration in government-controlled areas, and exit only for those who reside in non-government-controlled areas.

At the EECPs near Stanytsia Luhanska and Hnutove (government-controlled, 90km south of Donetsk), ten people (majority women, in their thirties through sixties) told the SMM that the new restrictions had prevented them from crossing the contact line to visit family members, attend a funeral, collect their pensions, or return to their residence, which may not necessarily be the place where they are permanently registered.

SMM facilitation of demining activities and repairs to critical civilian infrastructure

The SMM facilitated and monitored adherence to localized ceasefires to facilitate repair works to water pipelines in Zaitseve (50km north-east of Donetsk) and demining activities on a road leading east from Krasnyi Yar (non-government-controlled, 12km north-east of Luhansk). While along the aforementioned road, the SMM saw ten deminers arrive with metal detectors and equipment. The SMM continued to facilitate the operation of the DFS.

Border areas outside government control

While at a border crossing point near Novoazovsk (102km south-east of Donetsk) for 30 minutes, the SMM saw eight cars (one with Ukrainian, three with Russian Federation, and one with Polish licence plates, as well as three with "DPR" plates) entering Ukraine, as well as six cars (one with Ukrainian and three with Russian Federation licence plates, as well as two with "DPR" plates) and four covered cargo trucks (one with Ukrainian licence plates and three with "DPR" plates) exiting Ukraine.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, UXO and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate

mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see <u>SMM Daily Report of 16 March 2020</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near <u>Pryshyb</u>; these restrictions continued to limit the Mission's observations.

Denials of access:

- In non-government-controlled Donetsk city, a member of the armed formations again denied the SMM access to its regular observation post at the central railway station, citing "orders from superiors."
- At a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), four members of the armed formations (three visibly armed) <u>again</u> denied the SMM passage, citing "an ongoing operation."
- At a checkpoint about 2km east of Nova Marivka (non-government-controlled, 64km south of Donetsk), a member of the armed formations denied the SMM passage to the settlement, citing "an ongoing operation and engineering activities in the area."
- At a checkpoint east of Staromarivka (62km south of Donetsk), an armed member of the armed formations denied the SMM passage to the settlement, citing "sniper activity in the area." While present, the SMM saw a civilian car pass through the checkpoint, leaving the settlement.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- While conducting a mini-UAV flight near Krynychne (non-government-controlled, 45km west of Luhansk), the SMM heard small-arms fire assessed as directed at the UAV, which it landed safely (see above).
- An SMM mini-UAV experienced signal interference, assessed as caused by probable jamming, while flying over areas near Lebedynske (government-controlled, 99km south of Donetsk).⁷



The SMM is deployed to ten locations throughout Ukraine – Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Donetsk, Dnipro, Chernivtsi, Luhansk and Kyiv – as per Permanent Council Decision 1117 of 21 March 2014. This map of eastern Ukraine is meant for illustrative purposes and indicates locations mentioned in the report, as well as those where the SMM has offices (monitoring teams, patrol hubs, and forward patrol bases) in Donetsk and Luhansk regions. (In red: a forward patrol base from which SMM staff has temporarily relocated based on recommendations of security experts from participating States as well as SMM security considerations. The SMM uses the premises during daylight hours and patrols in this settlement during daylight hours, as well).
