


Daily Report 84/2020

9 April 2020¹

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in Donetsk region and fewer in Luhansk region.
- Members of the armed formations continued to deny the SMM passage towards nongovernment-controlled areas at checkpoints in Donetsk region and towards government-controlled areas at a checkpoint in Luhansk region.*
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske.
- The SMM monitored and facilitated adherence to localized ceasefires to enable repairs to and maintenance and construction of civilian infrastructure on both sides of the contact line, as well as demining activities in Krasnyi Yar, Luhansk region.
- The Mission again saw that two entry-exit checkpoints and their corresponding checkpoints in both Donetsk and Luhansk regions remained closed amid the COVID-19 outbreak.
- The SMM's freedom of movement continued to be restricted in both Donetsk and Luhansk regions.*

Ceasefire violations²





In Donetsk region, the SMM recorded more ceasefire violations, including more explosions (about 90) compared with the <u>previous reporting period</u> (about 65 explosions). The majority of ceasefire violations were recorded within a 3km radius of the Donetsk Filtration Station (DFS) (15km north of Donetsk), in areas south-east of Chernenko (government-controlled, 86km south of Donetsk) and at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk), where the majority of explosions occurred (about 23).

In Luhansk region, the SMM recorded fewer ceasefire violations, including fewer explosions (about 30), compared with the <u>previous reporting period</u> (about 80 explosions). Almost all ceasefire violations, including almost all explosions, were recorded in areas north-east, south-west and west of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below).

Members of the armed formations continued to deny SMM passage at checkpoints along the contact line in Donetsk and Luhansk regions

Members of the armed formations continued to deny the Mission passage at checkpoints in both Donetsk and Luhansk regions along official crossing routes. These restrictions constitute an impediment to the implementation of the Mission's mandate.⁵

At a checkpoint on road H-15 near Oleksandrivka (non-government-controlled, 20km southwest of Donetsk), three armed members of the armed formations denied the SMM passage towards non-government-controlled areas, citing "orders from their commanders related to COVID-19".*

Members of the armed formations <u>again</u> denied the SMM passage towards government-controlled areas at their checkpoint south of the Stanytsia Luhanska bridge (15km north-east of Luhansk).*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁶

On 8 April, positioned near the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw a member of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge and their checkpoint south of it. On 8 April, outside the disengagement area, the SMM saw that a barbed wire was placed around the mast of the SMM camera in Stanytsia Luhanska (about 350m north-north-east of the disengagement area's northern edge), which impedes the SMM's access to it.

On the evening of 7 April, inside the **disengagement area near Zolote**, an SMM long-range unmanned aerial vehicle (UAV) spotted two people within a former position of the Ukrainian Armed Forces south of the railway track and east of road T-1316 (for previous observations, see SMM Daily Report 7 April 2020).

On the evening of 7 April, while in Popasna (government-controlled, 69km west of Luhansk), the SMM heard two undetermined explosions at an assessed range of 6-10km

east, which it was unable to assess as inside or outside the disengagement area, as well as two undetermined explosions assessed as outside the disengagement area but within 5km of its periphery.

On 8 April, while positioned near a checkpoint of the armed formations near the southern edge of the disengagement area near Zolote, the SMM heard five undetermined explosions at an assessed range of 5-7km north-east, all assessed as outside the disengagement area but within 5km of its periphery. On the same day, the SMM saw six members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area.

On 8 April, while positioned about 2km north of the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), the SMM heard six undetermined explosions, all at an assessed range of 4-5km south. While positioned about 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk), it heard five undetermined explosions at an assessed range of 4-6km south-east. All of these were assessed as outside the disengagement area but within 5km of its periphery.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission saw two disassembled mortars as well as four men in military clothing nearby in a government-controlled area of Donetsk region, and a tank in a government-controlled area of Luhansk region. All the weapons were in violation of withdrawal lines (for further details, see table below).

Indications of military and military-type presence inside the security zone⁷

The SMM observed military and military-type presence in government-controlled areas of Donetsk region (for further details, see the table below).

On 8 April, while positioned in Raivka (non-government-controlled, 16km north-west of Luhansk) to conduct a mini-UAV flight, the SMM observed a non-SMM UAV flying at an altitude of about 70m over its position for around three minutes. The Mission left the area.*

Presence of anti-tank mines near Marinka

On 8 April, the SMM <u>again</u> spotted the southern part of a larger minefield (partially marked-off and fenced), starting about 9m north of road H-15 and about 1km south-west of the entry-exit checkpoint (EECP) in Marinka (government- controlled, 23km south-west of Donetsk). The SMM saw that the vegetation over the minefield had recently burned and some of the anti-tank mines were partly burned.

SMM facilitation of construction of and repairs to critical civilian infrastructure and demining activities

The SMM facilitated and monitored adherence to localized ceasefires to enable vegetation clearance, inspection and maintenance of railway tracks near Vilkhove (government-controlled, 22km north-east of Luhansk); repairs to water infrastructure near Pankivka (non-government-controlled, 16km north of Luhansk) and water wells in Raivka; the construction of a power line and repairs to a water pipeline near the entry-exit checkpoint EECP close to Maiorsk (government-controlled, 45km north-east of Donetsk); as well as to enable demining activities in Krasnyi Yar (non-government-controlled, 12km north-east of Luhansk).

The Mission continued to facilitate the operation of the DFS. During the day on 8 April, while positioned at two locations near the DFS, the SMM heard seven undetermined explosions and about 170 bursts and shots of heavy-machine-gun and small-arms fire, all assessed as within a 3km radius of the DFS.

Measures at entry-exit checkpoints and corresponding checkpoints to counter COVID-19 outbreak

In Luhansk region, the SMM saw that the EECP in Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge remained closed.

At a parking lot near the EECP in Stanytsia Luhanska, a woman (in her thirties) accompanied by two children (boy and a girl, aged 10 and 12) told the SMM that they had no place to stay and spent their nights on the street without money and food while waiting to cross towards non-government-controlled areas.

In Donetsk region, the Mission saw that the EECPs near Marinka and near Novotroitske (government-controlled, 36km south-west of Donetsk), as well as the checkpoint of the armed formations on road H-15 near Oleksandrivka (non-government-controlled, 20km south-west of Donetsk), remained closed.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines and unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Coordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example see SMM Daily Report 28 March 2020). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint on road H-15 near Oleksandrivka (non-government-controlled, 20km south-west of Donetsk), three armed members of the armed formations denied the SMM passage towards non-government-controlled areas, citing "orders from their commanders related to COVID-19".
- At a checkpoint in Staromykhailivka (non-government-controlled, 15km west of Donetsk), an unarmed member of the armed formations denied the SMM passage, citing "safety" and "his commander's decision". While present, the Mission saw pedestrians and civilian vehicles pass through the checkpoint.
- At the checkpoint of the armed formations south of Stanytsia Luhanska bridge (15km north-east of Luhansk), two members of the armed formations denied the SMM passage towards government-controlled areas, citing "closure of the checkpoint due to COVID-19".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- An SMM mid-range UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Styla (non-government-controlled, 34km south of Donetsk).⁸
- An SMM mini-UAV experienced GPS signal interference on two occasions, assessed as caused by probable jamming, while flying over areas near Novohryhorivka (non-government-controlled, 61km north-east of Donetsk).
- An SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over the disengagement area near Zolote (government-controlled, 60km west of Luhansk).
- The Mission had to abort a mini-UAV flight in Raivka (non-government-controlled, 16km north-west of Luhansk) due to the presence of a non-SMM UAV flying over its position (see above).



When information is not known (indicated with an "N/K"), the SMM was unable to ascertain such information due to distance, weather conditions technical limitations and/or other considerations. Ceasefire violations recorded by more than one patrol/camera and assessed to be the same are entered only once.
