

# Daily Report 94/2020


21 April 2020<sup>1</sup>

#### **Summary**

- Compared with the previous 24 hours, the Mission recorded more ceasefire violations in both Donetsk and Luhansk regions.
- The Mission's passage continued to be denied at checkpoints of the armed formations near Horlivka, Donetsk region and south of the Stanytsia Luhanska bridge, Luhansk region.\*
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. It spotted mines close to the disengagement area near Petrivske and persons inside the disengagement area near Zolote.
- The SMM saw weapons in violation of withdrawal lines in government- and non-government-controlled areas of Luhansk region.
- The Mission monitored and facilitated adherence to a localized ceasefire to enable vegetation clearance, inspection and maintenance of railway tracks near Vilkhove, Luhansk region.
- The SMM continued monitoring the situation of civilians amid the COVID-19 outbreak, including at entry-exit checkpoints and their corresponding checkpoints in both Donetsk and Luhansk regions.
- The Mission's freedom of movement continued to be restricted in both Donetsk and Luhansk regions.\*

### Ceasefire violations<sup>2</sup>



### Map of recorded ceasefire violations



In Donetsk region, the SMM recorded more ceasefire violations, including more explosions (about 170), compared with the <u>previous 24 hours</u> (seven explosions). The majority of ceasefire violations, including the majority of explosions, were recorded at southerly directions of the Donetsk Filtration Station (DFS) (15km north of Donetsk), at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk), at southerly and easterly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk), and at northerly directions of Horlivka (non-government-controlled, 39km north-east of Donetsk).

In Luhansk region, the SMM recorded more ceasefire violations, including more explosions (six), compared with the <u>previous 24 hours</u>, when it recorded no explosions. The majority of ceasefire violations were recorded at easterly directions of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below).

# Members of the armed formations continued to deny SMM passage at checkpoints along the contact line in Donetsk and Luhansk regions

Members of the armed formations continued to deny the Mission passage at checkpoints in both Donetsk and Luhansk regions along official crossing routes. These restrictions constitute an impediment to the implementation of the Mission's mandate.<sup>5</sup>

On 20 April, at a checkpoint of the armed formations south of Stanytsia Luhanska bridge (15km north-east of Luhansk), two members of the armed formations <u>again</u> denied the SMM passage towards government-controlled areas, citing the closure of the checkpoint due to COVID-19.\*

On 20 April, at a checkpoint near Horlivka, the SMM was <u>again</u> prevented from crossing towards non-government-controlled areas due to the presence of spikes laid across the entire road and of a mine hazard sign on either side of the road.\*

### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>6</sup>

On the evening of 19 April, while positioned in Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk), the SMM heard an undetermined explosion at an assessed range of 4-6km south-south-east and assessed as outside the **disengagement area near Stanytsia Luhanska** but within 5km of its periphery.

On 20 April, the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge and their checkpoint south of it.

On the evening of 18 April, inside the **disengagement area near Zolote**, an SMM long-range unmanned aerial vehicle (UAV) spotted two persons near a former position of the Ukrainian Armed Forces south-west of the railway bridge. On the same evening, the same UAV spotted another person near a former position of the Ukrainian Armed Forces about 60m south of the disengagement area's northern edge and 500m west of its eastern edge. the evening of 19 April, an SMM long-range UAV spotted three persons near the same position.

On the night between 19 and 20 April, the SMM camera in Zolote recorded 13 projectiles in flight at an assessed range of 2-5km east. On the morning of 20 April, while positioned on the southern edge of the disengagement area, the SMM heard ten bursts of heavy-machine-gun fire at an assessed range of 3-4km north-east, assessed as outside the disengagement area but within 5km of its periphery.

Throughout the day, the SMM saw five members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area.

On 18 April, outside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), an SMM mini-UAV again spotted 13 of 16 <u>previously reported</u> anti-tank mines south of the road between Petrivske and Viktorivka (non-government-controlled, 42km south-west of Donetsk). On the southern edge of the village of Petrivske, the UAV spotted for the first time two anti-tank mines and <u>again</u> spotted about 55 anti-tank mines, all assessed as belonging to the armed formations. On the same day, about 800m north-east of the disengagement area, in a field about 60m east of road C-051532, the same UAV spotted for the first time an anti-tank mine (probable TM-62).

The same UAV also spotted two persons wearing camouflage clothing, assessed as members of the armed formations, in a previously observed trench near the disengagement area's northern edge. The UAV additionally spotted a recently built trench starting near the disengagement area's northern edge and stretching for about 20m in a northerly direction.

On the morning of 20 April, while positioned about 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the Mission heard a burst of heavy-machine-gun fire at an assessed range of 3-5km north-west and assessed as outside the disengagement area but within 5km of its periphery.

#### Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum. In Luhansk region, the Mission saw seven weapons in violation of withdrawal lines, three (two of them probable) in government-controlled areas and four in non-government-controlled areas (for further details, see the tables below).

### Indications of military and military-type presence inside the security zone<sup>7</sup>

The SMM observed armored combat vehicles near residential houses in a government-controlled area of Donetsk region and in non-government-controlled areas of Luhansk region, all in the security zone (for further details, see the table below).

### SMM facilitation of operation and maintenance of critical civilian infrastructure

The SMM facilitated and monitored adherence to a localized ceasefire to enable vegetation clearance, inspection and maintenance of railway tracks near Vilkhove (government-controlled, 22km north-east of Luhansk).

The Mission also continued to facilitate the operation of the DFS. While positioned near it, the SMM heard six shots of small-arms fire assessed as within 5km of its periphery.

# Measures at entry-exit checkpoints and corresponding checkpoints to counter <u>COVID-19 outbreak</u>

In Donetsk region, the Mission noted that the checkpoint of the armed formations near Horlivka remained closed.\*

In Luhansk region, the SMM saw that the entry-exit checkpoint (EECP) in Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge remained closed.\* At the same EECP, the Mission was approached by a man (in his fifties), who told that he was a resident of non-government-controlled areas and that he had travelled to government-controlled areas for medical treatment but had been unable to return home due to the EECP's closure.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

# \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines and unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Coordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example see SMM Daily Report 28 March 2020). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

#### Denial of access:

- On 20 April, at a checkpoint of the armed formations south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), two members of the armed formations again denied the SMM passage towards government-controlled areas, citing the closure of the checkpoint due to COVID-19. They added that the Mission would also not be allowed passage towards non-government-controlled areas for the same reason.
- On 20 April, at a checkpoint north of Horlivka (non-government-controlled, 39km north-east of Donetsk), the SMM was <u>again</u> unable to proceed towards non-government-controlled areas due to spikes laid across the entire road, and the presence of a mine hazard sign on either side of the road (see above).

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

### Other impediments:

- On 18 April, an SMM long-range UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas between Kurdiumivka (government-controlled, 54km north of Donetsk) and Slovianoserbsk (non-government-controlled, 28km north-west of Luhansk), and between Rovenky (non-government-controlled, 54km south of Luhansk) and Holmivskyi (non-government-controlled, 49km north-east of Donetsk).<sup>8</sup>


