Summary

- Compared with the previous reporting period, the Mission recorded fewer ceasefire violations in Donetsk region and more in Luhansk region.
- The SMM followed up on reports of a woman hit by a bullet at a bus stop in Olenivka, Donetsk region.
- Members of the armed formations continued to deny the Mission passage at checkpoints along official crossing routes in Donetsk and Luhansk regions.*
- The SMM continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. Inside the disengagement area near Petrivske, it recorded ceasefire violations and spotted ongoing excavation and construction works to former positions of the armed formations.
- The Mission saw weapons in violation of withdrawal lines in non-government-controlled areas of Luhansk region.
- The Mission continued following up on measures taken amid the COVID-19 outbreak, including at entry-exit checkpoints and their corresponding checkpoints in Donetsk and Luhansk regions.
- The SMM's freedom of movement continued to be restricted, including at a checkpoint of the armed formations near Staromykhailivka, Donetsk region.*



In Donetsk region, the SMM recorded fewer ceasefire violations, including fewer explosions (about 200), compared with the <u>previous reporting period</u> (about 300 explosions). The majority of ceasefire violations, including the majority of explosions, were recorded near the Donetsk Filtration Station (DFS) (15km north of Donetsk) (see below), at westerly directions of Sakhanka (non-government-controlled, 97km south of Donetsk), in areas north-east and north-west of Horlivka (non-government-controlled, 39km north-east of Donetsk) and in areas north of Shyrokyne (government-controlled, 100km south of Donetsk).

In Luhansk region, the SMM recorded more ceasefire violations, including more explosions (about 135), compared with the <u>previous reporting period</u> (about 120 explosions). The majority of ceasefire violations, including the majority of explosions, were recorded at northerly directions of Kadiivka (formerly Stakhanov, non-government-controlled, 50km west of Luhansk), at north-easterly and north-westerly directions of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below) and in areas south of Kriakivka (government-controlled, 38km north-west of Luhansk).

Woman hit by bullet at bus stop in Olenivka

On 20 May, medical personnel at a hospital in non-government-controlled Donetsk city told the SMM that on the evening of 19 May a woman had been admitted with a bullet injury to her left shoulder. Medical staff added that the woman had undergone surgery on 20 May. The same day, the woman (in her fifties) told the SMM that on the evening of 19 May, while sitting at a bus stop in Olenivka (non-government-controlled, 23km south-west of Donetsk) with her husband, she had felt a blow to her left shoulder; she also said that about 20 minutes beforehand, she had heard explosions in the area. The bus stop at which the woman had sustained the bullet injury is located about 300m east of a checkpoint of the armed formations near Olenivka along an official crossing route, currently closed to civilians (see below), and within a 500m radius of a position of the armed formations.

Members of the armed formations continued to deny the SMM passage at checkpoints along the contact line in Donetsk and Luhansk regions

Members of the armed formations continued to deny the SMM passage at checkpoints in both Donetsk and Luhansk regions along official crossing routes. These restrictions constitute an impediment to the implementation of the Mission's mandate.⁵

In Donetsk region, at a checkpoint north of Horlivka, two armed members of the armed formations <u>again</u> denied the SMM passage towards non-government-controlled areas, referring to quarantine restrictions due to the COVID-19 outbreak. The SMM also continued to observe the presence of a metal barrier and spikes laid across the road, and of a mine hazard sign.*

In Luhansk region, at a checkpoint south of the Stanytsia Luhanska bridge (15km northeast of Luhansk), two members of the armed formations <u>again</u> denied the SMM passage

towards government-controlled areas, referring to quarantine restrictions due to the COVID-19 outbreak.*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁶

On 20 May, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the Mission saw a van and four persons near booths near the checkpoint of the armed formations south of the Stanytsia Luhanska bridge. A member of the armed formations (wearing an armband with "JCCC" written on it) told the SMM that the four persons were laying power cables for the booths.

During the night between 19 and 20 May, the SMM camera near the **disengagement area near Zolote** recorded two undetermined explosions and four explosions assessed as impacts, as well as ten projectiles in flight, all at an assessed range of 4-6km east-northeast and east (assessed as outside the disengagement area but within 5km of its periphery).

On 20 May, the Mission saw six members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area.

On the same day, outside the disengagement area, at the checkpoint of the Ukrainian Armed Forces 300m north of its northern edge, the SMM saw about 30 police officers (some of whom were wearing black and grey-green camouflage clothing), nine police vehicles and an ambulance.

On 18 May, inside **the disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), an SMM mini-unmanned aerial vehicle (UAV) spotted ten of 150 previously reported anti-tank mines starting from the area's northern edge and running south for about 350m. Outside the disengagement area, in a field north of the road between Bohdanivka (government-controlled, 41km south-west of Donetsk) and Petrivske, an SMM mini-UAV again spotted four anti-tank mines. All these mines were assessed as belonging to the Ukrainian Armed Forces.

Inside the disengagement area, about 20m west of its eastern edge and 350m north of its southern edge, the UAV spotted a 10m-long extension to a wooden structure covering part of an existing trench as well as new panels on the roof of a covered vehicle position (both not visible in imagery from 28 April 2020) and, for the first time, a 3m-long trench extension in a westerly direction, all assessed as belonging to the armed formations (for previous observations in the area, see SMM Daily Report 1 May 2020). Outside the disengagement area, about 200m north-west of the area's north-eastern corner, the same UAV spotted for the first time a bunker made of logs, walls and a roof structure, as well as a pile of logs lying nearby, near a position of the armed formations cutting through the aforementioned road between Bohdanivka and Petrivske. Also outside the disengagement area, about 200m east of its eastern edge and 250m south of Petrivske, the UAV again spotted 40 of 60 previously reported anti-tank mines (probable TM-62), assessed as belonging to the armed formations.

On 20 May, while positioned at two locations near the disengagement area, the SMM heard seven undetermined explosions and 46 bursts and shots of small-arms and heavy-

machine-gun fire, all assessed as inside the disengagement area, as well as an undetermined explosion (unable to be assessed as inside or outside the disengagement area).

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission saw six weapons in violation of withdrawal lines in non-government-controlled areas of Luhansk region. It also observed a tank beyond withdrawal lines but outside of designated storage sites in a government-controlled area of Donetsk region (for further details, see the tables below).

Indications of military and military-type presence inside the security zone⁷

The SMM observed armoured combat vehicles and anti-aircraft guns in the security zone in government-controlled areas of both Donetsk and Luhansk regions, and an armoured combat vehicle in a non-government-controlled area of Donetsk region (for further details, see the table below).

SMM facilitation of repairs to and operation of critical civilian infrastructure⁸

The SMM facilitated and monitored adherence to a localised ceasefire to enable repairs to a power substation in Uzhivka (formerly Leninske, non-government-controlled, 96km south of Donetsk), during which it heard about 190 ceasefire violations, including an undetermined explosion.

The SMM continued to facilitate the operation of the DFS. While positioned at four locations near the DFS, the Mission recorded about 55 explosions, including two assessed as outgoing, as well as bursts and shots of small-arms and heavy-machine-gun fire, all assessed as within a 5km radius of the DFS.

Measures taken at entry-exit checkpoints and corresponding checkpoints amid COVID-19 outbreak

In Donetsk region, the SMM noted that the entry-exit checkpoint (EECP) near Hnutove (government-controlled, 90km south of Donetsk), as well as the EECP near Maiorsk (government-controlled, 45km north-east of Donetsk) and its corresponding checkpoint near Horlivka, remained closed.*

In Luhansk region, the SMM saw that the EECP in Stanytsia Luhanska and its corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge remained closed.*

The Mission again saw checkpoints assessed as set up amid the COVID-19 outbreak in non-government-controlled areas of Luhansk region, namely on the southern outskirts of Kadiivka, on the eastern outskirts of Pervomaisk (58km west of Luhansk) and on the western outskirts of Brianka (46km south-west of Luhansk). The SMM observed no members of the armed formations at these checkpoints.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines and unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, SMM Daily Report 19 May 2020). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), two members of the armed formations <u>again</u> denied the SMM passage towards government-controlled areas, referring to quarantine restrictions due to the COVID-19 outbreak.
- At a checkpoint north of Horlivka (non-government-controlled, 39km north-east of Donetsk), two armed members of the armed formations <u>again</u> denied the SMM passage towards non-government-controlled areas, referring to quarantine restrictions due to the COVID-19 outbreak. The SMM also continued to observe the presence of a metal barrier and spikes laid across the road and of a mine hazard sign.
- At a checkpoint near Staromykhailivka (non-government-controlled, 15km west of Donetsk), two armed members of the armed formations denied the SMM passage.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Delay:

- At a checkpoint near Shevchenko (non-government-controlled, 82km south of Donetsk), two members of the armed formations allowed the SMM passage into the settlement only after about 30 minutes of waiting.

Conditional access:

- Near Ozerianivka (non-government-controlled, 35km north-east of Donetsk), two members of the armed formations allowed the SMM to conduct a mini-UAV flight only while in their presence and only over a certain area to follow up on reports of damage in the settlement. They then remained near the patrol while it conducted the flight.

Other impediments:

- On 20 May, staff at a morgue in Kadiivka (formerly Stakhanov, non-government-controlled, 50km west of Luhansk), at a hospital in Brianka (non-government-controlled, 46km south-west of Luhansk) and a member of the armed formations in Alchevsk (non-government-controlled, 40km west of Luhansk) declined to share information with the SMM.


