
# Daily Report 148/2020

23 June 2020<sup>1</sup>

### **Summary**

- Compared with the previous 24 hours, the SMM recorded fewer ceasefire violations in Donetsk region and a sharp increase in Luhansk region.
- The SMM camera near Shyrokyne was damaged.
- Members of the armed formations continued to deny the Mission passage at checkpoints along official crossing routes in Donetsk and Luhansk regions.\*
- The Mission continued monitoring all three disengagement areas: It observed people inside the disengagement areas near Zolote and Petrivske during evening hours.
- The Mission facilitated and monitored adherence to localised ceasefires to enable the assessment, maintenance and operation of critical civilian infrastructure, as well as demining activities.
- The SMM saw civilians travelling towards government- and non-governmentcontrolled areas through the entry-exit checkpoints in Stanytsia Luhanska and near Novotroitske, and saw civilians traveling towards government-controlled areas at a checkpoint of the armed formations near Olenivka.
- The SMM's freedom of movement continued to be restricted.\*

### Ceasefire violations<sup>2</sup>





In Donetsk region, the SMM recorded fewer ceasefire violations, including, however, more explosions (60), compared with the <u>previous 24 hours</u> (about 30). The majority of ceasefire violations were recorded in areas west of Yasynuvata (non-government-controlled, 16km north-east of Donetsk) and north and north-north-east of Shyrokyne (government-controlled, 100km south of Donetsk) (see below).

In Luhansk region, the SMM recorded a sharp increase in the number of ceasefire violations, including in explosions (about 2,170), compared with the <u>previous 24 hours</u> (one explosion). Almost all of the ceasefire violations, including explosions, were recorded on 22 June between 04:00 and 04:25 at south-easterly directions of Popasna (government-controlled, 69km west of Luhansk).

### SMM camera near Shyrokyne damaged

On the morning of 22 June, the SMM lost the video feed from its camera located 1km southwest of Shyrokyne (government-controlled, 100km south of Donetsk) and about 2km west of the contact line. Subsequently, a Ukrainian Armed Forces officer of the Joint Centre for Control and Co-ordination (JCCC) told the Mission that the camera had been damaged. During multiple flights conducted later in the day, an SMM mini-unmanned aerial vehicle (UAV) spotted that the camera was lying on the ground and its mast and cables were broken (see SMM Spot Report 33/2020). The SMM is following up with ground patrols and additional information will be published as it becomes available.

# Members of the armed formations continued to deny the SMM passage at checkpoints along the contact line in Donetsk and Luhansk regions

Members of the armed formations continued to deny the SMM passage at checkpoints in both Donetsk and Luhansk regions along official crossing routes. These restrictions constitute an impediment to the implementation of the Mission's mandate.<sup>5</sup>

In Donetsk region, at a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), members of the armed formations <u>again</u> denied the SMM passage towards non-government-controlled areas, referring to quarantine restrictions due to COVID-19.\*

In Luhansk region, at a checkpoint south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), a member of the armed formations <u>again</u> denied the SMM passage towards government-controlled areas, referring to the closure of the checkpoint due to COVID-19.\*

### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>6</sup>

On 20 June, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), an SMM mini-UAV spotted three persons in camouflage clothing replacing flags associated with the armed formations with new flags of the same pattern on the metal section of the Stanytsia Luhanska bridge, just south of the new span.

On 22 June, inside the disengagement area, the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them) near their checkpoint south of the Stanytsia Luhanska bridge.

On the evening of 20 June, inside the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk), an SMM long-range UAV spotted two persons near the area's north-eastern corner, as well as one person south of the railway tracks and about 550m east of road T-1316, all near former positions of the Ukrainian Armed Forces.

On the evening of 21 June, an SMM long-range UAV spotted two persons near a former position of the Ukrainian Armed Forces close to the area's north-eastern corner.

On the evening and night of 21-22 June, the SMM camera in Zolote recorded 11 undetermined explosions, an illumination flare and eight projectiles in flight, all at an assessed range of 4-7km east. While in Popasna on the same evening, the SMM heard 16 undetermined explosions and six bursts of heavy-machine-gun fire, all at an assessed range of 6-8km east-north-east. All of these ceasefire violations were assessed as outside the disengagement area but within 5km of its periphery.

On 22 June, the Mission saw three members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area. While positioned at three locations near the disengagement area, the SMM heard seven undetermined explosions, as well as shots and bursts of small-arms and heavy-machine-gun fire, all assessed as outside the disengagement area near Zolote but within 5km of its periphery.

On the night of 20-21 June, inside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), an SMM long-range UAV spotted a person near a former position of the Ukrainian Armed Forces about 700m south of the area's northern edge and about 2km east of its western edge.

On the night of 21-22 June, an SMM long-range UAV spotted a person near a former position of the armed formations close to the disengagement area's south-eastern corner.

On 22 June, while positioned about 2km north of Petrivske, the SMM heard an undetermined explosion at an assessed range of 7-9km south, assessed as outside the disengagement area but within 5km of its periphery.

### Presence of mines in Kruta Balka

On 21 June, an SMM mini-UAV <u>again</u> spotted seven anti-tank mines (probable TM-62) laid across a road about 200m from civilian houses on the northern outskirts of Kruta Balka (non-government-controlled, 16km north of Donetsk), assessed as belonging to the armed formations.

### Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum. It observed a surface-to-air

missile system in violation of withdrawal lines in a non-government-controlled area of Donetsk region.

The Mission also observed 25 tanks beyond withdrawal lines but outside designated storage sites in government- and non-government-controlled areas of Donetsk region, all but one of which were at a railway station in a government-controlled area.

### Indications of military and military-type presence inside the security zone 7

The SMM observed armoured combat vehicles in government-controlled areas of Donetsk and Luhansk regions (for further details, see the table below).

### SMM facilitation of maintenance to and operation of critical civilian infrastructure

The SMM facilitated and monitored adherence to localised ceasefires to enable vegetation clearance, inspection and maintenance of railway tracks near Vilkhove (government-controlled, 22km north-east of Luhansk); an assessment of power lines near Berezivske (non-government-controlled, 53km north-west of Luhansk); and demining activities near Stepove (government-controlled, 30km north-east of Luhansk), Orikhove (government-controlled, 57km north-west of Luhansk) and Hirske (government-controlled, 63km west of Luhansk).

The Mission continued to facilitate the operation of the Donetsk Filtration Station (DFS) (15km north of Donetsk). While positioned at three locations near the DFS, the SMM heard 13 undetermined explosions, 17 explosions assessed as outgoing rounds of an undetermined weapon, three explosions assessed as outgoing mortar rounds and an explosion assessed as an outgoing artillery round. The SMM also heard shots and bursts of small-arms and heavy-machine-gun fire. All these ceasefire violations were assessed as within a 5km radius of the station.

# Measures taken at entry-exit checkpoints and corresponding checkpoints amid COVID-19 outbreak

In Donetsk region, the SMM saw that checkpoints of the armed formations near Horlivka (non-government-controlled, 39km north-east of Donetsk), Kreminets (non-government-controlled, 16km south-west of Donetsk) and Verkhnoshyrokivske remained closed.\*

The SMM saw that the checkpoint of the armed formations near Olenivka (non-government-controlled, 23km south-west of Donetsk) was open. While present at the checkpoint from 10:35 to 14:40, the SMM saw that a total of about 180 people (mixed ages and genders) were gathering to exit non-government-controlled areas and that about ten people (mixed ages and genders), a minibus and two vehicles crossed the checkpoint towards government-controlled areas.

The SMM also saw that the corresponding checkpoint of the Ukrainian Armed Forces near Berezove (government-controlled, 31km south-west of Donetsk), north of the EECP near Novotroitske (government-controlled, 36km south-west of Donetsk), was open. While present at the checkpoint from 09:00 to 14:35, the SMM saw about 13 vehicles and 20 people (mixed ages and genders) crossing towards government-controlled areas and four

pedestrians (mixed ages and genders) and a car crossing towards non-government-controlled areas. After about 20 minutes, the car returned to government-controlled areas.

In Luhansk region, while at the EECP in Stanytsia Luhanska from 09:00 to 10:30 and from 13:00 to 14:41, the Mission saw that it was open and that a total of about 100 people (mixed ages and genders) were queuing to travel towards non-government-controlled areas and about 40 people (mixed ages and genders) were queuing to enter government-controlled areas.

On the same day, while near the checkpoint of the armed formations south of the Stanytsia Luhanska bridge from 10:05 to 11:03 and from 14:49 to 15:03, the SMM saw that it was open and that a total of about 30 people were queuing to enter non-government-controlled areas and a total of about ten people crossed towards government-controlled areas. The Mission also saw that an ambulance and seven personnel from an international humanitarian organization were present near the checkpoint and that about 20 civilian workers were clearing vegetation from the sides of the road south of the checkpoint of the armed formations.

Between 07:00 and 18:00, the SMM cameras at the parking lot south of the Stanytsia Luhanska bridge and north of the new span of the bridge recorded a total of about 550 people (mixed ages and genders) walking towards government-controlled areas and about 500 people (mixed ages and genders) walking towards non-government-controlled areas.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

# \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines and unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report of 22 June 2020). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

### Denial of access:

- At a checkpoint south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), a member of the armed formations <u>again</u> denied the SMM passage towards government-controlled areas, referring to the closure of the checkpoint due to COVID-19.
- At a checkpoint of the armed formations west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), two members of the armed formations (one visibly armed) <u>again</u> denied the SMM passage towards non-government-controlled areas, referring to quarantine restrictions due to COVID-19.

#### Delay:

- At a checkpoint near Olenivka (non-government-controlled, 23km south-west of Donetsk), two armed members of the armed formations allowed the SMM passage through the checkpoint only after 17 minutes of waiting, citing traffic at the checkpoint.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

#### Other impediments:

- On the evening of 20 June, an SMM long-range UAV experienced GPS signal interference, assessed as probable jamming, while flying over areas between government-controlled Kostiantynivka (60km north of Donetsk) and Pleshchiivka (51km north of Donetsk).8
- On the night of 21 and 22 June, an SMM long-range UAV experienced GPS signal interference, assessed as probable jamming, while flying over areas between government-controlled Stepanivka (71km south of Donetsk) and Novohryhorivka (55km south of Donetsk).<sup>9</sup>
- Medical staff at a hospital in Donetsk city refused to give the SMM information about a reported civilian casualty, referring the SMM instead to senior members of the armed formations.
