

OSCCE Special Monitoring Mission to Ukraine


Daily Report 47/2021

27 February 2021¹

Summary

- In Donetsk region, the SMM recorded 41 ceasefire violations. In the previous reporting period, it recorded ten ceasefire violations in the region.
- In Luhansk region, the Mission recorded 30 ceasefire violations. In the previous reporting period, it recorded 20 ceasefire violations in the region.
- The SMM continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske, and again saw containers inside and near the southern edge of the area near Zolote and people inside the latter area during daytime.
- The Mission observed weapons in violation of withdrawal lines on both sides of the contact line in Donetsk region.
- The SMM facilitated and monitored adherence to localized ceasefires to enable maintenance and operation of critical civilian infrastructure.
- The Mission continued following up on the situation of civilians, including at four entry-exit checkpoints and three corresponding checkpoints of the armed formations in Donetsk and Luhansk regions.
- The Mission's freedom of movement continued to be restricted, including at a checkpoint of the armed formations near Olenivka, Donetsk region.*

Ceasefire violations²





In Donetsk region, the SMM recorded 41 ceasefire violations, including 34 undetermined explosions. The majority of ceasefire violations occurred in areas south-east of Chermalyk (government-controlled, 77km south of Donetsk) and west of Novoselivka (government-controlled, 66km south of Donetsk). In the <u>previous reporting period</u>, the Mission recorded ten ceasefire violations.

In Luhansk region, the SMM recorded 30 ceasefire violations, including ten undetermined explosions, most of which occurred in areas east and west of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below). In the <u>previous reporting</u> <u>period</u>, the Mission recorded 20 ceasefire violations.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding additional measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has so far recorded at least 10,899 ceasefire violations in both Donetsk and Luhansk regions (including 3,599 explosions, 1,239 projectiles in flight, 105 muzzle flashes, 62 illumination flares and at least 5,894 bursts and shots).

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 26 February, inside the **disengagement area near Stanytsia Luhanska** (governmentcontrolled, 16km north-east of Luhansk), the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them) south of the repaired span of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

On the same day, while positioned near the checkpoint of the armed formations south of the **disengagement area near Zolote**, the SMM again saw five containers inside a fenced perimeter south of the area's southern edge, on the southern edge of the road leading eastwards towards Zolote-5/Mykhailivka (non-government-controlled, 61km west of Luhansk). The SMM again saw concrete blocks placed along the northern edge of the fenced perimeter.

The SMM again saw another container, which was previously located about 30m north of the area's southern edge, on the area's southern edge.

Inside the area, the SMM again saw a container about 60–70m north of the other five and another about 350m north of the area's southern edge, both on the western edge of road T-1316. About 10–30m north of the former container, the Mission again saw six concrete blocks placed in three rows across both lanes of the same road.

While positioned near the same checkpoint of the armed formations, the Mission saw three members of the armed formations (wearing armbands with "JCCC" written on them), all of whom walked inside the area to about 350m north of its southern edge and then returned. The SMM also saw an ambulance carrying two men (in their fifties) and two women (in their thirties), all in medical protective gear, drive to the same location and then return.

On the evening of 25 February, the SMM camera in Zolote recorded two undetermined explosions at an assessed range of 2-4km east-north-east, assessed as outside the disengagement area, but within 5km of its periphery. During the day on 26 February, while positioned at the abovementioned checkpoint of the armed formations south of the area, the

Mission heard three undetermined explosions and 20 bursts and shots of small-arms and heavymachine-gun fire, assessed as outside the disengagement area, but within 5km of its periphery as well as another undetermined explosion at an assessed range of 7-10km east, assessed as outside the disengagement area.

During the day on 24 February, inside the **disengagement area near Petrivske** (nongovernment-controlled, 41km south of Donetsk), an SMM long-range unmanned aerial vehicle (UAV) spotted two people inside a former position of the Ukrainian Armed Forces about 1.5km east-north-east of the area's south-western corner. The same UAV also spotted three people and <u>again</u> saw a car near a former position of the armed formations about 350m north-northwest of the area's south-eastern corner.

On 26 February, while positioned about 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the Mission heard five undetermined explosions at an assessed range of 7-10km north and south, assessed as outside the disengagement area. While positioned at the same location, about 350m west-north-west of the area's northern western corner, the SMM also saw two armoured personnel carriers (MT-LB) and one infantry fighting vehicle (type undetermined) in a field, about 150m west-south-west of its position, driving in a northerly direction towards road C-050563.

Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In violation of withdrawal lines, the SMM observed two anti-tank guided missile systems in a government-controlled area of Donetsk region and six anti-tank guns and six self-propelled howitzers in a training area in a non-government-controlled area of Donetsk region.

Beyond withdrawal lines but outside designated storage sites, the Mission observed three surface-to-air missile systems, 12 tanks and three howitzers, including at two railway stations in government-controlled areas of both Donetsk and Luhansk regions, and 22 tanks in a training area, in a non-government-controlled area of Donetsk region (for further information, see the tables below).

Indications of military and military-type presence in the security zone⁶

The SMM saw two self-propelled anti-aircraft systems and an anti-aircraft gun in governmentcontrolled areas of Donetsk region, armoured combat vehicles in government-controlled areas of both Donetsk and Luhansk regions as well as in a non-government-controlled area of Donetsk region (for further information, see the table below).

SMM facilitation of maintenance and operation of critical civilian infrastructure

The Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk).

It additionally facilitated and monitored adherence to localized ceasefires to enable maintenance to sewage treatment infrastructure near a government-controlled area of Dolomitne (53km north-east of Donetsk), maintenance to the phenol sludge reservoir near Zalizne (formerly Artemove, government-controlled, 42km north-east of Donetsk) and to water infrastructure in Zolote-5/Mykhailivka (non-government-controlled, 61km west of Luhansk).

Situation at entry-exit checkpoints and corresponding checkpoints

In Donetsk region, the Mission noted that the entry-exit checkpoint (EECP) near Novotroitske (government-controlled, 36km south-west of Donetsk) and the corresponding checkpoint of the armed formations near Olenivka (non-government-controlled, 23km south-west of Donetsk) were open, and saw civilian traffic passing through in both directions.

In Luhansk region, the Mission noted that the EECP near Stanytsia Luhanska was open, with people queueing to travel towards government-controlled areas and in the opposite direction. The Mission observed two golf carts operating between the repaired span of the Stanytsia Luhanska bridge and the EECP. While at the EECP, the Mission also saw a man (age unknown) transferring a coffin with a stretcher from government- to non-government-controlled areas.

The SMM also noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open but did not observe any people passing through, and that the corresponding checkpoints of the armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were closed.

While at the EECP near Shchastia, the SMM observed 11 trucks stationary on road H-21, about 50m north of the EECP, reportedly carrying construction material for an international humanitarian organization.

The Mission continued monitoring in Lviv, Kherson, Ivano-Frankivsk, Odessa, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see SMM Daily Report of 23 February 2021). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Delay:

- On 26 February, at a checkpoint of the armed formations near Olenivka (nongovernment-controlled, 23km south-west of Donetsk), two members of the armed formations (one of them visibly armed) allowed the Mission passage towards government-controlled areas only after about 18 minutes.

Other impediments:⁷

- On 24 February, an SMM long-range UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas between government-controlled Pisky (11km north-west of Donetsk) and Novotroitske (36km south-west of Donetsk).



This map of eastern Ukraine is meant for illustrative purposes and indicates locations mentioned in the report, as well as those where the SMM has offices (monitoring teams, patrol hubs and forward patrol bases) in Donetsk and Luhansk regions. (In red: a forward patrol base from which SMM staff have temporarily relocated based on recommendations of security experts from participating States, as well as SMM security considerations. The SMM uses the premises during daylight hours and also patrols in this settlement during daylight hours).
