


# Daily Report 51/2021

4 March 2021<sup>1</sup>

#### **Summary**

- In Donetsk region, the SMM recorded 102 ceasefire violations. In the previous reporting period, it recorded ten ceasefire violations in the region.
- In Luhansk region, the Mission recorded no ceasefire violations for the fourth consecutive day.
- The SMM continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske, and observed people inside the area near Zolote during daytime.
- The Mission observed weapons in violation of withdrawal lines in a non-government-controlled area of Donetsk region.
- The SMM facilitated and monitored adherence to localized ceasefires to enable maintenance, repairs and operation of critical civilian infrastructure. It heard seven ceasefire violations close to the Donetsk Filtration Station (DFS), near the time when a bus with DFS workers was driving towards the station.
- The Mission continued following up on the situation of civilians, including at two entry-exit checkpoints and four corresponding checkpoints of the armed formations in Donetsk and Luhansk regions.
- The SMM observed 11 trucks bearing the logo of a humanitarian organization cross the contact line near non-government-controlled Vesela Hora towards government-controlled Shchastia.
- The Mission's freedom of movement continued to be restricted.\*

#### Ceasefire violations<sup>2</sup>





In Donetsk region, the SMM recorded 102 ceasefire violations, the majority of which were undetermined explosions which occurred at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk). In the <u>previous reporting period</u>, the Mission recorded ten ceasefire violations, seven of which near Shyrokyne.

In Luhansk region, the SMM recorded no ceasefire violations for the fourth consecutive day. The last time it recorded ceasefire violations in the region was on the evening of 27 February. (See SMM Daily Report of 1 March 2021.)

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding additional measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has so far recorded at least 11,180 ceasefire violations in both Donetsk and Luhansk regions (including 3,825 explosions, 1,281 projectiles in flight, 108 muzzle flashes, 62 illumination flares and at least 5,904 bursts and shots).

#### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>5</sup>

On 3 March, inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them) south of the repaired span of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

During the day on 2 March, inside the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk), an SMM long-range unmanned aerial vehicle (UAV) spotted two people inside former positions of the Ukrainian Armed Forces, one about 550m west-south-west of the area's north-eastern corner and the other south of the railway track about 900m west of road T-1316.

On 3 March, while positioned near the checkpoint of the armed formations south of the area, the SMM again saw five containers inside a fenced perimeter south of its southern edge, on the southern edge of the road leading eastwards towards Zolote-5/Mykhailivka (non-government-controlled, 61km west of Luhansk). The Mission also again saw another container on the area's southern edge.

Inside the area, the SMM again saw a container about 60–70m north of the other five and another about 350m north of the area's southern edge, both on the western edge of road T-1316. About 10–30m north of the former container, the Mission again saw six concrete blocks placed in three rows across both lanes of the same road.

While positioned near the abovementioned checkpoint, the Mission saw four members of the armed formations (wearing armbands with "JCCC" written on them), three of whom walked inside the area to about 350m north of its southern edge and then returned, accompanied by an ambulance carrying four people (two men and two women, mixed ages) in protective medical gear.

On 1 March, an SMM mini-UAV spotted two people in military-type clothing outside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), about 5m north of its north-eastern corner, on road C-051532 between Petrivske and

Viktorivka (non-government-controlled, 42km south of Donetsk), as well as three people in military-type clothing carrying a large piece of wood on the same road, about 220m west-northwest of the area's north-eastern corner. Later on the same day, the UAV spotted four people in military-type clothing in the same location.

On the same day, an SMM mini-UAV spotted for the first time seven probable anti-tank mines (assessed as not recently laid) in a field about 300m north-west of the area's north-eastern corner (not visible in imagery from 29 October 2020), assessed as belonging to the armed formations.

Also on 1 March, inside the area, the same mini-UAV again spotted 60 anti-tank mines about 250m north-west of the its south-eastern corner; 18 anti-tank mines about 1.2km north-north-west of its south-eastern corner, close to the area's eastern edge; and two probable anti-personnel mines (one MON-50 and one MON-90) about 600m south-south-east of its north-eastern corner, near its eastern edge, all assessed as belonging to the armed formations. The UAV also again spotted a single row of about 150 anti-tank mines about 700m east-south-east of the area's north-western corner, assessed as belonging to the Ukrainian Armed Forces.

On the same day, outside the area, the same SMM mini-UAV again spotted an anti-tank mine (probable TM-62) in a field about 700m north of Petrivske; about 60 anti-tank mines in a field about 200m east of the area's eastern edge, about 900m south-east of its north-eastern corner; six anti-tank mines about 130m west-north-west of its north-eastern corner, beside road C-051532; and about 20 anti-personnel mines in a plastic bag in a field about 2km north of Petrivske. All of these mines were assessed as belonging to the armed formations. (For previous observations in the area, see SMM Daily Reports of 19 June 2020, 11 November 2020 and 28 January 2021.)

The same UAV also again spotted a single row of about 200 anti-tank mines about 650m east-north-east of the area's north-western corner, assessed as belonging to the Ukrainian Armed Forces. (For previous observations in the area, see <a href="SMM Daily Report of 19 June 2020">SMM Daily Report of 19 June 2020</a>.)

On 3 March, while positioned at three locations near the disengagement area, the Mission observed a calm situation.

#### Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In violation of withdrawal lines, the SMM observed six tanks and three howitzers in a non-government-controlled training in Donetsk region.

Beyond withdrawal lines but outside designated storage sites, the Mission observed two tanks, three anti-tank guided missile systems and four anti-tank guns in government-controlled areas of Donetsk and Luhansk regions. (For further information, see the tables below.)

#### Weapons storage sites

At a weapons permanent storage site in a government-controlled area of Luhansk region 3 March

The SMM noted that 65 tanks (T-64), 24 mortars (22 M120-15 *Molot*, 120mm and two 2B11 *Sani*, 120mm) were again missing.

#### Weapons the SMM could not verify as withdrawn<sup>6</sup>

At two heavy weapons holding areas in government-controlled areas of Luhansk region 3 March

The SMM noted that four anti-tank guns (MT-12 *Rapira*, 100mm) and 15 self-propelled howitzers (2S1 *Gvozdika*, 122 mm) were present, and that 86 howitzers (49 2A36 *Giatsint-B*, 152mm and 37 2A65 *Msta-B*, 152mm) were again missing.

#### Indications of military and military-type presence in the security zone<sup>7</sup>

The SMM saw armoured combat vehicles on both sides of the contact line in Donetsk region, including near residential houses, and in a non-government-controlled area of Luhansk region. (For further information, see the table below.)

Anti-tank mines near Petrivske, Donetsk region, and Vesela Hora, Luhansk region, as well as demining activities near Myrna Dolyna, Luhansk region

On 1 March, an SMM mini-UAV spotted for the first time eight anti-tank mines (assessed as not recently laid) about 3km north of Petrivske, assessed as belonging to the armed formations.

On the same day, in a field about 2.5km east-north-east of Vesela Hora (non-government-controlled, 16km north of Luhansk), an SMM mini-UAV again spotted about 32 anti-tank mines, assessed as belonging to the armed formations. (For previous observations in the area, see SMM Daily Report of 7 December 2020.)

On 3 March, on the eastern outskirts of Bohdanivka (government-controlled, 41km south-west of Donetsk), on the southern edge of a road leading towards Viktorivka, the SMM observed for the first time a hazard sign (red with a skull and crossbones and a warning written on it in Ukrainian).

On the same day, about 1.8km south-east of Myrna Dolyna (government-controlled, 67km north-west of Luhansk), on the western edge of road P-66, the SMM observed seven de-miners (men, mixed ages) of an international organisation conducting demining activities.

### SMM facilitation of maintenance, repairs and operation of critical civilian infrastructure

The Mission continued to facilitate the operation of the Donetsk Filtration Station (DFS) (15km north of Donetsk). During the day, while positioned near the station, the Mission recorded seven shots of small-arms fire, assessed as within a 5km radius of the station, near the time when a bus with DFS workers was driving towards the station.

It also facilitated and monitored adherence to localized ceasefires to enable maintenance and repairs to sewage treatment infrastructure near a government-controlled area of Dolomitne (53km north-east of Donetsk) and repairs to power lines near Zolote-5/Mykhailivka.

#### Situation at entry-exit checkpoints and corresponding checkpoints

In Donetsk region, the SMM noted that the checkpoint of the armed formations near Kreminets (non-government-controlled, 16km south-west of Donetsk) was closed.

In Luhansk region, the Mission noted that the checkpoint of the armed formations south of the repaired span of the Stanytsia Luhanska bridge was open, with people queueing to travel in both directions.

The SMM also noted that the entry-exit checkpoints (EECP) near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open but did not observe any people passing through, and that the corresponding checkpoint of the armed formations south of the disengagement area near Zolote was closed.

While positioned near the EECP and near the corresponding checkpoint of the armed formations 3km south-east of the bridge in Shchastia, the SMM saw 11 trucks bearing the logo of an international humanitarian organization cross towards government-controlled areas. (For a previous observation of trucks passing through this crossing point into non-government-controlled areas, see SMM Daily Report of 2 March 2021.)

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

# \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see SMM Daily Report of 2 March 2021). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

# Other impediments:<sup>8</sup>

- On 2 March, an SMM long-range UAV twice experienced GPS signal interference, assessed as caused by probable jamming, once while flying over areas between government-controlled Novozvanivka (70km west of Luhansk) and Troitske (69km west of Luhansk), and once between government-controlled Luhanske (59kn north-east of Donetsk) and Marinka (23km south-west of Donetsk).


