


Daily Report 160/2021

12 July 2021¹

Summary

- In Donetsk region, between the evenings of 9 and 11 July, the Mission recorded 335 ceasefire violations, including 28 explosions. In the previous reporting period, it recorded 15 ceasefire violations in the region.
- In Luhansk region, between the evenings of 9 and 11 July, the SMM recorded 56 ceasefire violations, including 25 explosions. In the previous reporting period, it recorded 114 ceasefire violations in the region.
- The Mission followed up on reports of a man who died due to shelling in non-government-controlled Donetsk city.
- The SMM observed damage to a civilian property in non-government-controlled Yasne, Donetsk region.
- The SMM continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. It recorded ceasefire violations inside the disengagement area near Petrivske.
- The Mission facilitated and monitored adherence to localized ceasefires to enable the operation and repairs of critical civilian infrastructure.
- The SMM continued following up on the situation of civilians, including at four entry-exit checkpoints and the corresponding checkpoints of the armed formations in Donetsk and Luhansk regions. At the checkpoint of the armed formations south of Stanytsia Luhanska bridge the SMM saw three people receive medical attention while queuing.
- The Mission visited two border crossing points outside government control in Donetsk region and monitored a railway station and border areas outside government control in Luhansk region.
- The Mission observed no change in the security situation in east and south-east Kherson region.
- The SMM's freedom of movement continued to be restricted, including at four checkpoints
 of the armed formations in southern Donetsk region. Its UAVs again experienced multiple
 instances of GPS signal interference.*



In Donetsk region, between the evenings of 9 and 11 July, the SMM recorded 335 ceasefire violations, including 28 explosions (two airbursts, nine impacts, and 17 undetermined). The majority of ceasefire violations occurred during the night of 9-10 July in areas east of Maiorsk (government-controlled, 45km north-east of Donetsk). In the <u>previous reporting period</u>, the Mission recorded 15 ceasefire violations.

In Luhansk region, between the evenings of 9 and 11 July, the SMM recorded 56 ceasefire violations, including 25 undetermined explosions. The majority of ceasefire violations occurred during the night of 9-10 July and during the day of 10 July in areas close to the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below). In the <u>previous reporting period</u>, the Mission recorded 114 ceasefire violations, the majority of which also occurred near the aforementioned disengagement area.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding additional measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has recorded at least 42,806 ceasefire violations in both Donetsk and Luhansk regions (including 13,063 explosions, 6,888 projectiles in flight, 242 muzzle flashes, 135 illumination flares and at least 22,478 bursts and shots).

A man died due to shelling in non-government-controlled Donetsk city

The SMM followed up on reports of a man (in his fifties) who died in the Kyivskyi district of non-government-controlled Donetsk city on 14 April.

On 16 April, staff at a morgue in non-government-controlled Donetsk city told the SMM by phone that a man (in his fifties), a resident of the Kyivskyi district of Donetsk city, had been found dead in his apartment on 15 April with shrapnel injuries to his chest and left lung.

On 15 April, at the deceased man's apartment building in the Kyivskyi district of Donetsk city, six people, who introduced themselves as neighbours (five men and a woman, mixed ages), told the SMM that on 14 April in the evening they had heard, felt and seen multiple explosions. The neighbours also said that they had seen the man on his balcony and that, on the morning of 15 April, members of the armed formations had found the man's body in his apartment.

On 9 July, a woman (in her fifties), who introduced herself as the wife of the deceased, told the SMM by phone that on the morning of 15 April she had received a phone call from members of the armed formations in Donetsk city, informing her that her husband had sustained fatal injuries due to shelling on 14 April. She added that his funeral had taken place on 20 April.

Damage to a civilian property in Yasne, Donetsk region

The SMM followed up on reports of damage to a civilian property in Yasne (non-government-controlled, 30km south-west of Donetsk) on 2 July.

On 9 July, in Yasne, on the south-facing wall of a two-storey building on 31 Shchorsa Street, the SMM saw multiple holes (about 1cm in diameter) in a window, and multiple holes (1-5cm in diameter) in the wall. The Mission assessed the damage as caused by shrapnel from an explosion occurring about 2m above ground, but was unable to determine the type of weapon used or direction of fire

At the same address, a man (in his eighties) told the SMM that in the morning of 2 July he had heard an explosion, as a result of which the south-facing walls of three two-storey buildings at 31, 31A and 33 Shchorsa Street had sustained damage. The SMM could not access the buildings at Shchorsa Street 31A and 33 due to security concerns.

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 10 and 11 July, while positioned inside the **disengagement areanear Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the Mission saw members of the armed formations (wearing armbands with "JCCC" written on them) south of the repaired span of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

During the night of 9-10 July, the SMM camera in Zolote recorded one undetermined explosion and four projectiles in flight, all at an assessed range of 2-3km east and east-north-east. During the day of 10 July, while positioned in Zolote-5/Mykhailivka (non-government-controlled, 60km west of Luhansk), the Mission heard one undetermined explosion at an assessed range of 2-3km north. On the evening of 10 July, the SMM camera in Zolote recorded two illumination flares at an assessed range of 3-5km east-south-east. During the night of 10-11 July, while positioned on the northern edge of Popasna (government-controlled, 69km west of Luhansk), the Mission heard 13 undetermined explosions and ten bursts of heavy-machine-gun fire, all at an assessed range 3-6km east-north-east. During the day on 11 July, while positioned at two locations near the area, the Mission heard eight undetermined explosions and three bursts of heavy-machine-gun fire. All these ceasefire violations were assessed as outside the disengagement area near Zolote, but within 5km of its periphery.

On 10 and 11 July, while positioned near the checkpoint of the armed formations south of the same disengagement area, the Mission saw members of the armed formations (wearing armbands with "JCCC" written on them). The SMM again saw the seven previously observed containers located south of the disengagement area's southern edge and inside the area.

On the evening of 9 July, the SMM camera about 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded four projectiles in flight at an assessed range of 100-500m east-south-east, all assessed as inside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk).

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In violation of withdrawal lines, the Mission saw one surface-to-air missile system and seven howitzers in two residential areas in government-controlled areas of Donetsk and Luhansk regions.

Beyond withdrawal lines but outside designated storage sides, the SMM observed 33 howitzers and six anti-tank guns, all in a residential area and at a railway station in government-controlled areas of Donetsk region. (For further information, see the tables below.)

Indication of military and military-type presence in the security zone

The SMM saw eight armoured combat vehicles and one anti-aircraft gun, as well as two radar systems, including in a residential area and in a compound, in government-controlled areas of Donetsk and Luhansk regions, as well as a probable anti-aircraft gun in a non-government-controlled area of Luhansk region (For further information, see the table below.)

Presence of mines near Popasna, Luhansk region

On 9 July, near a checkpoint of the Ukrainian Armed Forces on the eastern edge of Popasna (government-controlled, 69km west of Luhansk), an SMM mini-UAV spotted six anti-tank mines attached to a board, on the southern edge of road T-0504, one of which for the first time. In a field about 150m south of the same road, the same UAV again spotted three anti-tank mines. All these mines were assessed as belonging to the Ukrainian Armed Forces. (For previous observations in the area, see SMM Daily Report of 31 May 2021).

SMM facilitation of maintenance and operation of critical civilian infrastructure

On 10 and 11 July, the Mission continued to facilitate the operation of the Donetsk Filtration Station (DFS) (15km north of Donetsk) and monitored the security situation near the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

On 10 July, the SMM registered 17 ceasefire violations, including two undetermined explosions within a 5km radius of the DFS.

On 10 July, the Mission also monitored adherence to a localized ceasefire to enable repairs to a water pipeline near Berezove (government-controlled, 31km south-west of Donetsk).

Situation at entry-exit checkpoints and corresponding checkpoints

In Donetsk region, on 11 July, the SMM noted that the entry-exit checkpoint (EECP) near Marinka (government-controlled, 23km south-west of Donetsk) was open but that the corresponding checkpoint of the armed formations near Kreminets (non-government-controlled, 16km south-west of Donetsk) was closed.

In Luhansk region, on 10 and 11 July, the Mission observed that the EECP near Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of Stanytsia Luhanska bridge were open, with people queueing to travel in both directions.

In the afternoon of 9 July, at the checkpoint of the armed formations south of Stanytsia Luhanska bridge, the SMM observed medical staff provide assistance to a man (in his fifties) who appeared to be physically exhausted, reportedly after crossing from government-controlled areas. On 10 July, at the same checkpoint, the Mission observed a man and a woman (in their forties) collapse while queuing to cross to government-controlled areas, and subsequently receive assistance from medical staff.

On both days, the SMM also noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open, but that the corresponding checkpoints of the

armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were closed.

Border areas outside government control

While at a border crossing point⁶ near Uspenka (73km south-east of Donetsk) for about an hour, the Mission observed 16 cars (including ten with "DPR" plates), three covered cargo trucks (including two with "DPR" plates), six minibuses (with "DPR" plates, with passengers of mixed ages and genders) and 46 people (16 women and 27 men, mixed ages and three children) entering Ukraine. During the same time, the SMM saw 15 cars (including nine with "DPR" plates), seven covered cargo trucks (including four with "DPR" plates), four minibuses (including three with "DPR" plates, with passengers of mixed ages and genders), one bus (with "DPR" plates, with passengers of mixed ages and genders) and 38 people (16 women and 18 men of mixed ages and four children) exiting Ukraine.

While at a border crossing point near Ulianivske (61km south-east of Donetsk) for about 40 minutes, the Mission saw two women (in their sixties) entering Ukraine.

On 11 July, at a railway station in Sukhodilsk (38km south-east of Luhansk), the SMM observed 36 freight cars and six tank cars, all stationary.

On the same day, the Mission also monitored areas along the border outside government control near the border with the Russian Federation near Sukhodilsk and observed no change in the security situation.

Security situation in east and south-east Kherson region

Between 9 and 11 July, the SMM monitored areas of east and south-east Kherson region at checkpoints near Kalanchak (67km south-east of Kherson), Chaplynka (77km south-east of Kherson) and Chonhar (163km south-east of Kherson), as well as areas along the coast of the Azov Sea near Henichesk (176km east of Kherson) and areas near Novotroitske (154km east of Kherson). While monitoring these areas, the Mission observed no change in the security situation.

The SMM continued monitoring in Lviv, Odessa, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi, and Kyiv.

${ m *Restrictions}$ of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Coordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed

formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see SMM Daily Report of 8 July 2021). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denials:

- On 10 July, while at the railway station depot in Sloviansk (government-controlled, 95km north of Donetsk), a man (in his fifties), asked the SMM to leave the area, referring to their lack of written permission and the safety of the Mission.
- On the same day, at a checkpoint of the armed formations near Zaichenko (non-governmentcontrolled, 93km south of Donetsk), two armed members of the armed formations denied the SMM passage westwards towards Pikuzy (formerly Kominternove, non-governmentcontrolled, 92km south of Donetsk) and southwards towards Sakhanka (non-governmentcontrolled, 97km south of Donetsk), referring to "ongoing roadworks in the area".
- On 11 July, at a checkpoint of the armed formations near Staromariyka (62km south of Donetsk), an armed member of the armed formations denied the SMM passage into the settlement, referring to "the SMM's safety".
- On the same day, at a checkpoint of the armed formations on the eastern edge of Nova Marivka (non-government-controlled, 64km south of Donetsk), an armed member of the armed formations denied the SMM passage into the settlement, referring to "the SMM's safety". While at the checkpoint, the Mission observed a civilian car with passengers pass through the checkpoint.
- On the same day, at a checkpoint of the armed formations on the north-eastern edge of Starolaspa (non-government-controlled, 51km south of Donetsk), an armed member of the armed formations denied the SMM passage into the settlement, referring to "ongoing demining activities in the area".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:⁷

- On 10 July, SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, during one flight over areas near New York (formerly Novhorodske, government-controlled, 35km north of Donetsk), during one flight over areas near Nelipivka (government-controlled, 40km north of Donetsk), during one flight over areas near Pervomaisk (non-government-controlled, 58km west of Luhansk) and during one flight over areas near Zolote-5/Mykhailivka (non-government-controlled, 58km west of Luhansk).
- On the same day, SMM mid-range UAVs experienced GPS signal interference, assessed as caused by probable jamming, during one flight over areas near Dokuchaievsk (nongovernment-controlled, 30km south-west of Donetsk), during one flight over areas near

- Manhush (government-controlled, 111km south of Donetsk) and during one flight over areas near Pryazovske (government-controlled, 99km south of Donetsk).
- On 11 July, SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, during one flight over areas near Zolote-5/Mykhailivka (non-government-controlled, 58km west of Luhansk).
- On the same day, SMM mid-range UAV experienced GPS signal interference, assessed as caused by probable jamming, during two flights over areas near Mariupol (government-controlled, 102km south of Donetsk).



The SMM uses the premises during daylight hours and also patrols in this settlement during daylight hours).
