

OSCCE Special Monitoring Mission to Ukraine


Daily Report 208/2021

6 September 2021¹

Summary

- In Donetsk region, from the evenings of 3 to 5 September, the Mission recorded 172 ceasefire violations, including 11 explosions. In the previous reporting period, it recorded 48 ceasefire violations in the region.
- In Luhansk region, from the evenings of 3 to 5 September, the SMM recorded 38 ceasefire violations, including seven explosions. In the previous reporting period, it recorded 34 ceasefire violations in the region.
- The Mission corroborated civilian casualty a in non-government-controlled Staromykhailivka, Donetsk region.
- The SMM followed up on damage to a civilian property in government-controlled Avdiivka, Donetsk region.
- Small-arms fire was assessed as directed at SMM's mini-unmanned aerial vehicles on three occasions near non-government-controlled Vasvlivka. Nvzhnie Lozove and Yakovlivka, Donetsk region.*
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. It recorded ceasefire violations inside the disengagement area near Petrivske.
- The SMM facilitated and monitored adherence to localized ceasefires to enable the operation and repair of critical civilian infrastructure.
- The Mission continued following up on the situation of civilians, including at five entry-exit checkpoints and two corresponding checkpoints of the armed formations in Donetsk and Luhansk regions.
- The SMM visited a border crossing point outside government control and monitored areas near the border with the Russian Federation in Donetsk region.
- The Mission's freedom of movement continued to be restricted. Its unmanned aerial vehicles again experienced multiple instances of GPS signal interference. *



In Donetsk region, from the evenings of 3 to 5 September, the SMM recorded 172 ceasefire violations, including eleven explosions (two airbursts and nine undetermined). The majority of ceasefire violations occurred in areas close to the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk) on the night of 3-4 September, evening of 4 September and during the day on 5 September (see below), and north of Shyrokyne (government-controlled, 100km south of Donetsk) on the nights of 3-4 and 4-5 September. In the previous reporting period, the Mission recorded 48 ceasefire violations, some of which also occurred in areas close to the disengagement area near Petrivske.

In Luhansk region, from the evenings of 3 to 5 September, the SMM recorded 38 ceasefire violations, including seven undetermined explosions. The majority of ceasefire violations occurred east of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) on the night of 4-5 September and during the day on 5 September (see below). In the previous reporting period, the Mission recorded 34 ceasefire violations, all of which also occurred near the same disengagement area.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has recorded at least 54,154 ceasefire violations in both Donetsk and Luhansk regions (including 15,602 explosions, 10,630 projectiles in flight, 270 muzzle flashes, 220 illumination flares and at least 27,432 bursts and shots).

A civilian casualty was corroborated in Staromykhailivka, Donetsk region

The Mission followed up on reports of a man injured in Staromykhailivka (non-government-controlled, 15km west of Donetsk) on 26 August.

On 4 September, a man (in his fifties) told the SMM over the phone that, on the evening of 26 August, he had been repairing a car in front of his house in the south-western part of the settlement when he heard explosions nearby, and noticed that he sustained an injury to his forehead. He added that an ambulance had subsequently taken him to a hospital in Donetsk city (non-government-controlled).

On 27 August, in Staromykhailivka, a woman (in her twenties), who introduced herself as the man's daughter, told the Mission that, on the evening of 26 August, she had been in front of her father's house when she had heard an explosion nearby and then seen that her father had sustained a head injury.

On 26 August, medical staff at a hospital in Donetsk city told the SMM over the phone that on the evening of 26 August a man (in his fifties) had been admitted. According to a medical certificate the Mission saw, the man had sustained shrapnel injuries to his forehead consistent with those caused by an explosion.

Damage to a civilian property in government-controlled Avdiivka, Donetsk region

The SMM followed up on reports of damage to a civilian property in Avdiivka (government-controlled, 17km north of Donetsk) on 28 August 2021.

On 2 September, at a one-storey civilian property at 101 Industrialnyi Avenue in the eastern part of Avdiivka, an SMM mini-unmanned aerial vehicle (UAV) spotted damage to the

building's north-western wall and its flat roof, with some of the asbestos panels removed. The Mission assessed the damage as recent, but was unable to assess the weapon used or the direction of fire.

On the same day, the SMM spoke to a man (age unknown), who introduced himself as the manager of a vehicle repair shop at the aforementioned address. He said that on the morning of 28 August he had been inside the shop when he had heard explosions nearby and had left the building. When he had returned to his shop, he saw, he said, that the roof and four north-facing windows had been damaged due to explosions.

Small-arms fire assessed as directed at SMM mini-UAVs near non-governmentcontrolled Vasylivka, Nyzhnie Lozove and Yakovlivka, Donetsk region

On 5 September, while positioned on the western edge of Vasylivka (non-governmentcontrolled, 20km north of Donetsk) to conduct an announced mini-UAV flight, the SMM heard six shots of small-arms fire at an assessed distance of about 2km south-south-west of the SMM's position, assessed as targeting the UAV. During the same and two other flights, the UAV also experienced GPS signal interference, assessed as caused by probable jamming.

On the same day, while positioned about 1km south-south-east of Nyzhnie Lozove (nongovernment-controlled, 59km north-east of Donetsk) to conduct an announced mini-UAV flight, the SMM heard 28 bursts and shots of small-arms fire at an assessed distance of about 1km west of the SMM's position, assessed as targeting the UAV, which was flying near positions of the armed formations, about 600m west-north-west of the SMM's position. During the same and two other flights, the UAV also experienced GPS signal interference, assessed as caused by probable jamming.

On the same day, while positioned on the eastern edge of Yakovlivka (non-governmentcontrolled, 10km north of Donetsk) to conduct an announced mini-UAV flight, the SMM heard five bursts of small-arms fire at an assessed distance of about 100m north-north-west of the SMM's position, assessed as targeting the UAV.

In all three instances, the Mission landed the UAVs and left the area. (See below.)*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 4 and 5 September, while positioned inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the Mission saw members of the armed formations (wearing armbands with "JCCC" written on them) south of the repaired span of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

On 2 September, about 60m north of the northern edge of the disengagement area, an SMM mini-UAV spotted an infantry fighting vehicle, in a field about 300m east of the EECP.

On the night of 4-5 September, the SMM camera in Zolote recorded one illumination flare at an assessed range of 1-3km east-south-east. During the day on 5 September, while positioned in two locations near the **disengagement area near Zolote**, the Mission heard 21 bursts and

shots of small-arms fire. All these ceasefire violations were assessed as outside the disengagement area, but within 5km of its periphery.

On 4 and 5 September, the SMM again saw the seven previously observed containers located south of the disengagement area's southern edge, and inside the area. Inside the disengagement area, about 350m north of its southern edge, the SMM saw again a previously reported underground structure covered by a green camouflage net. On both days, near the checkpoint of the armed formations south of the disengagement area, the Mission saw members of the armed formations (wearing armbands with "JCCC" written on them).

On the evening and night of 3-4 September, the SMM camera 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded 13 projectiles in flight at an assessed range of 2-4km south-east, unable to be assessed as inside or outside the **disengagement area near Petrivske**. On the evening of 4 September, the same camera recorded 19 projectiles in flight and one undetermined explosion at an assessed range of 1-4km east-south-east and south-east, all assessed as inside the disengagement area, and one undetermined explosion at an assessed range of 4-5km east-south-east, assessed as outside the disengagement area but within 5km of its periphery. During the day on 5 September, while positioned about 2km north of Petrivske, the SMM heard 24 bursts of heavy-machine-gun fire at an assessed distance of 2-3km west-south-west, assessed as outside the disengagement area, but within 5km of its periphery.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

Indications of military and military-type presence in the security zone

The SMM saw one anti-aircraft gun and five armoured combat vehicles in governmentcontrolled areas of Donetsk and Luhansk regions, including near a residential area. It also saw one armoured combat vehicle near a residential area in a non-government-controlled area of Luhansk region. (For further information, see the table below.)

Mines near Popasna, Luhansk region, and de-mining activities near Novoluhanske, Donetsk region

On 5 September, about 2km east of the eastern edge of Popasna (government-controlled, 69km west of Luhansk), the SMM saw an anti-personnel mine (MON-90), not previously reported, next to the road T-0504.

On 4 September, in a field about 2km north of Novoluhanske (government-controlled, 53km north-east of Donetsk), the SMM observed eight members (unknown genders and ages) of an international organization wearing protective gear and using mine detectors to carry out demining activities on both sides of a local road.

SMM facilitation of the operation of and repairs to critical civilian infrastructure

On 4 and 5 September, the Mission continued to facilitate the operation of the Donetsk Filtration Station (DFS) (15km north of Donetsk). On 5 September, while positioned on the

western edge of Vasylivka, the SMM heard six shots of small arms fire at an assessed distance of 2km south-south-west, assessed as within a 5km radius of the DFS.

On both days, the SMM also monitored the security situation near the pumping station near Vasylivka. On 4 September, it also monitored adherence to a localized ceasefire to enable repairs to the roof of a sewage treatment plant near Novoluhanske.

Situation at entry-exit checkpoints and corresponding checkpoints

On 4 September, in Donetsk region, the Mission observed that the entry-exit checkpoint (EECP) near government-controlled Maiorsk (45km north-east of Donetsk) was open, but did not see any traffic passing through.

On the same day, the Mission observed that the EECP near government-controlled Novotroitske (36km south-west of Donetsk) was open, but did not see any traffic passing through. The SMM also saw a convoy of 15 covered cargo trucks and eight vehicles stationary near and inside the EECP, all with the flag of a European country attached to the front of the cabin, waiting to move towards non-government-controlled areas.

On 4 and 5 September, in Luhansk region, the SMM observed that the EECP near Stanytsia Luhanska was open, with people queueing to travel in both directions.

On 5 September, at the EECP, the Mission observed the ongoing fence replacement works: workers (men, in their twenties to forties) continued to install a 3m-high wire fence. On both days, also at the EECP, the SMM again observed workers (men, in their twenties to fifties) assembling structures, assessed as shelters for the border guards.

On both days, the Mission noted that the EECPs near Zolote and Shchastia (governmentcontrolled, 20km north of Luhansk) were open, but that the corresponding checkpoints of the armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were closed.

On both days, about 50m north of the EECP near Zolote, the SMM observed seven Border Guards of the State Border Guard Service of Ukraine (SBGS) conducting works to reinforce an existing shelter for personnel and equipment, and 20 concrete blocks lying on the ground nearby. An officer of the SBGS told the SMM that the reinforced shelter would be used as accommodation for the SBGS and the one located about 70m north of the disengagement area would be dismantled.

Border areas outside government control

On 5 September, while at a border crossing point near Marynivka (78km east of Donetsk) for 90 minutes, the Mission observed 17 cars (including 11 with "DPR" plates), two buses (with "DPR" plates, carrying passengers of mixed genders and ages) and 14 people (ten women and two men of mixed ages, two children) entering Ukraine.⁶ During this time, it also saw 24 cars (including 12 with "DPR" plates), eight covered cargo trucks (including four with "DPR" plates), one motorbike and two people (one woman and one man of mixed ages) exiting

Ukraine.

The SMM also monitored areas near the border with the Russian Federation near Krasnopillia (56km south-east of Donetsk), Zelenyi Hai (73km south-east of Donetsk) Kuznetsovo-Mykhailivka (67km south-east of Donetsk), Novooleksandrivka (75km south-east of Donetsk), Samsonove (83km south of Donetsk) and observed no change in the security situation.

Security situation in east and south-east Kherson region

Between 3 and 5 September, the SMM monitored areas in east and south-east Kherson region, at checkpoints near Kalanchak (67km south-east of Kherson), Chaplynka (77km south-east of Kherson) and Chonhar (163km south-east of Kherson), as well as areas near Novotroitske (154km east of Kherson), Henichesk (176km east of Kherson) and along the North Crimean canal. While monitoring these areas, the Mission observed no change in the security situation.

The Mission continued monitoring in Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Coordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see <u>SMM Daily Report of 1</u> <u>September 2021</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:7

- On 5 September, while positioned on the western edge of Vasylivka (non-governmentcontrolled, 20km north of Donetsk) to conduct an announced mini-UAV flight, the Mission heard six shots of small-arms fire, assessed as aimed at the UAV. The Mission landed the UAV and left the area. During the same and two others flights, the UAV also experienced

GPS signal interference, assessed as caused by probable jamming. (See above.)

- On the same day, while positioned about 1km south-south-east of Nyzhnie Lozove (nongovernment-controlled, 59km north-east of Donetsk) to conduct an announced mini-UAV flight, the Mission heard 28 bursts and shots of small-arms fire, assessed as aimed at the UAV. The Mission landed the UAV and left the area. During the same and two other flights, the UAV also experienced GPS signal interference, assessed as caused by probable jamming. (See above.)
- On the same day, while positioned on the eastern edge of Yakovlivka (non-governmentcontrolled, 10km north of Donetsk) to conduct an announced mini-UAV flight, the Mission heard five bursts of small-arms fire, assessed as aimed at the UAV. The Mission landed the UAV and left the area. (See above.)
- SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, during 18 flights: twice over areas near government-controlled Berezove (31km south-west of Donetsk) and Novoluhanske (53km north-east of Donetsk); once over areas near government-controlled Taramchuk (29km south-west of Donetsk) and Semyhiria (58km north-east of Donetsk); twice over areas near non-government-controlled Vuhlehirsk (49km north-east of Donetsk), as well as once over areas near non-government-controlled Lohvynove (59km north-east of Donetsk), Debaltseve (58km north-east of Donetsk) and Sofiivka (formerly Karlo-Marksove, 40km north-east of Donetsk).
- On 5 September, the Mission cancelled three mid-range UAV flights due to GPS signal interference, assessed as caused by probable jamming: once near government-controlled Semyhiria and twice near non-government-controlled Lohvynove.


