

OSCE Special Monitoring Mission to Ukraine

Daily Report 287/2021

7 December 2021¹


Summary

- In Donetsk region, the SMM recorded 442 ceasefire violations, including 44 explosions. In the previous 24 hours, it recorded 71 ceasefire violations in the region.
- In Luhansk region, the Mission recorded 178 ceasefire violations, including 78 explosions. In the previous 24 hours, it recorded 22 ceasefire violations in the region.
- The SMM corroborated reports of two civilian casualties in government-controlled areas of Donetsk and Luhansk regions.
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. It recorded ceasefire violations inside the disengagement area near Petrivske.
- The SMM facilitated the operation and maintenance of critical civilian infrastructure.
- The Mission continued following up on the situation of civilians, including at five entry-exit checkpoints and four corresponding checkpoints of the armed formations in Donetsk and Luhansk regions.
- The SMM monitored areas near the border outside government control in Luhansk region.
- The Mission's freedom of movement continued to be restricted, including at a checkpoint of the Ukrainian Armed Forces near Lisne, near non-government-controlled Kovske and at checkpoints of the armed formations near Horlivka and Khreshchatytske (formerly Krasnoarmiiske), Donetsk region.*

Number of recorded ceasefire violations³







In Donetsk region, the SMM recorded 442 ceasefire violations, including 44 explosions (one impact and 43 undetermined). The majority of ceasefire violations occurred in areas north-west of Horlivka (non-government-controlled, 39km north-east of Donetsk), south-east of Pivdenne (formerly Leninske, government-controlled, 40km north-east of Donetsk) and inside and north-west of the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk). (See below.) In the previous 24 hours, the Mission recorded 71 ceasefire violations in the region.

In Luhansk region, the SMM recorded 178 ceasefire violations, including 78 undetermined explosions. All ceasefire violations occurred in areas south-west and north-west of the disengagement area near Zolote (government-controlled, 60km west of Luhansk). (See below.) In the <u>previous 24 hours</u>, the Mission recorded 22 ceasefire violations in the region, all of which also occurred close to the disengagement area near Zolote.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding Measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has recorded at least 89,796 ceasefire violations in both Donetsk and Luhansk regions (including 24,652 explosions, 21,308 projectiles in flight, 403 muzzle flashes, 390 illumination flares and at least 43,043 bursts and shots).

Two civilian casualties corroborated in government-controlled areas of Donetsk and Luhansk regions

The Mission followed up on reports of two civilians injured near government-controlled Marinka (23km south-west of Donetsk) on 1 December and in Stanytsia Luhanska (16km north-east of Luhansk) on 29 November, respectively.

On 2 December, a man (in his forties), who introduced himself as an employee of an electrical company, told the Mission over the phone that, on the morning of 1 December, he and a colleague had been driving in a company car to conduct electrical repair works, when an explosion had occurred which hit the car near a checkpoint of the Ukrainian Armed Forces on the south-eastern edge of Marinka. He added that he realized he had sustained an injury to his right leg and that he was subsequently taken to a hospital in Kurakhove (government-controlled, 40km west of Donetsk).

On 2 December, a police officer (man, age unknown) in Marinka told the SMM over the phone that on the morning of 1 December, a man (in his forties) had been injured in a car while on his way to conduct repair works near a checkpoint of the Ukrainian Armed Forces in the vicinity of Marinka. He added that the police had not been able to reach the scene of the incident due to shelling in the area.

On the same day, medical staff (man, age unknown) at a hospital in Kurakhove told the Mission over the phone that on the afternoon of 1 December, a man (in his forties) had been admitted with wounds to his right leg, consistent with those caused by the detonation of an explosive object.

On 6 December, a man (in his fifties) told the Mission over the phone that on the afternoon of 29 November, he had been working at a train depot in the north-western part of Stanytsia Luhanska, when he had heard explosions nearby and felt that he had sustained an injury to his head.

On 30 November, at a train depot at Depovska Street 1 in Stanytsia Luhanska, a woman (in her fifties) told the SMM that on the afternoon of the previous day, she had heard explosions nearby, while she had been working inside an administrative building. She added that subsequently, she saw a colleague (man, in his fifties) bleeding from his head.

On the same day, medical staff (woman in her fifties) at a hospital in Stanytsia Luhanska told the Mission that on the afternoon of 29 November, a man (in his fifties) had been admitted with a head injury, which she assessed as caused by shrapnel.

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 6 December, inside the **disengagement area near Stanytsia Luhanska** (16km north-east of Luhansk), the Mission saw two members of the armed formations (wearing armbands with "JCCC" written on them) about 50m south of the repaired span of the Stanytsia Luhanska bridge.

During the day, while on the northern edge of Popasna (government-controlled, 69km west of Luhansk), the SMM heard 54 undetermined explosions and 36 bursts and shots of heavy-machine-gun fire, assessed as outside the **disengagement area near Zolote**, but within 5km of its periphery.

Near the checkpoint of the armed formations south of the disengagement area, the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them). The Mission again saw the seven previously observed containers located south of the area's southern edge and inside the disengagement area. It saw that the previously reported road barriers across road T-1316, on the area's southern edge, continued to be closed.

During the day, while positioned on the western edge of Petrivske (non-government-controlled, 41km south of Donetsk), the Mission heard four shots of small-arms fire, assessed as inside the **disengagement area near Petrivske**. While positioned about 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the SMM also heard 97 bursts of heavy-machine-gun fire, assessed as outside the area but within 5km of its periphery.

Weapons storage sites

At a permanent storage site in a non-government-controlled area of Luhansk region

6 December

The SMM noted that one tank (T-72) was missing, compared with the previous visit on 9 September 2021.

Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In violation of withdrawal lines, the Mission saw a mortar south-east of the disengagement area near Stanytsia Luhanska and six howitzers near Bile (22km west of Luhansk), all in non-government-controlled areas of Luhansk region.

Beyond withdrawal lines but outside designated storage sites, the Mission saw one anti-aircraft system in a government-controlled area of Donetsk region, in a residential area, and 27 tanks in a training area in a non-government-controlled area of Luhansk region. (For further information, see the table below.)

Indications of military and military-type presence in the security zone

The SMM observed two armoured combat vehicles and a probable electronic warfare system (Suricatta-Bukovel type) in government-controlled areas of Donetsk region, including in a residential area. In a non-government-controlled area of Luhansk region it saw five armoured combat vehicles. (For further information, see the table below.)

Presence of mines and other obstacles between Pyshchevyk and Verkhnoshyrokivske

On 5 December, an SMM mini-UAV spotted three anti-tank mines (not previously reported and not visible in imagery from 3 December 2021) mounted on a wooden board on a road 400m west of the western edge of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), assessed as belonging to the armed formations. The mines were placed next to five Czech hedgehogs (not previously reported).

SMM facilitation of the operation and maintenance of critical civilian infrastructure

The SMM continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) (DFS). While positioned on the western edge of Yasynuvata (non-government-controlled, 16km north-east of Donetsk), the Mission heard 32 shots of small-arms fire, assessed as within a 5km radius of the DFS, of which 12 occurred during the transfer of DFS workers between the station and Yasynuvata.

The SMM also monitored the security situation in the area of the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk) and facilitated the inspection of gas pipelines between Vodiane (government-controlled, 15km north-west of Donetsk) and Opytne (government-controlled, 12km north-west of Donetsk).

Situation at entry-exit checkpoints and corresponding checkpoints⁶

In Donetsk region, the Mission observed that the entry-exit checkpoint (EECP) near Maiorsk (government-controlled, 45km north-east of Donetsk) was open and that the corresponding checkpoint of the armed formations near Horlivka (non-government-controlled, 39km north-east of Donetsk) was closed. The SMM also observed that the EECP near Novotroitske (government-controlled, 36km south-west of Donetsk) and the corresponding checkpoint of the armed formations near Olenivka (non-government-controlled, 23km south-west of Donetsk) were open, with civilian traffic passing through in both directions.

In Luhansk region, the SMM observed that the EECP near Stanytsia Luhanska was open, with people queueing to travel in both directions.

The Mission noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open, but that the corresponding checkpoints of the armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were closed.

Along road T-1316, between the EECP near Zolote and the following intersection, on the western side of the road, the Mission observed that eight workers continued building a fence. (For previous observations in the area, see <u>SMM Daily Report of 6 December 2021</u>.)

Border areas outside government control⁷

The SMM monitored areas close to the border with the Russian Federation near Provallia (60km south-east of Luhansk) and Cheremshyne (59km south-east of Luhansk) and observed no change in the security situation.

The SMM continued monitoring in Lviv, Odessa, Ivano-Frankivsk, Kharkiv, Kherson, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see <u>SMM Daily Report of 30</u> <u>November 2021</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denials:

- At a checkpoint near Lisne (government-controlled, 100km south of Donetsk), a soldier of the Ukrainian Armed Forces denied the Mission passage south of the settlement, citing "a lack of permission from superiors".
- On a road near Kovske (non-government-controlled, 91km south of Donetsk), two members of the armed formations denied the SMM passage north towards Samiilove (non-government-controlled, 89km south of Donetsk), citing "ongoing training activities" in the area.
- At a checkpoint near Khreshchatytske (formerly Krasnoarmiiske, non-governmentcontrolled, 86km south of Donetsk), a visibly armed member of the armed formations denied

the Mission passage west towards Kulykove (non-government-controlled, 87km south of Donetsk), citing "ongoing de-mining and engineering activities" in the area. While at the checkpoint, the Mission observed civilian traffic passing through.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Delay:

- At a checkpoint north-west of Horlivka (non-government-controlled, 39km north-east of Donetsk), a visibly armed member of the armed formations allowed the SMM passage towards non-government-controlled areas only after about 35 minutes of waiting.

Other impediments:8

- SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, during four flights: on two occasions while flying over areas near Zoria (government-controlled, 40km north-west of Donetsk) and once each while flying over areas near Trokhizbenka (government-controlled, 32km north-west of Luhansk) and Smile (non-government-controlled, 31km north-west of Luhansk).



When information is not known (indicated with an "N/K"), the SMM was unable to ascertain such information due to distance, weather conditions technical limitations and/or other considerations. Ceasefire violations recorded by more than one patrol/camera and assessed to be the same are entered only once.

This map of eastern Ukraine is meant for illustrative purposes and indicates locations mentioned in the report, as well as those where the SMM has offices (monitoring teams, patrol hubs and forward patrol bases) in Donetsk and Luhansk regions. (In red: a forward patrol base from which SMM staff have temporarily relocated based on recommendations of security experts from participating States, as well as SMM security considerations. The SMM uses the premises during daylight hours and also patrols in this settlement during daylight hours).
