

Organization for Security and Co-operation in Europe Special Monitoring Mission to Ukraine

# Daily Report 290/2021

10 December 2021<sup>1</sup>

#### **Summary**

- In Donetsk region, the SMM recorded 1,463 ceasefire violations, including 142 explosions. In the previous reporting period, it recorded 815 ceasefire violations in the region.
- In Luhansk region, the Mission recorded 161 ceasefire violations, including 97 explosions. In the previous reporting period, it recorded 32 ceasefire violations in the region.
- Members of the armed formations denied the SMM passage near Zolote and Molodizhne, Luhansk region, and delayed its passage for more than two hours near Olenivka, Donetsk region.\*
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske.
- The SMM facilitated and monitored the operation of and repairs to critical civilian infrastructure.
- The Mission continued following up on the situation of civilians, including at three entry-exit checkpoints and the corresponding checkpoints of the armed formations in Luhansk region.
- The Mission's freedom of movement continued to be restricted, including at two checkpoints of the armed formations in Donetsk region. Its unmanned aerial vehicles encountered instances of GPS signal interference, assessed as caused by probable jamming.\*





#### Map of recorded ceasefire violations



In Donetsk region, the SMM recorded 1,463 ceasefire violations, including 142 explosions (two impacts and 140 undetermined). The majority of ceasefire violations occurred in areas south-south-west of Svitlodarsk (government-controlled, 57km north-east of Donetsk), south and west of Zaichenko (non-government-controlled, 93km south of Donetsk), and north and north-north-east of Shyrokyne (government-controlled, 100km south of Donetsk). In the previous reporting period, the Mission recorded 815 ceasefire violations in the region, some of which also occurred in areas near Shyrokyne.

In Luhansk region, the SMM recorded 161 ceasefire violations, including 97 undetermined explosions. The majority of ceasefire violations occurred in areas south-south-west and south-south-east of the disengagement area near Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk) and south-west, north-north-east and east of the disengagement area near Zolote (government-controlled, 60km west of Luhansk). (See below.) In the previous reporting period, the Mission recorded 32 ceasefire violations in the region, some of which were also near the disengagement area near Zolote.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding Measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has recorded at least 92,463 ceasefire violations in both Donetsk and Luhansk regions (including 25,108 explosions, 22,011 projectiles in flight, 409 muzzle flashes, 397 illumination flares and at least 44,538 bursts and shots).

# Armed formations denied and delayed the SMM's passage at their checkpoints near Zolote, Molodizhne, Luhansk region, and near Olenivka, Donetsk region

On 9 December, the armed formations in Luhansk region twice denied SMM patrols travelling from government-controlled areas passage to non-government-controlled areas. The first denial occurred at 09:18, at the checkpoint near the southern edge of the disengagement area near Zolote. The second occurred at 11:30 at a checkpoint of the armed formations on road T-0504 about 1.5km south-west of Molodizhne (non-government-controlled, 63km north-west of Luhansk). Members of the armed formations cited a "lack of security guarantees" on the first occasion and a "clear order from those in control not to let the SMM cross" on the second.

While close to the checkpoint near Molodizhne, at 11:38, the SMM patrol heard at least five shots of small-arms fire at an assessed range of 20m north, assessed as originating from positions of the armed formations. The Mission immediately left the area. (See <u>SMM Spot</u> <u>Report 38/2021</u>.)

On the same day, at a checkpoint near Olenivka (non-government-controlled, 23km south-west of Donetsk), a member of the armed formations delayed the passage of an SMM patrol with Deputy Chief Monitor Mark Etherington on board south towards Novotroitske (government-controlled, 36km south-west of Donetsk) for two hours and eight minutes, citing "lack of information about the SMM patrol's crossing".\* (See <u>SMM Spot Report 39/2021</u>.)

#### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>5</sup>

During the day on 9 December, while positioned in Stanytsia Luhanska, the SMM heard 78 undetermined explosions and six shots of small-arms fire, assessed as outside the **disengagement area near Stanytsia Luhanska** but within 5km of its periphery.

Inside the disengagement area, the Mission saw three members of the armed formations (wearing armbands with "JCCC" written on them) south of the repaired span of the Stanytsia Luhanska bridge.

During the reporting period, while positioned at two locations near **the disengagement area near Zolote**, the Mission heard 67 ceasefire violations, including 17 undetermined explosions and at least five shots of small-arms fire (see above). During the same period, the SMM cameras in Popasna (government-controlled, 69km west of Luhansk) and Zolote recorded two undetermined explosions and eight projectiles in flight. All these ceasefire violations were assessed as outside the disengagement area near Zolote but within 5km of its periphery.

During the day on 9 December, near the checkpoint of the armed formations south of the disengagement area, the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them). The Mission again saw the seven previously observed containers located south of the area's southern edge and inside the disengagement area. It saw that the previously reported road barriers across road T-1316, on the area's southern edge, continued to be closed.

While positioned inside the area, about 1km south of its northern edge, the Mission again saw a metal box on the western edge of road T-1316 about 130m south-south-east of the railway bridge, and again saw a camera, wrapped in camouflage fabric, attached to a tree about 20m west of the same road. About 600m north of the area's southern edge, the Mission again observed one wooden box on the western edge of the same road. About 570m north of the area's southern edge, the SMM again saw one anti-personnel mine (MON-50, without a fuse) on the western edge of the same road, assessed as belonging to the armed formations. About 450m north of the area's southern edge, the SMM also again observed a wooden crate and two metal boxes placed across the same road, assessed as ammunition boxes. (For previous observations in the area, see <u>SMM Daily Report of 6 December 2021</u>.)

During the day, while positioned on the western edge of Petrivske (non-government-controlled, 41km south of Donetsk), the SMM heard six undetermined explosions, assessed as outside the **disengagement area near Petrivske** but within 5km of its periphery.

#### Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In violation of withdrawal lines, the SMM saw nine multiple launch rocket systems and 24 howitzers in three training areas in non-government-controlled areas of Luhansk region. Beyond withdrawal lines but outside designated storage sites, the Mission observed six mortars in a compound and 17 tanks at a train station in government-controlled areas of Donetsk region,

and 129 tanks, 42 howitzers, 12 mortars, nine surface-to-air missiles, and six anti-tanks guns in five training areas in non-government-controlled areas of Luhansk region. (For further information, see the tables below.)

### Indications of military and military-type presence in the security zone

On 8 December, on the north-eastern edge of Hranitne (government-controlled, 60km south of Donetsk), an SMM mini-unmanned aerial vehicle (UAV) again spotted a previously reported pontoon bridge across the river Kalmius. The Mission again noted that the wooden deck was broken in the middle, with a gap of about 3m separating its two parts. (For previous observations in the area, see SMM Daily Reports of <u>20 November</u> and <u>26 November 2021</u>.)

About 350m east of the north-eastern edge of Staromarivka (62km south of Donetsk), on the northern edge of road T-0512, the same UAV <u>again</u> spotted a Ukrainian flag on a pole and barbed wire running north to south from the pole to the edge of the road.

On 9 December, while positioned on the north-western edge of Yasynuvata, the SMM heard the sound of a non-SMM UAV flying above the patrol. The operation of any aerial vehicles is banned by the 22 July 2020 agreement on Measures to strengthen the ceasefire.

The Mission also observed two anti-aircraft guns and five armoured combat vehicles in government-controlled areas of Donetsk and Luhansk regions, and four armoured personnel carriers in a residential area of non-government-controlled Luhansk city. (For further information, see the table below.)

#### SMM facilitation of operation and repair of critical civilian infrastructure

The SMM continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) (DFS). While positioned in Yasynuvata (non-government-controlled, 16km northeast of Donetsk), the Mission heard 16 shots of small-arms fire, assessed as within a 5km radius of the DFS.

The SMM also facilitated and monitored repair works to power lines in Krasnohorivka (government-controlled, 21km west of Donetsk) and Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk), as well as maintenance and assessment of phenol sludge reservoirs near Nelipivka (government-controlled, 40km north of Donetsk). While positioned about 1km north-east of Zaichenko to facilitate repairs in Pikuzy, the SMM heard 488 ceasefire violations, including 12 undetermined explosions.

#### Situation at entry-exit checkpoints and corresponding checkpoints

In Luhansk region, the SMM observed that the entry-exit checkpoint (EECP) near Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the repaired span of the Stanytsia Luhanska bridge were open, with people queueing to travel in both directions.

The SMM noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open, but that the corresponding checkpoints of the armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were closed for civilian traffic. While at the latter checkpoint, the SMM observed a convoy

consisting of a civilian vehicle and three trucks, all bearing the logo of an international humanitarian organisation, travelling towards government-controlled areas.

The SMM continued monitoring in Kherson, Odessa, Ivano-Frankivsk, Lviv, Kharkiv, Dnipro, Chernivtsi and Kyiv.

# \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see <u>SMM Daily Report of 8</u> <u>December 2021</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

### Denial:

- At a checkpoint near Zaichenko (non-government-controlled, 93km south of Donetsk), a member of the armed formations denied the Mission passage west towards an observation post near the settlement, citing "ongoing kinetic activities". While at the checkpoint, the SMM observed civilian traffic passing through.

### Delay:

- At a checkpoint near Yasynuvata (non-government-controlled, 16km north-east of Donetsk), a member of the armed formations allowed the Mission passage east towards Debaltseve (non-government-controlled, 58km north-east of Donetsk) only after 32 minutes of waiting, citing an "intention to inspect the trailer".

#### Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

### Other impediments:6

- SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, during six flights: on three occasions while flying over areas near Orikhove

(government-controlled, 57km north-west of Luhansk), twice near New York (formerly Novhorodske, government-controlled, 35km north of Donetsk), and once near Pervomaisk (non-government-controlled, 58km west of Luhansk).


