# **Daily Report 13/2022**

20 January 2022<sup>1</sup>

# **Summary**

- In Donetsk region, the SMM recorded 68 ceasefire violations, including eight explosions. In the previous reporting period, it recorded 14 ceasefire violations in the region.
- In Luhansk region, the Mission recorded 15 ceasefire violations, including one explosion. In the previous reporting period, it recorded 44 ceasefire violations in the region.
- The SMM followed up on reports of damage to civilian properties in Donetskyi, Luhansk region.
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote, and Petrivske. It recorded ceasefire violations inside the disengagement area near Petrivske.
- The SMM monitored the operation of critical civilian infrastructure.
- The Mission continued following up on the situation of civilians, including at three entry-exit checkpoints and two corresponding checkpoints of the armed formations in Luhansk region.
- The SMM observed a gathering in Kyiv.
- The Mission's freedom of movement continued to be restricted, including near nongovernment-controlled Korsun in Donetsk region. Its unmanned aerial vehicles again experienced multiple instances of probable jamming.\*

# Map of recorded ceasefire violations



In Donetsk region, the SMM recorded 68 ceasefire violations, including eight explosions (one airburst and seven undetermined). The majority of ceasefire violations occurred in areas north of Shyrokyne (government-controlled, 100km south of Donetsk), as well as inside and north of the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk) (see below). In the previous reporting period, the Mission recorded 14 ceasefire violations in the region, some of which also occurred near Shyrokyne.

In Luhansk region, the SMM recorded 15 ceasefire violations, including one undetermined explosion, all of which occurred in areas north-east of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below). In the <u>previous reporting period</u>, the Mission recorded 44 ceasefire violations in the region, all of which also occurred in an area close to the disengagement area near Zolote.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding Measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has recorded at least 101,974 ceasefire violations in both Donetsk and Luhansk regions (including 27,927 explosions, 24,559 projectiles in flight, 447 muzzle flashes, 470 illumination flares and at least 48,571 bursts and shots).

#### Damage to civilian properties in Donetskyi, Luhansk region

On 18 January, the Mission followed up on reports of damage to civilian properties in the south-eastern part of Donetskyi (non-government-controlled, 49km west of Luhansk).

At number 21, 30 Rokiv Peremohy Quarter, about 20m east-south-east of an inhabited twostorey apartment building, the SMM observed a severely damaged wooden storage shed, with a hole in the roof, damaged walls and windows, and metal fragments assessed as shrapnel inside the structure as well as multiple dents assessed as shrapnel marks. The Mission assessed the damage as recent and caused by a probable mortar round.

About 60m south of the aforementioned address, at number 29, 30 Rokiv Peremohy Quarter, in a yard about 40m east-south-east of an inhabited two-storey apartment building, the Mission observed a crater (about 1m in diameter) and, near the crater, a damaged fence with multiple dents assessed as shrapnel marks. The SMM assessed the damage as recent and caused by a probable mortar round.

About 100m north of the aforementioned address, at number 31, 30 Rokiv Peremohy Quarter, in an inhabited two-storey apartment building, the Mission observed three windows with broken panes on the first floor and seven windows with broken panes on the second floor, covered with plastic film, as well as multiple dents assessed as shrapnel marks in the building's east-south-east facing concrete wall. Just east of the building, the SMM saw a hole in the west-north-western part of the roof of a wooden storage shed with rubble underneath and several holes in its west-north-west facing wall, as well as a dent assessed as a shrapnel mark on the ground in front of the shed. The SMM assessed the damage as recent and caused by two probable projectiles, but was unable to assess the weapon used and the direction of fire.

#### Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske<sup>5</sup>

Inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the Mission observed a calm situation.

During the reporting period, the SMM camera in Zolote recorded 14 projectiles in flights assessed as outside the **disengagement area near Zolote** but within 5km of its periphery. While positioned about 3km north of Pervomaisk (non-government-controlled, 58km west of Luhansk), the Mission heard one undetermined explosion, assessed as outside the area but within 5km of its periphery. (For details please see the table below.)

Near the checkpoint of the armed formations south of the disengagement area, the SMM saw four members of the armed formations (wearing armbands with "JCCC" written on them). The Mission again saw the seven previously observed containers located south of the area's southern edge and inside the disengagement area. It also observed that the previously reported road barriers across road T-1316, on the area's southern edge, continued to be closed.

During the reporting period, the SMM cameras 2km east of Bohdanivka (governmentcontrolled, 41km south-west of Donetsk) and in Petrivske recorded one undetermined explosion, six projectiles in flight and one illumination flare, assessed as inside the **disengagement area near Petrivske**, as well as four projectiles in flight, assessed as outside the area but within 5km of its periphery. (For details please see the table below.)

During the day on 19 January, while positioned at three locations near the disengagement area, the Mission observed a calm situation.

# At two heavy weapons holding areas in government-controlled areas of Donetsk region 19 January

The SMM noted that ten multiple launch rocket systems (BM-21 *Grad*, 122mm) and 11 selfpropelled howitzers (2S1 *Gvozdika*, 122mm) were present. However, nine multiple launch rocket systems (BM-21 *Grad*, 122mm) were missing compared with the previous visits on 10 and 13 December 2021.

#### Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In violation of withdrawal lines, the SMM saw one probable tank in a training area near Boikivske (formerly Telmanove, non-government-controlled, 67km south-east of Donetsk), in a zone within which deployment of heavy armaments and military equipment is further proscribed according to Point 5 of the Memorandum of 19 September 2014, and one probable mortar in a non-government-controlled area of Luhansk region.

Beyond withdrawal lines but outside designated storage sites, the Mission spotted 24 tanks, including ten probable, ten self-propelled howitzers and 12 towed artillery pieces in training areas near Ternove (non-government-controlled, 57km east of Donetsk) and Myrne (non-government-controlled, 28km south-west of Luhansk). # Indications of military and military-type presence in the security zone

The SMM observed two armoured combat vehicles in and near residential areas in governmentcontrolled areas of Donetsk region and two probable armoured combat vehicles in the training area near Boikivske (formerly Telmanove), in a zone within which deployment of heavy armaments and military equipment is proscribed according to Point 5 of the Memorandum of 19 September 2014. (For further information, see the table below.)

Additionally, outside the security zone, the Mission observed four armoured combat vehicles (including three probable) in the training area near Boikivske (formerly Telmanove), in a zone within which deployment of heavy armaments and military equipment is proscribed according to Point 5 of the Memorandum of 19 September 2014.

## The SMM followed up on reports of an alleged occupation of a school in governmentcontrolled Novohnativka, Donetsk region

On 19 January, the Mission followed up on reports of an alleged occupation of a school by a group of armed people without insignias in Novohnativka (government-controlled, 40km south of Donetsk). During a UAV flight, the Mission observed no signs of military occupation at the school, which appeared to be closed. The Mission observed a calm situation in the area and will continue to follow up.

#### SMM facilitation of the operation of critical civilian infrastructure

The Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk).

#### Situation at entry-exit checkpoints and corresponding checkpoints

In Luhansk region, the SMM observed that the entry-exit checkpoint (EECP) near Stanytsia Luhanska was open, with people queueing to travel towards government-controlled areas.

The Mission noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open, but that the corresponding checkpoints of the armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were closed.

#### The Mission observed gatherings in Kyiv

In Kyiv, at the Pechersk District Court on 15 Volodymyrska Street, the SMM observed about 3,500 people (mixed genders and ages) in support of a former President of Ukraine who was in Court, some of whom were giving speeches supporting the former President and expressing messages critical of the current government, others were holding banners with similar messages, as well as flags of Ukraine, the *European Solidarity* party, and flags of different

regions of Ukraine. The Mission noted that a makeshift screen had been set up in front of the Court's entrance, transmitting proceedings and screening the aforementioned speeches. It saw about 500 law enforcement officers nearby.

After the Court announced its decision, the SMM saw the former President address his supporters in front of the court, and observed the supporters sing the national anthem of Ukraine, march towards the Office of the President of Ukraine at 11 Bankova Street, and give speeches there and noted some participants lighting red flares. The Mission observed about 250 law enforcement officers nearby.

At both locations, the SMM observed a calm situation.

Additionally, at multiple locations, the Mission observed civilians engaged in religious celebrations to mark the Orthodox Epiphany, and observed a calm situation.

The Mission continued monitoring in Kherson, Odessa, Ivano-Frankivsk, Lviv, Kharkiv, Dnipro and Chernivtsi.

\*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see <u>SMM Daily Report of 4 January 2022</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following <u>the fatal incident of 23 April 2017 near Pryshyb</u>; these restrictions continued to limit the Mission's observations.

# Denial:

- About 2km north-east of Korsun (non-government-controlled, 31km north-east of Donetsk), an armed member of the armed formations denied the SMM passage further east, citing "ongoing training exercises".

# *Regular restrictions related to disengagement areas and mines/UXO:*

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:<sup>7</sup>

- SMM mini-unmanned aerial vehicles experienced GPS signal interference, assessed as caused by probable jamming, during 12 flights: five times while flying over areas near Sanzharivka (non-government-controlled, 67km north-east of Donetsk), four times while flying over areas near Holubivka (formerly Kirovsk, non-government-controlled, 51km west of Luhansk), twice while flying over areas near Nyzhnie Lozove (non-government-controlled, 59km north-east of Donetsk), and once while flying over areas near Novohryhorivka (non-government-controlled, 61km north-east of Donetsk).
