
Daily Report 18/2022

26 January 2022¹

Summary

- In Donetsk region, the SMM recorded 403 ceasefire violations, including 26 explosions. In the previous reporting period, it recorded 39 ceasefire violations in the region.
- In Luhansk region, the Mission recorded 57 ceasefire violations, including seven explosions. In the previous reporting period, it recorded 163 ceasefire violations in the region.
- Small-arms fire was assessed as directed at an SMM mini-unmanned aerial vehicle (UAV) near government-controlled Pyshchevyk, Donetsk region.*
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote, and Petrivske.
- The SMM monitored the operation and repair of critical civilian infrastructure.
- The Mission continued following up on the situation of civilians, including at three entry-exit checkpoints and the corresponding checkpoints of the armed formations in Luhansk region.
- The SMM visited a border crossing point outside government control in Donetsk region.
- The Mission monitored the security situation in east Kherson region.
- The SMM monitored a gathering in Kyiv.
- The Mission's freedom of movement continued to be restricted. Its UAVs again encountered multiple instances of GPS signal interference assessed as caused by probable jamming.*





In Donetsk region, the SMM recorded 403 ceasefire violations, including 26 explosions (two airbursts and 24 undetermined). The majority of ceasefire violations occurred in areas northeast of Lebedynske (government-controlled, 99km south of Donetsk) and south-east and south of Pyshchevyk (government-controlled, 84km south of Donetsk). In the <u>previous reporting period</u>, the Mission recorded 39 ceasefire violations in the region.

In Luhansk region, the SMM recorded 57 ceasefire violations, including seven undetermined explosions. The majority of ceasefire violations occurred in areas north-east and south-west of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below). In the <u>previous reporting period</u>, the Mission recorded 163 ceasefire violations in the region, the majority of which also occurred in areas close to the disengagement area near Zolote.

Following agreement reached at the meeting of the Trilateral Contact Group on 22 July 2020 regarding Measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has recorded at least 103,610 ceasefire violations in both Donetsk and Luhansk regions (including 28,415 explosions, 24,819 projectiles in flight, 448 muzzle flashes, 475 illumination flares and at least 49,453 bursts and shots).

Small-arms fire assessed as directed at an SMM mini-UAV near government-controlled Pyshchevyk, Donetsk region

While positioned about 2km south-west of Pyshchevyk to conduct an announced miniunmanned aerial vehicle (UAV) flight, the SMM heard eight bursts of small-arms fire at an assessed range of 3-4km east of its position, assessed as targeting the UAV, which was flying about 3.5km east-south-east of the SMM's position. The SMM landed the UAV and left the area. The UAV also experienced GPS signal interference, assessed as caused by probable jamming, during the same and one subsequent flight. *

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

Inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the Mission saw five members of the armed formations (wearing armbands with "JCCC" written on them) south of the repaired span of the Stanytsia Luhanska bridge (15km north-east of Luhansk).

During the reporting period, SMM patrols heard six undetermined explosions and 42 bursts and shots of heavy-machine-gun fire, assessed as outside the **disengagement area near Zolote**, but within 5km of its periphery. (For details, see the table below.)

In Katerynivka (government-controlled, 64km west of Luhansk), inside the disengagement area, the Mission observed a military jeep with three unarmed persons inside wearing Ukrainian military uniforms traveling north-east.

Near the checkpoint of the armed formations south of the disengagement area, the Mission saw one member of the armed formations (wearing an armband with "JCCC" written on it). The SMM again saw the seven previously observed containers located south of the area's southern

edge and inside the disengagement area. It also observed that the previously reported road barriers across road T-1316, on the area's southern edge, continued to be closed.

While positioned at two locations near the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), the SMM observed a calm situation.

Weapons that the SMM could not verify as withdrawn⁶

At two heavy weapons holding areas in government-controlled areas of Luhansk region 25 January

The SMM noted that all weapons observed at these sites were present, compared with previous visits on 20 December 2021.

At one heavy weapons holding area in a government-controlled area of Luhansk region 25 January

The SMM noted that ten self-propelled howitzers (2S5 *Giatsint*-S, 152mm) were present. It last visited the site on 24 August 2021.

Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

Indications of military and military-type presence in the security zone

The Mission saw two armoured personnel carriers and an anti-aircraft gun in government-controlled areas of Luhansk region, including in a residential area. (For further information, see the table below.)

At two locations in the eastern part of Makiivka (non-government-controlled, 12km north-east of Donetsk), the SMM observed a convoy of three utility trucks (Ural-type) with "chemical protection" written in white letters in Russian language on their sides and two utility trucks (one KamAZ-type and one Ural-type) loaded with green wooden objects, assessed as ammunition boxes.

Anti-tank mines near Kruta Balka, and mine hazard signs near Yasynuvata, Donetsk region

On 23 January, about 150m north of residential houses on the northern edge of Kruta Balka (non-government-controlled, 16km north of Donetsk), an SMM mini-UAV spotted six previously observed anti-tank mines (probable TM-62), assessed as belonging to the armed formations, laid across a local road. (For previous observations in the area, see SMM Daily Report 20 July 2021.)

On 25 January, on the north-western edge of Yasynuvata (non-government-controlled, 16km north-east of Donetsk), the Mission saw two recently erected mine hazard signs (red rectangles,

with the words "Danger, Mines" written on them in Russian, not previously reported) on the eastern edge of road M-04.

SMM facilitation of the operation and repair of critical civilian infrastructure

The Mission continued to facilitate the operation of the Donetsk Filtration Station (DFS) (15km north of Donetsk). While positioned on the western edge of Yasynuvata, the SMM heard three undetermined explosions and three bursts of small-arms fire, assessed as within a 5km radius of the DFS.

The SMM also monitored repair works to power lines near Verkhnotoretske (government-controlled, 23km north-east of Donetsk), and to water pipeline in Sakhanka (non-government-controlled, 97km south of Donetsk).

Situation at entry-exit checkpoints and corresponding checkpoints

In Luhansk region, the Mission observed that the entry-exit checkpoint (EECP) near Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the repaired span of the Stanytsia Luhanska bridge were open, with people queueing to travel in both directions.

The SMM noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open, but that the corresponding checkpoints of the armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were closed.

At the EECP near Zolote, the SMM observed three workers (men in their thirties and forties) nearby, conducting works, assessed as improvement of crossing infrastructure.

Areas near the border outside government control⁷

While at a border crossing point near Novoazovsk (102km south-east of Donetsk) for about 45 minutes, the Mission observed two cars (with "DPR" plates), three covered cargo trucks (including two with "DPR" plates), and three men (in their forties) entering Ukraine. At the same time, the SMM observed four cars (including two with "DPR" plates) exiting Ukraine.

Security situation in east Kherson region

On 24 January, the Mission monitored areas in east Kherson region near Henichesk (176km east of Kherson), Novooleksiivka (162km east of Kherson), and Novotroitske (135km east of Kherson), as well as areas along the North Crimean Canal. While monitoring these areas, the SMM observed no change in the security situation.

SMM monitored a gathering in Kyiv

On the afternoon of 25 January, in front of the Verkhovna Rada in Kyiv, the SMM observed a gathering of about 5,000 people (mixed genders and ages), some of whom were holding flags

with #SaveFOP written on them as well as flags of Ukraine and expressing support for the easing of certain tax and accounting regulations for small businesses. Throughout the gathering, the Mission saw about 3,000 law enforcement officers nearby. At one point, the Mission noticed that law enforcement officers were pushing back on participants who tried to move towards the steps of the Verkhovna Rada. At 16:30, the participants dispersed.

The SMM continued monitoring in Odessa, Lviv, Kharkiv, Ivano-Frankivsk, Dnipro and Chernivtsi.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see SMM Daily Report of 4 January 2022). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:8

- An SMM mini-UAV was assessed as targeted by small-arms fire while flying over areas near Pyshchevyk (government-controlled, 84km south of Donetsk). (See above and below.)

- An SMM long-range UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Varvarivka (government-controlled, 81km north-west of Donetsk).
- SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, during ten flights: twice each while flying over areas near Novohryhorivka (non-government-controlled, 61km north-east of Donetsk), Pyshchevyk and Kriakivka (government-controlled, 38km north-west of Luhansk), as well as once each while flying over areas near Debaltseve (non-government-controlled, 58km north-east of Donetsk), Vuhlehirsk (non-government-controlled, 49km north-east of Donetsk), Fedorivka (government-controlled, 87km north of Donetsk) and Orikhove-Donetske (government-controlled, 44km north-west of Luhansk).



When information is not known (indicated with an "N/K"), the SMM was unable to ascertain such information due to distance, weather conditions technical limitations and/or other considerations. Ceasefire violations recorded by more than one patrol/camera and assessed to be the same are entered only once.

This map of eastern Ukraine is meant for illustrative purposes and indicates locations mentioned in the report, as well as those where the SMM has offices (monitoring teams, patrol hubs and forward patrol bases) in Donetsk and Luhansk regions. (In red: a forward patrol base from which SMM staff have temporarily relocated based on recommendations of security experts from participating States, as well as SMM security considerations. The SMM uses the premises during daylight hours and also patrols in this settlement during daylight hours).
