
DUNJA MIJATOVIĆ


NANI JANSEN REVENTLOW

Previously, she oversaw the litigation practice of the Media Legal Defence Initiative (MLDI) globally.

Vučić is a journalist for the Crime and Corruption Reporting Network (KRIK) from Belgrade, in particular for Raskrikavanje.rs, KRIK's platform for fact-checking media articles and debunking fake news. She worked as a deputy editor-in-chief for Slavko Ćuruvija Foundation's Cenzolovka news portal, specializing in media related topics and problems in Serbian journalism - censorship, pressures and violence against journalists, media ownership and political influence over the media. In 2017 she received death threats online after writing an article about right-wing extremists.

Franks was appointed as head of the Journalism department at City, University of London in 2016. political coverage. In 2007 she completed a PhD and joined the Centre for Journalism at the University of Kent as director of research. Suzanne's academic work focuses on Humanitarian Communication and gender and Journalism. Her books include *Africa's Media Image in the Twenty First Century: From Heart of Darkness to Africa Rising* (Routledge 2016), *Having None of it: Women, Men and the Future of Work* (Simon & Schuster 2000) and *Women and Journalism* in association with the Reuters Institute for the Study of Journalism in Oxford.

Hanna Andersson is a former journalist, based at the FOJO Media Institute at the Linneaus University in Sweden. Over the course of her career she has published 18 books and collections on journalism, culture, gender and human rights.

EROL ÖNDEROĞLU


Turkey Representative, Reporters without Borders




IRINA BOROCHAN
