


Daily Report 221/2019

18 September 2019¹

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in Donetsk region and no ceasefire violations in Luhansk region.
- Inside the Stanytsia Luhanska disengagement area, the Mission saw workers from government-controlled areas placing concrete plates under the broken section of the bridge and workers from non-government-controlled areas repairing the metal section of the bridge.
- The Mission monitored adherence to the ceasefire to facilitate repairs to and the operation of essential civilian infrastructure, including water pipelines repairs between Zolote-3/Stakhanovets and Popasna.
- Restrictions of the Mission's access continued, including at checkpoints in Petrivske, restricting SMM's access to its camera, and near Verkhnoshyrokivske, all in nongovernment-controlled areas.*



In Donetsk region, the SMM recorded more ceasefire violations, including, however, fewer explosions (about 55), compared with the <u>previous reporting period</u> (about 80 explosions). The majority of ceasefire violations, including the majority of explosions, were recorded at easterly and southerly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk) and in areas east of Maiorsk (government-controlled, 45km north-east of Donetsk).

In Luhansk region, the SMM recorded no ceasefire violations during the reporting period.

Stanytsia Luhanska disengagement area

On the afternoon of 16 September, inside the disengagement area, the SMM saw three vehicles belonging to the State Emergency Service (SES) of Ukraine and a crane loading tree trunks onto a truck, respectively about 25m and 50m west of the road, about 600m north of the broken section of the bridge. Five workers from government-controlled areas with a crane and a tractor were placing concrete plates under the southern side of the broken section of the bridge (see <u>SMM Daily Report 17 September 2019</u>).

On the same afternoon, the SMM saw a member of the armed formations burning firewood and black smoke rising from an area along the riverbank about 100m south-west of the broken section of the bridge. The SMM also saw two workers from non-government-controlled areas placing two cylinders (gas and oxygen), into a formerly brown container which had been painted grey, on the eastern side of the southern edge of the metal section of the bridge. The SMM also saw a truck unloading steel angles near the grey container. Six members of the armed formations with a crane, an excavator and a mini-van loaded concrete slabs and dug out tree stumps in an area on the eastern side of the broken section of the bridge.

On the afternoon of 16 September, the SMM saw that a golf cart continued operating between the Ukrainian Armed Forces entry-exit checkpoint (EECP) and the broken section of the bridge and back. A Ukrainian Armed Forces officer of the Joint Centre for Control and Coordination (JCCC) told the SMM that the shuttle bus was discontinued as it could damage the newly laid asphalt on the road. ⁴

On the morning of 17 September, the SMM saw SES members wearing protective gear, with shovels, sticks and a metal detector checking areas east of and under the broken section of the bridge, and other SES members checking an area on the eastern side of the road, respectively about 70m and 80m north of the broken section of the bridge.

On three separate occasions, the SMM saw a crane and workers from government-controlled areas unloading 11 concrete plates from three trucks and subsequently laying four of them in two stacks under the broken section of the bridge.

The SMM also saw two stacks of ten concrete slabs about 50m east and two concrete slabs about 15m north of the broken section of the bridge. The SMM saw four SES members with a

ladder fixing a camera on a telegraph post west of the road, about 15m north of the broken section of the bridge.

On the morning of 17 September, the SMM saw two people wearing white t-shirts with an inscription in Ukrainian standing in the middle of the broken section of the bridge and subsequently carrying the belongings of elderly people across the wooden ramps on it (see SMM Daily Report 16 September 2019).

On the morning of 17 September, the SMM saw two members of the armed formations welding pillars on the metal section of the bridge. It observed that the previously damaged areas on the northern edge of the metal section of the bridge had been patched with welded plates of iron and repainted. The areas on the southern riverbank (immediately east and west of the metal section of the bridge) had been freshly cleared of trees. The SMM also saw seven members of the armed formations (wearing armbands with "JCCC" written on them) between the southern edge of the broken section of the bridge and the checkpoint of the armed formations south of the bridge.

Outside the disengagement area, on the afternoon of 17 September, the SMM saw concrete slabs and 12 members of the armed formations with equipment and vehicles operating and placing a metal container on the western and eastern sides of the road respectively, adjacent to the Prince Ihor Monument, south-east of the Stanytsia Luhanska bridge.

The SMM saw ten workers on the eastern and western edges of the road, in the area of the Ukrainian Armed Forces EECP and continuing for several hundred meters south, pulling together severed pieces of cables from the guardrails and clamping and welding them together.

Other disengagement areas⁵

On 16 September, inside the disengagement area near Zolote (government-controlled, 60km west of Luhansk), an SMM mini-UAV spotted two ammunition crates on the western side of road T-1316 (assessed as belonging to the armed formations).

The UAV also spotted an armoured personnel carrier (APC) (MT-LB) and a probable armoured combat vehicle (ACV) less than 20m from a civilian house inside the disengagement area and, 500m south-west, four additional revetted, sand bagged firing positions (not seen in imagery from 6 September 2019) to an existing trench running east to west, 600m south of the northern edge of the disengagement area, all assessed as belonging to the Ukrainian Armed Forces.

On 17 September, while travelling along road T-1316 inside the disengagement area near Zolote, the SMM <u>again</u> saw a remnant of a 120mm mortar tailfin, embedded in the ground on the eastern edge of the road between positions of the Ukrainian Armed Forces and the armed formations. The SMM also saw that ten previously reported anti-tank mines on the north-western side of the railway bridge, as well as two anti-tank mines about 20m north of the railway bridge were no longer present. The SMM travelled south until it saw <u>again</u> the

"Barely Visible Obstacle" (MZP) stretched across the road, about 350m north of the checkpoint of the armed formations on the southern edge of the disengagement area, thus preventing the Mission from crossing through it.

In the morning of 17 September, positioned close to the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk), the SMM heard and saw an undetermined explosion at an assessed range of 4-6km south-east, assessed as outside the disengagement area but within its 5km periphery.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

On 17 September, the Mission observed no weapons in violation of withdrawal lines (for weapons observed beyond withdrawal lines but outside designated storage sites, see table below).

Indications of military and military-type presence in the security zone⁶

Government-controlled areas

16 September

An SMM mini-UAV spotted an armoured ambulance (MT-LB S) near a checkpoint of the Ukrainian Armed Forces on the northern edge of the disengagement area near Zolote.

Non-government-controlled areas

15 September

Aerial imagery available to the SMM revealed the presence of a new trench running northeast to south-west (not visible in imagery from 2 September 2019) for about 240m in a residential area in Petrivske, about 400m east of the disengagement's area eastern edge. About 900m north-east of the aforementioned trench, the aerial imagery revealed a new 70m-long trench along a treeline and, about 1km further east, two new trenches (about 200 and 660m in length). About 900m north-west of the previous two trenches, the aerial imagery revealed the presence of a newly built position consisting of two trenches, both about 300m in length.

17 September

The SMM saw an almost finished bunker and about 20 people in camouflage clothing and about 12 trucks, a trench digger and several cranes digging trenches and semi-concealed earth works next to the road between Petrivske and Styla (non-government-controlled, 34km south of Donetsk), north-east of the Petrivske disengagement area.

SMM facilitation of repairs to and the operation of civilian infrastructure

The Mission monitored adherence to the ceasefire to facilitate repairs to water pipelines between Zolote-3/Stakhanovets (government-controlled, 61km west of Luhansk) and

Popasna (government-controlled, 69km west of Luhansk), to power lines near Kruta Balka (non-government-controlled, 16km north of Donetsk) and Holmivskyi (non-government-controlled, 49 north-east of Donetsk), to the sewage system near Novoluhanske (government-controlled, 57km north-east of Donetsk) and to enable the drilling of wells near Raivka (non-government-controlled, 16km north-west of Luhansk).

The Mission continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitor the security situation around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

The Mission continued monitoring in Kharkiv, Kherson, Odessa, Lviv, Ivano-Frankivsk, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report 14 September 2019). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint in Petrivske (non-government-controlled, 41km south of Donetsk), on two occasions, two members of the armed formations (one visibly armed) <u>again</u> denied the SMM passage, restricting its access to the camera in Petrivske.
- At a checkpoint west of Verkhnoshyrokivske (formerly, Oktiabr, non-government-controlled, 85km south of Donetsk), on two occasions, three members of the armed formations <u>again</u> denied the SMM passage citing "ongoing work in the area". The SMM saw, however, that civilian vehicles continued to cross the checkpoint.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access to disengagement areas near Zolote and Petrivske, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines and UXO.

Other impediments:

- On 17 September, an SMM mini-UAV lost its GPS signal due to signal interference, assessed as caused by probable jamming, on two occasions, while flying over areas near Kyrylivka (government-controlled, 76km south of Donetsk).⁷


