# Trade Information Portal

## Business needs

Easy access to all trade related laws, regulations, documents and forms

Access to clear and detailed step-by-step description of trade formalities

Access to market access information such as trade flows and non-tariff requirements

## Expected benefits

Reduced time and cost for researching, collecting and understanding trade environment

Improved compliance with procedural requirements

Enhanced understanding of trade opportunities and challenges to access new destination markets



**Trade Information Portal: Step-by step guidelines on import and export procedures for 23 categories of goods are developed and inserted**

The portal is implemented in collaboration with UNCTAD e-regulation teams and supported by the OSCE, the Swiss Cooperation Office, the International Trade Centre and the UNDP Country Office

3 key functionalities of the portal include: 1) trade regulation repository; 2) step-by-step description of the trade formalities and 3) market access

# Investment Information Portal

## OBJECTIVES

To improve Tajikistan's services for entrepreneurs and investors by implementing the e-Regulations system which clarifies administrative procedures for investments in various sectors of economy in Tajikistan and to display them online.

The administrative procedures will be described step-by-step, including information on sequence of procedures, points of contact, downloadable forms, list of documents that must be attached to an application, costs, duration, ways of recourse, legal basis for each step as well as the expected outcome of each

Name of the step	Result of the step	Entity/office/officer in charge
Requirements (forms and documents)	Cost	Duration (minimum and maximum)
Legal justification	Entity/office/officer in charge of attending complaints	Endorsement of correctly described step

- Promoting active participation of the civil society
