International consultative workshop to discuss first drafts of national technical regulations
“ON CLASSIFICATION AND LABELLING OF HAZARDOUS CHEMICALS” and
“ON SAFE AND SECURE MANAGEMENT OF CHEMICAL PRODUCTS”

30-31 October 2018, Kyiv, Ukraine

BACKGROUND

The OSCE Project Co-ordinator in Ukraine currently implements the project “Improving Ukraine’s Regulatory System on Chemical Safety and Security” (the Project) with a view to facilitate the development of the Ukrainian legislative framework to reduce potential risks of harm posed by the hazardous chemical substances to health of workers, consumers and the environment, as well as to prevent the unauthorized access to the toxic substances, especially to the dual-use chemicals.

The Project was developed by the OSCE Conflict Prevention Centre jointly with the OSCE Project Co-ordinator in Ukraine and in close co-operation with Ukrainian authorities, based on the outcome of the Comprehensive Review of Chemical Safety and Security in Ukraine, conducted in 2015 under the UN Security Council Resolution 1540 (2004). The Ministry of Economic Development and Trade of Ukraine is the beneficiary of the Project component for the development of national technical regulations “On Classification and Labelling of Hazardous Chemicals” and “On Safe and Secure Management of Chemical Products” (the National Regulations).

The National Regulations will be harmonized with the international legal framework, including the European Union Regulation (EC) No 1907/2006 concerning the registration, evaluation, authorization and restriction of chemicals (the REACH) and the Regulation No (EC) 1272/2008 on classification, labelling and packaging of substances and mixtures (the CLP).

OSCE experts produced first drafts of the National Regulations, which will be presented and discussed in the scope of this international consultative workshop. Engagement of interested stakeholders into the active discussion will promote principles of chemical safety and security and account for interests of the involved parties. Results of analysis by international experts will demonstrate alignment of the draft National Regulations with the international regulatory framework and communicate best practices.

Successful implementation of the National Regulations will enhance the safety and security of production, handling, transportation, storage and disposal of hazardous chemical substances in Ukraine.

EXPECTED OUTCOMES

1. The national experts will familiarise the involved stakeholders, including government agencies, chemical industry representatives, scientific institutions, civil society and international organizations, with the first drafts of National Regulations.
2. Observations, feedback and recommendations by the participants will inform refinement and finalisation of draft National Regulations.
