## **STATEMENT BY THE DELEGATION OF TAJIKISTAN**

Mr. Chairperson,

The delegation of the Republic of Tajikistan would like to recall that it spoke at the Permanent Council meeting of 8 October this year about the criminal activity of the leaders and members of the Islamic Revival Party of Tajikistan (IRPT) and also the decision of the Supreme Court banning the party's operation and recognizing it as a terrorist organization.

The leaders of the party and its members are accused of serious terrorist crimes. Criminal proceedings have been instigated against the former Chairman of the party Muhiddin Kabiri and an international search warrant has been issued by Interpol.

Unfortunately, however, the delegations of a number of OSCE participating States have failed to take note of or simply ignored this information.

This is illustrated by the fact that the former Chairman of the IRPT, Mr. Kabiri, and a number of former members of the party are actively attempting to use the OSCE to continue their illegal activity and to advocate extremist ideas. Unfortunately, these efforts are being directly supported by some countries and organizations.

The aforementioned persons were registered for and took part in the Supplementary Human Dimension Meeting in Vienna on 29 and 30 October 2015. They were also registered to take part in an event during the Security Days in the Hofburg on 13 November this year. It should be pointed out that the names of these people were not mentioned in the provisional lists of participants and they were included only a few hours before the start.

It should also be mentioned here that these people were registered as members of a non-existent political party. One might ask how this could have been allowed.

Following the intervention of the delegation of Tajikistan, Mr. Kabiri and the former press secretary of the IRPT were not admitted to the meeting during the Security Days. We are grateful to the OSCE Secretariat for its timely reaction to our concerns.

It has come to our knowledge, however, that on 13 November these persons were somehow all admitted after all to the Hofburg and held meetings with the delegations of some

OSCE participating States. Unfortunately, we have received no response to our appeals to confirm or deny these meetings and cannot therefore say today who admitted them. I imagine that those who took part in the meetings themselves know this very well.

This fact gives rise to serious concern and incomprehension on our part. I should like to ask the distinguished colleagues who took part in those meetings to explain why meetings were held with people who are accused of serious crimes and are on the Interpol list.

And, of course, there is the question of how these people, who are on an international wanted list, could have freely entered the territory of the European Union at all and strolled without hindrance in the corridors of the OSCE.

Right now we should like to ask our colleagues what we are to make of such behaviour. These people are criminals who participate directly in the financing and planning of attacks on law enforcement bodies and in attempts to overthrow the constitutional order of Tajikistan by armed force. Should it not be seen as open support for members of a terrorist group responsible, in particular, for the deaths of citizens and law enforcement officers?

I should like to recall that experience in other countries has shown that nothing good comes of dalliance with such groups and people taking part in terrorist or extremist activities.

Another reasonable question suggests itself. Where do the former leader and members of the IRPT, who have been outside the country for a long time, get the money to move freely between countries, including European ones, and to live in luxury hotels and organize meetings and events that demand considerable financial resources?

We regard the OSCE as a platform for dialogue between the official representatives of the Organization's participating States, but steps like these by some of our colleagues would indicate that it is something completely different.

At a time when the entire world is confronted by an unprecedented stepping up of terrorist activity in various regions of the globe and we need to unite to counter this phenomenon, the actions of some of our partners unfortunately encourage and provide inspiration for representatives of terrorist and extremist groups.

We should like to stress that the sheer fact that criminals can take part in OSCE events, let alone meet official representatives of the Organization's participating States, is absolutely inadmissible and unacceptable for us.

In this regard, we should like once again to draw the attention of the distinguished Chairmanship, Secretariat and OSCE institutions to these facts and to express the hope that the necessary steps will be taken to prevent people representing criminal and terrorist organizations and accused of particularly serious crimes from taking part in any of the Organization's events.

I should like to appeal to our distinguished colleagues to pay greater attention to the statements by other delegations and to be more selective as regards the people with whom they meet.



Mr. Chairperson, I request that this statement be included in the journal of the day.
