Minister of Interior meets mayors

On 8 June 2010, the TA Project in cooperation with the Ministry of Interior held a meeting with Mayors and Heads of Municipal Councils of 73 Local Government Units LGUs that are lagging behind on the address system implementation, more specifically the street naming process. The meeting was addressed by Minister of Interior Lulzim Basha and Deputy Minister of Interior Ferdinand Poni.

Minister Basha stated that: "Decisions on the street names and other parts of the public territory should be taken no later than end of June 2010. The Ministry of Interior considers it unacceptable that completion of this task is delayed by the lack of decisions in the municipal councils for those streets which are still unnamed. This situation is even more unacceptable and intolerable in those LGUs where technical work has been completed months ago.

I appeal to your sense of cooperation and of building together a European future for Albania, for which we are committed irrespectively of our political beliefs. We committed to take joint decisions and to cooperate at a central and local level in order to conclude this important phase of the address system implementation".

The TA Project and MoI are aiming to finish the address work for 220 LGUs that cover 3.8 million registered citizens by July 2010.

Progress on address system implementation

There has been continuous progress on address system implementation throughout Albania. At the end of June some 75 out of 373 Local Government Units (LGUs) finished work on creating an address system for their territories. Compared to the previous month, additional 20 LGUs have finished their tasks in identifying streets, naming them and marking buildings and their entrances. Some of the largest municipalities that have completed the work during the last month include Permet, Pogradec and Kruja.

Currently, the address system is completed for 75 LGUs where about 33 percent of the citizens are registered.

Out of these 75 LGUs address data for 64 of them is uploaded on the internet. Therefore, currently about 1.2 million albanian citizens are able to identify their addresses. The remaining areas require further clarification on the exact boundary between the LGUs to complete the work. Regular meetings on resolution of boundary issues take place under the auspices of the Ministry of Interior.

Highlights

Address system European Address presented to students Conference

On 10 June 2010, the TA Project and Address System Unit of the General Directorate of Civil Status (GDCS) met with students of the Civil Engineering Faculty of the University of Tirana to introduce the principles of the new modernized address system and the National Register of Addresses. In addition, students where informed on the legal framework, work done so far for the digitization of maps and the way ahead.

The aim of the event was to raise the awareness of these experts-to-be on the work done on the address system as well as invite them to think about working for the address system in the future.

Speaking to the student audience, the TA Project Manager Mr. Frank challenged the students to consider acquiring GIS skills that would enable them to work on the address system or any other form of GEO information, which will become relevant and vital for future spatial planning in Albania. The General Director of the GDCS Mr. Armand Teliti encouraged the students to contact the Address System Unit about any questions they may have on address related issues.

The TA Project and GDCS consider students of the Faculty of Civil Engineering as potential urban planners and GIS experts who may work both at local and central government institutions for address related planning activities.

The TA Project participated in the first conference on the European Address Infrastructure - Addressing the future which was held in Brussels on 15 June 2010.

The conference was held to inform participants on the results of EURADIN, a project co-funded by the EC.

Conference topics, amongst others, included "Addressing Europe - Why addresses are important for Europe?" and "Global perspective: Location matters -Addresses for all". In addition, business cases on social and economic benefits of a functioning address system on local and central level were presented.

At the conference the European Address Forum (EAF), which will build upon the results of the EURADIN project, was launched. The EAF aims to support the development of well structured addresses and the availability and efficient use of harmonized and good quality address data throughout Europe.

IT training for GDCS

On 31 May 2010, the TA Project started the specialised IT training of the General Directorate of Civil Status (GDCS) staff responsible for maintaining the National Register of Civil Status (NCRS). Training of the GDCS staff is a significant component of the TA project.

The online system of the NRCS is based on the Austrian model modified in compliance with the Albanian reality and legal framework. The NRCS is a complex system, which requires in-depth knowledge on the part of the GDCS staff, in order to be able to administer and maintain the system. To achieve this objective, the technical competencies of the GDCS staff need to be strengthened through specific training on all the components of the NRCS system.

BACKGROUND

What is EURADIN?

EURADIN stands for European Addresses Infrastructure. EURADIN is a project that aims at constituting a Best Practice Network to promote European the Addresses harmonization. The emphasis will be put in defining access to existing address data should be made to ensure the interoperability of existing address data and working out a strategy on how to build up access services to national or regional addresses infrastructures.

In everyday life and in a large number of systems (e.g. cartography, cadastre, postal services, health and risk management, services, transportation and logistics, emergency situations management, tourism), addresses are used as a common reference. number of IT applications is very big and, given the importance of address infrastructure as a useful tool for public and private services, it is logical to expect that the EU should have an adequate address infrastructure allowing access in a seamless and interoperable way to the existing European addresses.

The EURADIN project's main result will be the proposal for European Addresses Infrastructure and implementation, testing, and validation of a pilot European Addresses Infrastructure in line with the EU INSPIRE Directive. The results shall be used as a reference for all European Member States.
