

The OSCE Project Co-ordinator in Ukraine is seeking a qualified and motivated person to fill the position of:

National Project Officer, Media

(2 vacant positions)

Tasks:

Co-ordination and Implementation of Project Activities

- Preparing agenda, co-ordination and planning of specific activities such as seminars, conferences, study trips to implement projects;
- Preparing project proposals and budgets estimates within allocation pledged by donor, usually for 6 months;
- Planning and co-ordinating implementation of different phases of the projects;
- Establishing and maintaining contacts with media experts, policy makers and relevant government officials and institutions involved in media development in Ukraine;
- Co-ordinating and participating in the work of high level experts, trainers and members of working groups; liaising with International Organizations/Institutions;
- Research on systems applied in different countries;
- Development of training material and hand out, selection of the participants to working groups.

Evaluation and monitoring

• Monitoring ongoing project work, providing guidance and assistance to implementing partners, if required.

Reporting and planning Future Activities

- Based on a thorough evaluation and analysis of the respective project, preparing reports, overviews, and other information and analytical material on demand of the senior management;
- Preparing narrative and financial reports to the donors based on the demands of the respective OSCE donor agreements.

Administrative duties

- Preparing agreements with the respective implementing partners;
- Maintaining expenditure table;
- Preparing relevant documentation for selecting experts and implementing partners: ToRs and tender/job announcements;
- Preparing relevant financial documentation: PRs, financial settlements, OTAs and settlements of duty trips;
- Translation of relevant documentation and project proposals;
- Photocopying, filing and faxing;
- Communicating with implementing partners, co-implementer of the project, representatives of authorities, respective NGOs and mass media;
- Updating database of media experts, media NGOs and legislative database; requesting and updating action plans of implementing partners and bodies of authorities.

Other duties as required

Requirements:

- University degree in journalism, social sciences or political science;
- Minimum of two years relevant professional experience, preferably with some experience at the international level; project management experience; experience in working with Eastern European Countries / the CIS;
- Knowledge of Ukrainian and European media environments;
- Experience in drafting reports; proven ability to establish, contact and develop constructive relations with civil society, as well as the ability to work with government officials and institutions:
- Demonstrable management, organizational, analytical, communication and interpersonal skills;
- Computer literate with practical experience in Microsoft packages;
- Excellent written and oral communication skills in English and Ukrainian;
- Ability to work with people of different nationalities, religions and cultural backgrounds.

This position is for residents of Ukraine only and will **commence from September 2013**. We strongly encourage applicants to apply on-line.
