Concept Note & Agenda

The EStAR project is Implemented by the OSCE Office for Democratic Institutions and Human Rights (ODIHR) and the Association of Counseling Centers for Victims of Right-wing, Racist and Antisemitic Violence in Germany (VBRG). Through a victim-centered approach, the project provides tools for improving protection and services for hate crime victims and builds capacity of criminal justice and victim support experts and practitioners.

An effective and responsive hate crime victim support system is built upon several essential elements. These include the law that establishes the rights of victims of crime, including recognizing hate crime victims as victims with special needs and requiring additional protection, the existence of a state-run system that provides general support to all victims and specialist support to victims of hate crimes, as well as the ability of the police to record hate crimes as a separate category of crime and the ability to prosecute such crimes accordingly. Not all OSCE participating States have all these elements in place.

Most OSCE participating States run general systems to support victims of crimes, but are lacking specialized hate crime victim support services. This gap is very often filled by civil society organizations (CSOs) that provide targeted support to victims of hate crimes and lead advocacy and strategic litigation efforts to improve the overall situation of hate crime victims in their respective countries. While the role of CSOs is crucial, they often operate with minimal resources, by working closely with the communities they serve, applying the skills and knowledge they gain through listening to the needs of victims and tailoring their services to meet those needs.

To promote international exchange on existing good practices in CSO response to hate crime victims' needs, ODIHR and VBRG are hosting a workshop featuring promising and successful initiatives from select project countries. CSO representatives will share their practical experience, serving as role models for other CSOs looking to expand, enhance and strengthen their support to hate crime victims. The sessions will focus on international efforts to improve hate crime victim support with a focus on grass-roots initiatives and their efforts to engage with state authorities on hate crime prevention and improving victim support. All presentations will be followed by short Q&A sessions.

The workshop is primarily aimed at experts and professionals involved with the EStAR project who work to protect and support hate crime victims in several regions of the OSCE region. These include civil society representatives, human rights activists, representatives from the criminal justice sector, including prosecutors and judges, as well as researchers in the field of criminal and restorative justice alongside specialist hate crime victim support providers. The workshop will also be open to the general public.

The workshop will be held in English, with simultaneous interpretation into Russian.
