The Permanent Council,

Recalling its Decision No. 1440 of 21 July 2022 on the date and venue of the 2022 OSCE Mediterranean Conference, to be held in the Hashemite Kingdom of Jordan, on 24 and 25 October 2022,

Welcoming again the offer by the Hashemite Kingdom of Jordan to host the annual OSCE Mediterranean Conference,

Decides to hold the 2022 OSCE Mediterranean Conference on the subject “Advancing security and co-operation in the Mediterranean: fostering dialogue with the OSCE Mediterranean Partners for Co-operation”;

Adopts the agenda, timetable and organizational modalities of the Conference, as contained in the annex.

## **AGENDA AND ORGANIZATIONAL MODALITIES OF THE 2022 OSCE MEDITERRANEAN CONFERENCE**

Hashemite Kingdom of Jordan, 24 and 25 October 2022

### **I. Indicative agenda**

#### **Introduction**

The 1975 Helsinki Final Act recognized that “security in Europe is to be considered in the broader context of world security and is closely linked with security in the Mediterranean area as a whole, and that accordingly the process of improving security should not be confined to Europe but should extend to other parts of the world, and in particular to the Mediterranean area”.

The 2018 Milan Ministerial Council Declaration on Security and Co-operation in the Mediterranean (MC.DOC/4/18) reiterated these notions, noting that “this link between security in the OSCE area and security in the Mediterranean region has become all the more relevant, as has our co-operation with our Mediterranean Partners, given the growing range of challenges and opportunities stemming from the Mediterranean region and beyond”.

Among other factors and events, the COVID-19 pandemic, the growing challenges posed by climate change, the intensification of transnational threats to security, and ongoing armed conflicts, make the OSCE and Mediterranean regions even more interconnected in security, economic-environmental, as well as human terms.

Against this backdrop, North Macedonia as the Chairmanship of the 2022 OSCE Mediterranean Partners for Co-operation Group fostered dialogue with the OSCE Mediterranean Partners for Co-operation on a range of important topics with a view to tackling ongoing challenges as well as seizing available opportunities for co-operation. Topics included: “Strengthening co-operation to address the challenges caused by climate” and “Empowering women and youth in times of crisis” and others to be discussed in the second half of the year.

As a continuation of the same approach, the 2022 OSCE Mediterranean Conference will address the topic of “Advancing security and co-operation in the Mediterranean: fostering dialogue with the OSCE Mediterranean Partners for Co-operation”. The event shall start with a high-level political segment devoted to the role of youth. Thematic sessions shall then tackle specific aspects, including: the challenges caused by climate change, the trafficking of human beings and women’s economic empowerment. A closing remarks session will conclude the event.

In so doing, the Conference shall provide a platform for “advancing a common approach in tackling challenges ... and seizing emerging opportunities, in a spirit of genuine

partnership, co-operation, and ownership”, as called for by the Milan Ministerial Council Declaration on Security and Co-operation in the Mediterranean (MC.DOC/4/18).

## **II. Participation**

The Mediterranean Partners for Co-operation (Algeria, Egypt, Israel, Jordan, Morocco and Tunisia) will participate in and contribute to the Conference.

The Asian Partners for Co-operation (Afghanistan, Australia, Japan, the Republic of Korea and Thailand) will be invited to participate in and contribute to the Conference.

The OSCE institutions and the OSCE Parliamentary Assembly will be invited to participate in and contribute to the Conference. Representatives of non-governmental organizations may be invited by the host country to attend and may be invited to contribute to the Conference in accordance with the relevant OSCE provisions and practices (advance registration required).

Other countries may be invited by the host country to attend and may be invited to contribute to the Conference.

### **III. Organizational modalities**

The Conference will begin at 10 a.m. on the first day and end at 1 p.m. on the second day.

Each session will have a moderator and a rapporteur appointed by the Chairmanship. The consolidated summary will be forwarded to the Permanent Council for further consideration.

Appropriate arrangements for press coverage will be made.

The 2022 OSCE Mediterranean Conference will be held in English and French. This arrangement will not constitute a precedent that can be relied upon in other circumstances.

The Rules of Procedure of the OSCE will be followed, *mutatis mutandis*, at the Conference. Also, the guidelines for organizing OSCE meetings (Permanent Council Decision No. 762) will be considered.
