#### Side event on Online Safety of Female Journalists - Bibliotheksaal

Organized by the Office of the Representative on Freedom of Media

#### Topic and objective:

Democracy thrives when a plurality of voices are heard online. Though harassment of journalists online is not a new problem, it has become evident that the online harassment of female journalists is a cause for particular concern as a significant obstacle to the freedom of expression. What does this harassment look like, however, when, instead of nameless trolls, female journalists are targeted for harassment by state or state-supported actors? The panel will explore this specific type of online abuse and the differentiated response needed from the international community. The topic will be put into the larger framework of the importance of plurality, specifically the threat that online abuse poses to the concept of plurality and, therefore, freedom of the media and freedom of expression.
