

FACTS MATTER

- Between 27 November and 10 December, the security situation in eastern Ukraine further deteriorated. The SMM recorded close to 19,700 ceasefire violations in total a 25% increase on the previous two weeks. The vast majority of recorded ceasefire violations were concentrated in the Avdiivka-Yasynuvata-Donetsk airport area; areas south-west, south, and south-east of Svitlodarsk; the Popasna-Pervomaisk area; areas east and northeast of Mariupol; and the western and northern outskirts of Horlivka.
- The SMM's freedom of movement remained restricted on both sides of the contact line, especially around Travneve, where mines and unexploded ordnance prevented repeated attempts to enter the village, and close to the border areas with the Russian Federation around Siedove (southern Donetsk region), where patrols have been consistently denied access by armed members of the "DPR" since April 2017. The SMM faced impediments in the air as well, with one of its unmanned aerial vehicles being fired upon while in non-government-controlled Dovhe on 27 November.
- From 27 November to 10 December, the Mission monitored and facilitated 54 "windows of silence" localized adherence to the ceasefire which allow for inspection, repair, and maintenance work on 17 critical infrastructure facilities on both sides of the contact line. On 9 December, the SMM facilitated and monitored adherence to the ceasefire in order to carry out long overdue repairs to the wooden ramps at the Stanytsia Luhanska bridge, which will bring greater safety to thousands of people who pass through the nearby entry-exit checkpoint on a daily basis.
- As part of the "16 Days of Activism Against Gender-Based Violence" campaign, the SMM organized a number of activities, including OSCE Cafés throughout Ukraine, focus group discussions, and presentations at educational institutions featuring a range of guest speakers and interlocutors aiming to jointly raise awareness of the impact of gender-based violence, particularly in the context of armed conflict situations.
