Do not open before Monday 13 December 2005 12:00". Bids sent by fax will not be accepted. All bid prices shall be mentioned in Euros.

Special note: Partial bids will be accepted and partial awards may be granted. Where alternative replacement equipment or upgrades exist, these should be mentioned separately in the bid document.

The OSCE Entity reserves the right to accept or reject any Bid and to annul, in whole or in part, or to suspend the bidding process and reject all Bids at any time and without reason prior to award, without thereby incurring any liability to the affected Bidder or Bidders.
