Tasks:

- Plans and coordinates the activities in the project “Transboundary cooperation and sustainable management in the Dniester River basin (Dniester: climate change and floods)” and ensures that the activities are implemented according to the deadlines, communicates with Moldovan and Ukrainian partners, monitors and controls achievement of the project results. In particular, the activities include development of the Dniester basin adaptation strategy and conduction of small-scale ecosystem restoration;
- Plans and coordinates the activities in the project “Assessment of environmental risks in the Exclusion Zone along the Ukrainian and Belarusian borders to facilitate the demarcation process” and ensures that the activities are implemented according to the deadlines, communicates with Belarusian and Ukrainian partners, monitors and controls achievement of the project results. In particular, the activities include planning of research on radio-ecological situation in the Exclusion Zone along the Ukrainian and Belarusian borders and conduction of sampling;
- Coordinates the activities on development of the e-learning course on detection and prevention of environmental crimes at border in Eastern Europe and cooperates with State Environmental Inspectorate of Ukraine on creation of the collection of hazardous wastes;
- Develops the content of the national workshop on climate change assessment and communicates with relevant representatives from Ukraine in the project “Climate change and security in Eastern Europe, Central Asia and the Southern Caucasus”;
- Follows up with National Project Focal points and National Working groups regarding projects deliverables and ENVSEC programme, and on the ENVSEC Eastern Europe Consultations;
- Assists in the realization of the identified work programme for ENVSEC Eastern Europe initiatives;
- Performs other duties as required.

- University degree in International Relations and Development, Political or Environment Science;
- Minimum two years of experience in project management, preferably in international environment;
- Computer literate with practical experience in Microsoft packages;
- Excellent written and oral communication skills in Ukrainian and English;
