# DIVERSITY EDUCATION AND LAW ENFORCEMENT OUTREACH PROGRAM (LEOP)

The United States is a country made up of diverse groups of people who immigrated here from all over the world. It is important for law enforcement personnel to have the skill set, to effectively deal with these cultures in a manner that can improve communication and gain trust. Policing with a biased or uninformed outlook is inherently counter-productive and seriously undermines the ability to be successful in the communities officers are sworn to protect and serve.

#### **APPROACH**

After a brief welcome and introduction, a pop-quiz is handed out to the participants. This evaluates current cultural knowledge and allows the instructor to determine a base line for the class.

The quiz is a teaching tool and a vehicle for broader discussion about stereotypes of Arabs, Arab Americans, Muslims and those perceived to be such. This is followed by an open dialogue and discussion about the responses to the questions posed. Any and all questions are welcome during this phase and nothing is taboo. It is never offensive and no one is ever put on the spot. The sessions are engaging, interactive, and conversational.

#### **BACKGROUND**

Under the leadership of Nawar Shora, the curriculum has been run through a variety of courses and types of students - including Washington, DC Metro Police Officers, Park and Capitol Police, FBI Agents and Intelligence Analysts, DHS Personnel, Customs and Border Protection Managers and Analysts, FLETC instructors and attorneys, global employees of a U.S. based international airlines and other members of the corporate community, as well as individuals from Church groups and overall society.

Sessions can be tailored to fit varied interests and goals, including: Arabs, Arab-Americans, Arab Culture (including norms and mores), Islam, regional religions, geography, post 9-11 government actions and the "Backlash" against Arabs, Muslims, and those perceived to be such.
