Questions:

- What are the main challenges and barriers to women’s participation in political and public life in the OSCE region? How can we move beyond gender-balance quantitative measures to ensure that women have genuine influence in politics and decision-making bodies?
- How can we transform democratic institutions to be more gender- sensitive and inclusive? How would this benefit whole societies?
- How can we foster stronger political will towards gender parity in politics? In order to achieve this goal, should we consider new strategic partnerships, for example with male leaders and allies, women’s and youth organizations, or even with the private sector?
- What good practices can advance political participation of traditionally under-represented groups, such as women belonging to minorities, especially Roma and Sinti, young women, migrant women or women with disabilities?
- What strategies are effective in addressing violence against women in public life, including online violence?

Wednesday, 28 October

9:00 – 10:30 Session: Women’s Participation in the Security Sector

This session will identify best practices and formulate recommendations for achieving institutional change in security sector institutions (SSIs), including the armed forces.

Questions:

- What more can be done to increase women’s meaningful participation in SSIs beyond increasing their numbers?
- What benefits does having a gender-sensitive and inclusive institutional culture bring to operational effectiveness?
- What are the key elements and windows of opportunity that can bring about changes in institutional culture?
- How to move from good actions by individual leaders to institutionalized approaches? How to make institutional change a positive process?
